11	(i) Is a current member of the National Guard or a		
12	reserve component of the United States Armed Forces or an active duty member

14	(ii) Is of good character and sound judgment; and		
15	(iii) Has A form, as designated by the department,		
16	showing that the applicant has met the military qualification requirements		
17	for issuance and operation of a handgun within one (1) year of the
