A BILL FOR AN ACT

101	CONCERNING AUTHORIZATION FOR LOCAL POLICIES TO ALLOW
102	CARRYING OF CONCEALED HANDGUNS ON PUBLIC ELEMENTARY
103	AND SECONDARY SCHOOL PROPERTIES.

Bill Summary

The bill authorizes a school district board of education and the governing board of a charter school to adopt a written policy to allow an employee of the school district or charter school to carry a concealed handgun on school grounds if the person holds a valid permit to carry a

25	a concealed handgun onto the real property, or into any improvement

18	preservation of the public peace, health, and safety.
