17	(b-1) (1) "Convicted of a disqualifying crime" includes:
18 19	(i) a case in which a person received probation before judgment for a crime of violence; and
20 21	(ii) a case in which a person received probation before judgment in a domestically related crime as defined in § 6–233 of the Criminal Procedure Article.
