## Public Safety - Handgun Permit Review Board - Repeal

3 FOR the purpose of altering the process by which a person who is denied a certain handgun 4 permit or renewal of a permit or whose permit is revoked or limited by the Secretary 5 of State Police or the Secretary's designee may appeal the decision; repealing 6 provisions of law relating to the Handgun Permit Review Board; providing that 7 appeals from a certain decision by the Secretary or the Secretary's designee may be 8 made to the Office of Administrative Hearings in a certain manner; providing that a 9 person whose application for a certain permit or renewal of a permit is not acted on 10 by the Secretary within a certain period may request a certain hearing before the Office of Administrative Hearings; making conforming changes; and generally 11 12 relating to handgun permits.

- 4 (3) At the end of a term, a member continues to serve until a successor is appointed and qualifies.
- 6 (4) A member who is appointed after a term has begun serves only for the 7 rest of the term and until a successor is appointed and qualifies.
- 8 (5) A member of the Board is eligible for reappointment.
- 9 (d) A member of the Board is entitled to:
- 10 (1) compensation in accordance with the State budget for each day that the 11 member actually is engaged in the discharge of the member's official duties; and
- 12 (2) reimbursement for expenses under the Standard State Travel 13 Regulations, as provided in the State budget.]

- 15 (a) A person who is denied a permit or renewal of a permit or whose permit is 16 revoked or limited may request the Secretary to conduct an informal review by filing a 17 written request within 10 days after receipt of written notice of the Secretary's initial 18 action.
