- (a) This act shall be known and may be cited as the "Minnesota Anti-Red Flag Act."
- (b) The legislature hereby preempts the entire field of legislation in this state concerning 1.9 in any way federal or state extreme risk protection orders that have been issued against a 1.10 citizen of Minnesota. No city, county, or other political subdivision of this state shall enact 1.11 any ordinance, resolution, or regulation providing for extreme risk protection orders nor 1.12 enforce or aid in the enforcement of any extreme risk protection order issued pursuant to 1.13 federal law or the laws of another jurisdiction. 1.14
