## AN ACT

- To amend the State Department Basic Authorities Act of 1956 to include severe forms of trafficking in persons within the definition of transnational organized crime for purposes of the rewards program of the Department of State, and for other purposes.

### SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Targeted Rewards for
- 3 the Global Eradication of Human Trafficking" or the
- 4 "TARGET Act".

### 5 SEC. 2. FINDINGS; SENSE OF CONGRESS.

- 6 (a) FINDINGS.—Congress finds the following:
- 7 (1) Trafficking in persons is a major
- 8 transnational crime that threatens United States na-
- 9 tional security and humanitarian interests.
- 10 (2) Trafficking in persons is increasingly per-
- petrated by organized, sophisticated criminal enter-
- prises.
- 13 (3) Combating trafficking in persons requires a
- global approach to identifying and apprehending the
- world's worst human trafficking rings.
- 16 (b) Sense of Congress.—It is the sense of Con-
- 17 gress that the Department of State's rewards program is
- 18 a powerful tool in combating sophisticated international
- 19 crime and that the Department of State and Federal law
- 20 enforcement should work in concert to offer rewards that
- 21 target human traffickers who threaten United States na-
- 22 tional security and humanitarian interests by preying on
- 23 the most vulnerable people around the world.
