| 12 | WHEREAS, it is with highest commendation that we |
| 13 | recognize Alabama Department of Public Safety Trooper Tony |
| 14 | Brewer as the recipient of the 2014 Legislative Medal of Honor |
| 15 | for Law Enforcement, Alabama's highest law enforcement award |
| 16 | for extraordinary courage in the line of duty; and |
| 17 | WHEREAS, Trooper Brewer is currently assigned to |
| 18 | Troop A, Marion County/Highway Patrol Division/Hamilton Post, |
| 19 | and has been a member of the Department of Public Safety Since |
| 20 | February 9, 2003; and |
| 21 | WHEREAS, on July 29, 2013, at approximately 11:55 |
| 22 | a.m., Trooper Brewer responded to a local agency call for |
| 23 | assistance at the Hampton Inn in Winfield, Alabama; the call |
| 24 | was made by a local agency responding to a suspicious person |
| 25 | call in which a suspect tried to lure a female into a car, |
| 26 | broke from custody, brandished a firearm, and ran into the |
| 27 | woods; and |

WHEREAS, Trooper Brewer arrived on scene along with the DPS Aviation Unit, who conducted an aerial search and located the suspect; Trooper Brewer then exited his patrol car and confronted the suspect, whom he commanded to the ground; when the suspect failed to follow direction and ran, Trooper Brewer realized that fellow officers were approaching from the other side of the woods; although well aware that the suspect had a weapon and of the danger to other officers, with the potential for an ambush, Trooper Brewer without hesitation or backup pursued the suspect into the woods in order to maintain visual contact; and

WHEREAS, upon Trooper Brewer's close approach, the suspect turned and began firing his weapon; Trooper Brewer took cover on the ground and returned fire, along with other agency officers who had closed in; during the exchange of gunfire the suspect, who was walking toward Trooper Brewer firing his weapon, fell to the ground; Trooper Brewer then jumped to his feet and maintained a cover fire position as the other officers approached; due to the actions of Trooper Brewer and his courageous actions to apprehend the suspect, the threat was neutralized; and

WHEREAS, the investigation into this incident revealed that the suspect had recently been released from prison, had stolen a car and two handguns, and was on a crime spree; and

WHEREAS, Trooper Tony Brewer demonstrated courage and selfless service, risking his life without hesitation, to

ensure the safety of his fellow law enforcement officers and
the public, and he is truly deserving of this significant
honor; now therefore,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF

THE LEGISLATURE OF ALABAMA, That we hereby commend and
congratulate Alabama Department of Public Safety Trooper Tony
Brewer on being awarded the 2014 Legislative Medal of Honor
for Law Enforcement, and direct that he receive a copy of this

resolution as evidence of our admiration and esteem.
