21	SECTION 1. Arkansas Code § 5-73-119(e)(11), concerning places that are
22	exempt from the places it is prohibited from possessing a firearm, is amended
23	to read as follows:
24	(11) The person has a license to carry a concealed handgun under
25	§ 5-73-301 et seq. and is carrying a concealed handgun on the developed
26	property of <u>:</u>
27	(A) a A kindergarten through grade twelve (K-12) private
28	school operated by a church or other place of worship that:
29	(A)(i) Is located on the developed property of the
30	kindergarten through grade twelve (K-12) private school;
31	(B)(ii) Allows the person to carry a concealed
32	handgun into the church or other place of worship under § 5-73-306; and
33	(C)(iii) Allows the person to possess a concealed
34	handgun on the developed property of the kindergarten through grade twelve
35	(K-12) private school <del>.</del> ; or
36	(B)(i) A kindergarten through grade twelve (K-12) private
