Under current law, postsecondary and workforce readiness and closing the achievement gap are 2 of the performance indicators that the department of education (department) must use to measure a public

school's, a public school district's, the state charter school institute's, and the state's level of performance. The bill adds as a measure for each of these indicators the percentages of high school graduates who enroll in a career and technical education program, community college, or 4-year institution of higher education in the school year immediately following graduation. The department must give each postsecondary enrollment option equal weight in calculating performance.

Under existing law, each school district accountability committee must include a person from the community who is involved in business, and each school accountability committee must include a person from the community. The bill clarifies that the community person on the school district accountability committee must be involved in business or industry and that the community person on the school accountability committee must be involved in business or industry in the community.

The bill clarifies that the state board of education will issue career and technical education authorizations based on the qualifications that the state board for community colleges and occupational education adopts.

The bill creates the position of postsecondary and workforce readiness statewide coordinator (statewide coordinator). The statewide coordinator is responsible to the state work force development council (council) in the department of labor and employment. The executive committee of the council and the commissioner of the department of education will enter into a memorandum of understanding as necessary to enable the statewide coordinator to collaborate with appropriate offices within the department of education. The statewide coordinator will work with school districts, boards of cooperative services, the state charter school institute, charter schools, institutions of higher education, businesses, industry, the department of education, the department of labor and employment, and the work force development council to raise the level of postsecondary and workforce readiness that Colorado high school graduates achieve, especially with regard to obtaining skilled career positions in business and industry upon high school graduation.

1 APPRENTICESHIP PROGRAMS; AND INTERNSHIPS AND EXTERNSHIPS;  
2 (II) IMPLEMENTING CONCURRENT ENROLLMENT PROGRAMS AS  
3 PROVIDED IN ARTICLE 35 OF TITLE 22, C.R.S., AND IN ENTERING INTO  
4 CONCURRENT ENROLLMENT AGREEMENTS WITH AREA VOCATIONAL  
5 SCHOOLS, COMMUNITY COLLEGES, AND FOUR-YEAR INSTITUTIONS OF  
6 HIGHER EDUCATION;  
7 (III) IDENTIFYING LOCAL INDUSTRY AND WORKFORCE NEEDS AND  
8 EXISTING EDUCATIONAL TOOLS, PROGRAMS, AND RESOURCES TO HELP  
9 PREPARE MIDDLE AND HIGH SCHOOL STUDENTS TO MEET THOSE NEEDS  
10 UPON GRADUATING FROM HIGH SCHOOL;  
11 (IV) WORKING WITH STATE AND FEDERAL PROGRAMS THAT  
12 PROVIDE CAREER AND WORKFORCE DEVELOPMENT OPPORTUNITIES FOR  
13 STUDENTS ENROLLED IN MIDDLE AND HIGH SCHOOL AND IN ACCESSING  
14 ANY STATE OR FEDERAL MONEYS THAT ARE AVAILABLE TO LOCAL  
15 EDUCATION PROVIDERS TO SUPPORT AND IMPLEMENT THE PROGRAMS;  
16 (V) PROMOTING OPPORTUNITIES FOR INDUSTRY TO ENGAGE IN THE  
17 CLASSROOM WITH STUDENTS ENROLLED IN GRADES SIX THROUGH TWELVE;  
18 (VI) ENGAGING STUDENTS WITH THE MANUFACTURING CAREER  
19 PATHWAY CREATED PURSUANT TO SECTION 23-60-1003, C.R.S.; AND  
20 (VII) DEVELOPING PARTNERSHIPS WITH BUSINESSES, INDUSTRY,  
21 UNIONS, AREA VOCATIONAL SCHOOLS, COMMUNITY COLLEGES,  
22 APPRENTICESHIP PROGRAMS, AND OTHER ENTITIES TO CREATE  
23 OPPORTUNITIES FOR STUDENTS TO PARTICIPATE IN EDUCATIONAL AND  
24 TRAINING PROGRAMS THAT LEAD TO OBTAINING A CAREER ENTRY-LEVEL  
25 CREDENTIAL.  
26 (b) THE STATEWIDE COORDINATOR SHALL COLLABORATE WITH THE  
27 DEPARTMENT OF EDUCATION, THE DEPARTMENT OF HIGHER EDUCATION,

1 AND THE COLORADO COMMUNITY COLLEGE SYSTEM TO DEVELOP AND  
2 MAINTAIN A SET OF ELECTRONIC TOOLS AND A NETWORK OF STATEWIDE  
3 SUPPORT TO PROVIDE GUIDANCE FOR LOCAL EDUCATION PROVIDERS IN  
4 PROVIDING WORKFORCE READINESS PROGRAMS AND INITIATIVES.

5 **24-46.3-303. Annual report.** THE STATE WORK FORCE  
6 DEVELOPMENT COUNCIL AND THE DEPARTMENT OF EDUCATION SHALL  
7 ANNUALLY REVIEW THE WORK OF THE STATEWIDE COORDINATOR IN  
8 IMPLEMENTING THE DUTIES DESCRIBED IN SECTION 24-46.3-302. THE  
9 STATE WORK FORCE DEVELOPMENT COUNCIL SHALL INCLUDE A SUMMARY  
10 OF THE REVIEW IN THE COLORADO TALENT REPORT PREPARED PURSUANT  
11 TO SECTION 24-46.3-103 (3).

12 **SECTION 7. Appropriation.** (1) For the 2015-16 state fiscal  
13 year, \$92,934 is appropriated to the department of education. This  
14 appropriation is from the general fund and is based on the assumption that  
15 the department will require an additional 0.7 FTE. To implement this act,  
16 the department may use this appropriation for longitudinal analyses of  
17 student assessment results.

18 (2) For the 2015-16 state fiscal year, \$118,969 is appropriated to  
19 the department of labor and employment. This appropriation is from the  
20 general fund. To implement this act, the department may use this  
21 appropriation as follows:

22 (a) \$98,969 for use by the workforce development council, which  
23 amount is based on an assumption that the council will require an  
24 additional 1.0 FTE; and

25 (b) \$20,000 for the purchase of information technology services.

26 (3) For the 2015-16 state fiscal year, \$20,000 is appropriated to  
27 the office of the governor for use by the office of information technology.

1 This appropriation is from reappropriated funds received from the  
2 department of labor and employment under paragraph (b) of subsection  
3 (2) of this section. To implement this act, the office may use this  
4 appropriation to provide information technology services for the  
5 department of labor and employment.

6 **SECTION 8. Safety clause.** The general assembly hereby finds,  
7 determines, and declares that this act is necessary for the immediate  
8 preservation of the public peace, health, and safety.
