A BILL FOR AN ACT

CONCERNING THE REORGANIZATION OF FUNDS EXPENDED BY THE STATE HISTORICAL SOCIETY.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://www.leg.state.co.us/billsummaries.)

Joint Budget Committee. Under current law, a portion of the revenues generated by limited gaming in the state each year are deposited in the state historical fund. Of the moneys in the fund, 20% are distributed back to the cities of Black Hawk, Central City, and Cripple Creek for the preservation and restoration of the cities.

The remaining 80% of the revenues in the state historical fund are

used by the state historical society (history Colorado) for the historic preservation and restoration of historical sites and municipalities throughout the state as follows:

- ! 50.1% of the revenues (majority share) are used to provide historic preservation grants; and
- ! 49.9% of the revenues (minority share) are used to further the history Colorado's mission as a state educational institution to collect, preserve, and interpret history, including capital construction and controlled maintenance costs relating to its properties.

The bill creates 2 distinct subaccounts in the state historical fund to separately track the deposit and expenditure of the majority share and the minority share of revenues. The majority share is deposited in a new preservation grant program account. Moneys in this account that are used to provide grants are continuously appropriated to history Colorado, and moneys used to administer the grant program are subject to annual appropriation. The minority share is deposited in a new museum and preservation operations account. Moneys in this account are subject to annual appropriation.

Currently, some nongaming revenues received by history Colorado, such as donations, store sale revenues, and admission fees, are deposited in the state historical fund. The bill requires these revenues to be deposited in a separate cash fund called the enterprise services cash fund, which is subject to annual appropriation. The fund is exempted from the existing statutory limit on uncommitted reserves.

Be it enacted by the General Assembly of the State of Colorado:

the state historical fund shall be used for the preservation and restoration of the cities of Central, Black Hawk, and Cripple Creek. The remaining eighty percent of the fund shall be administered by the state historical society IN ACCORDANCE WITH SUBSECTION (5) OF THIS SECTION. Expenditures from the fund shall be subject to the provisions of section 12-47.1-1202. The society shall make grants from the eighty percent portion of said fund administered by the society for the following historic preservation purposes:

- (3) The society may expend a portion of the state historical fund administered by the society to cover such reasonable costs as may be incurred in the selection, monitoring, and administration of grants for historic preservation purposes. SUBJECT TO ANNUAL APPROPRIATION, the society may employ such personnel in accordance with section 13 of article XII of the state constitution as may be necessary to fulfill its duties in accordance with this section.
- (5) (b) Subject to annual appropriation, the society may make expenditures FROM THE MUSEUM AND PRESERVATION OPERATIONS ACCOUNT for THE reasonable costs incurred by the society in connection with fulfilling the society's mission as a state educational institution to collect, preserve, and interpret the history of Colorado and the west and carrying out other activities and programs authorized by statute or rule. Such reasonable costs may include capital construction and controlled maintenance expenditures relating to properties owned, managed, or used by the society.
- (c) (I) All moneys received by the society FROM LIMITED GAMING REVENUES PURSUANT TO SECTION 12-47.1-701 (1) (d) (II) shall be transmitted to the state treasurer, who shall credit the same to the state

1 historical fund. or other funds authorized by law. Such moneys include, 2 but are not limited to, grants, admission fees, user charges, concessionaire 3 fees, rentals, commissions, store sales, service fees, program fees, 4 membership fees, publications income, exhibit fees, special event fees, 5 donations, and gifts. EIGHTY PERCENT OF THE STATE HISTORICAL FUND 6 ADMINISTERED BY THE SOCIETY IS DIVIDED INTO THE FOLLOWING TWO 7 ACCOUNTS: 8 (A) THE PRESERVATION GRANT PROGRAM ACCOUNT, WHICH IS 9 HEREBY CREATED IN THE STATE HISTORICAL FUND, THAT CONSISTS OF 10 FIFTY AND ONE-TENTH OF ONE PERCENT OF THE MONEYS RECEIVED FROM 11 THE SOCIETY IN A FISCAL YEAR. MONEYS IN THE ACCOUNT ARE SUBJECT 12 TO ANNUAL APPROPRIATION BY THE GENERAL ASSEMBLY TO THE SOCIETY 13 TO COVER THE REASONABLE COSTS AS MAY BE INCURRED IN THE 14 SELECTION, MONITORING, AND ADMINISTRATION OF GRANTS FOR HISTORIC 15 PRESERVATION PURPOSES. ANY MONEYS NOT APPROPRIATED FOR SUCH 16 COSTS ARE CONTINUOUSLY APPROPRIATED TO THE SOCIETY FOR THE 17 PURPOSE OF MAKING GRANTS PURSUANT TO SUBSECTION (1) OF THIS 18 SECTION. 19 (B) THE MUSEUM AND PRESERVATION OPERATIONS ACCOUNT, 20 WHICH IS HEREBY CREATED IN THE STATE HISTORICAL FUND, THAT 21 CONSISTS OF FORTY-NINE AND NINE-TENTHS OF ONE PERCENT OF THE 22 MONEYS RECEIVED FROM THE SOCIETY IN A FISCAL YEAR. MONEYS IN THE 23 ACCOUNT ARE SUBJECT TO ANNUAL APPROPRIATION BY THE GENERAL 24 ASSEMBLY FOR THE PURPOSES SET FORTH IN PARAGRAPH (b) OF THIS 25 SUBSECTION (5). 26 (II) Except as otherwise specified in subparagraph (III) of this

(2) All moneys or securities NONCUSTODIAL REVENUES received by it, sale THE SOCIETY OTHER THAN LIMITED GAMING REVENUES DEPOSITED IN THE STATE HISTORICAL FUND PURSUANT TO SECTION 12-47.1-1201, C.R.S., whether from gifts, sales of duplicate or undesired books, specimens, documents, exhibits, or other properties, sale of microfilms or other copies, publication or sale of books, magazines, postcards, pamphlets, maps, or other materials, COMMISSIONS, SALE OF GOODS AND SERVICES, admissions, dues, MEMBERSHIP AND USER CHARGES, SERVICE FEES, operation or rental of concessions or facilities, rendering of services, or from any other STATE source shall be DEPOSITED IN THE ENTERPRISE SERVICES CASH FUND, WHICH FUND IS HEREBY CREATED IN THE STATE TREASURY. MONEYS IN THE FUND ARE SUBJECT TO ANNUAL APPROPRIATION BY THE GENERAL ASSEMBLY FOR THE DIRECT AND INDIRECT COSTS OF CARRYING OUT THE ACTIVITIES OF THE SOCIETY. THE STATE TREASURER SHALL CREDIT ALL INTEREST DERIVED FROM THE DEPOSIT AND INVESTMENT OF MONEYS IN THE FUND TO THE FUND. ANY MONEYS NOT APPROPRIATED REMAIN IN THE FUND AND SHALL NOT BE TRANSFERRED OR REVERT TO THE GENERAL FUND OR ANY OTHER FUND AT THE END OF ANY FISCAL YEAR. MONEYS IN THE ENTERPRISE SERVICES CASH FUND AND ANY OTHER HISTORICAL SOCIETY CUSTODIAL ACCOUNTS SHALL BE held by the state treasurer as custodian separate and apart from other funds and may be withdrawn from his custody for the purposes and under the control of the society, only upon the issuance of vouchers signed by the president or vice-president and treasurer or secretary of the society and upon warrants drawn against such funds by the controller.
