1 Amend engrossed bill, page 338, after line 23, insert:

2 "SECTION 736. In Colorado Revised Statutes, 42-4-1701,
3 amend (4)(a)(I) as follows:

4 **42-4-1701. Traffic offenses and infractions classified -**
5 **penalties - penalty and surcharge schedule - repeal.** (4) (a) (I) Except
6 as provided in subsection (5)(c) of this section, every person who is
7 convicted of, who admits liability for, or against whom a judgment is
8 entered for a violation of this title 42 to which subsection (5)(a) or (5)(b)
9 of this section applies shall be fined or penalized and have a surcharge
10 levied in accordance with sections 24-4.1-119 (1)(f) and 24-4.2-104
11 (1)(b)(I), in accordance with the penalty and surcharge schedule set forth
12 in subsections (4)(a)(I)(A) to ~~(4)(a)(I)(P)~~ **(4)(a)(I)(S)** of this section; or,
13 if no penalty or surcharge is specified in the schedule, the penalty for
14 class A and class B traffic infractions is fifteen dollars, and the surcharge
15 is four dollars. These penalties and surcharges apply whether the
16 defendant acknowledges the defendant's guilt or liability in accordance
17 with the procedure set forth by subsection (5)(a) of this section, is found
18 guilty by a court of competent jurisdiction, or has judgment entered
19 against the defendant by a county court magistrate. Penalties and
