

HB23-1230 be amended as follows:

1 Amend printed bill, page 10, strike lines 12 through 27.

2 Strike pages 11 through 13 and substitute:

3 **"18-12-603. Unlawful manufacture, import, or sale of**
4 **rapid-fire trigger activators prohibited.** A PERSON COMMITS THE
5 OFFENSE OF UNLAWFUL MANUFACTURE, IMPORT, OR SALE OF A RAPID-FIRE
6 TRIGGER ACTIVATOR IF THE PERSON KNOWINGLY MANUFACTURES,
7 IMPORTS, SELLS, OR OFFERS TO SELL, OR KNOWINGLY CAUSES THE
8 MANUFACTURE, IMPORTATION, OR SALE OF A RAPID-FIRE TRIGGER
9 ACTIVATOR.

10 **18-12-604. Penalties - civil.** (1) A PERSON WHO VIOLATES
11 SECTION 18-12-603 ON OR AFTER JULY 1, 2023, SHALL BE ASSESSED A
12 CIVIL PENALTY AS FOLLOWS:

13 (a) FOR VIOLATIONS OCCURRING BETWEEN JULY 1, 2023, AND
14 DECEMBER 31, 2023, THE PERSON SHALL BE ASSESSED A ONE THOUSAND
15 DOLLAR CIVIL PENALTY FOR EACH VIOLATION; AND

16 (b) FOR VIOLATIONS OCCURRING ON OR AFTER JANUARY 1, 2024,
17 THE PERSON SHALL BE ASSESSED A FIVE THOUSAND DOLLAR CIVIL
18 PENALTY FOR EACH VIOLATION.

19 (2) A LICENSED GUN DEALER, LICENSED FIREARMS DEALER, GUN
20 SHOW VENDOR, OR PERSON ATTEMPTING TO SELL OR WHO SELLS A
21 RAPID-FIRE TRIGGER ACTIVATOR ON OR AFTER JULY 1, 2023, SHALL BE
22 ASSESSED A CIVIL PENALTY IN THE AMOUNT OF TWO HUNDRED FIFTY
23 THOUSAND DOLLARS FOR THE FIRST RAPID-FIRE TRIGGER ACTIVATOR SOLD
24 IN VIOLATION OF SECTION 18-12-603 AND FIVE HUNDRED THOUSAND
25 DOLLARS FOR EACH SUBSEQUENT VIOLATION.

26 **SECTION 2. Effective date - applicability.** This act takes effect
27 upon passage and applies to offenses committed on or after said date.

28 **SECTION 3. Safety clause.** The general assembly hereby finds,
29 determines, and declares that this act is necessary for the immediate
30 preservation of the public peace, health, or safety."

31 Page 1, strike lines 101 and 102 and substitute "**CONCERNING**
32 **PROHIBITIONS ON RAPID-FIRE TRIGGER ACTIVATORS.**".
