

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB25-003 be amended as follows:

1 Amend reengrossed bill, page 15, before line 20 insert:

2 "(c) (I) BEFORE DECEMBER 31, 2029, IN ORDER TO IMPLEMENT
3 THIS SECTION, THE DIRECTOR OF THE DIVISION MAY REPORT TO THE STATE
4 TREASURER AN AMOUNT OF MONEY TO TRANSFER TO THE FIREARMS
5 TRAINING AND SAFETY COURSE CASH FUND FROM THE PARKS AND
6 OUTDOOR RECREATION CASH FUND OR FROM THE WILDLIFE CASH FUND.
7 WITHIN THREE DAYS AFTER RECEIVING A REPORT FROM THE DIRECTOR,
8 THE STATE TREASURER SHALL TRANSFER THE AMOUNT OF MONEY
9 DESCRIBED IN THE REPORT FROM THE FUND DESIGNATED IN THE REPORT.
10 THE DIRECTOR OF THE DIVISION MAY MAKE MULTIPLE REPORTS TO THE
11 TREASURER PURSUANT TO THIS SUBSECTION (5)(c)(I).

12 (II) (A) IN ORDER TO RESTORE TO THE PARKS AND OUTDOOR
13 RECREATION CASH FUND AND THE WILDLIFE CASH FUND THE AMOUNT OF
14 MONEY TRANSFERRED FROM EACH FUND PURSUANT TO SUBSECTION
15 (5)(c)(I) OF THIS SECTION, THE DIRECTOR OF THE DIVISION MAY REPORT TO
16 THE STATE TREASURER AN AMOUNT OF MONEY TO TRANSFER FROM THE
17 FIREARMS TRAINING AND SAFETY COURSE CASH FUND TO THE PARKS AND
18 OUTDOOR RECREATION CASH FUND OR TO THE WILDLIFE CASH FUND.
19 WITHIN THREE DAYS AFTER RECEIVING A REPORT FROM THE DIRECTOR,
20 THE STATE TREASURER SHALL TRANSFER THE AMOUNT OF MONEY
21 DESCRIBED IN THE REPORT TO THE FUND DESIGNATED IN THE REPORT. THE
22 DIRECTOR OF THE DIVISION MAY MAKE MULTIPLE REPORTS TO THE
23 TREASURER PURSUANT TO THIS SUBSECTION (5)(c)(II)(A).

24 (B) THE TOTAL AMOUNT OF THE TRANSFERS TO THE PARKS AND
25 OUTDOOR RECREATION CASH FUND AND TO THE WILDLIFE CASH FUND
26 PURSUANT TO THIS SUBSECTION (5)(c)(II) MUST NOT BE GREATER THAN
27 THE TOTAL AMOUNT TRANSFERRED FROM THE RELEVANT CASH FUND
28 PURSUANT TO SUBSECTION (5)(c)(I) OF THIS SECTION.

29 (C) BY JUNE 30, 2030, THE TOTAL AMOUNT OF THE TRANSFERS TO
30 THE PARKS AND OUTDOOR RECREATION CASH FUND REPORTED BY THE
31 DIRECTOR OF THE DIVISION TO THE STATE TREASURER PURSUANT TO THIS
32 SUBSECTION (5)(c)(II) MUST BE EQUAL TO THE TOTAL AMOUNT
33 TRANSFERRED FROM THE PARKS AND OUTDOOR RECREATION CASH FUND
34 PURSUANT TO SUBSECTION (5)(c)(I) OF THIS SECTION.

35 (D) BY JUNE 30, 2030, THE TOTAL AMOUNT OF THE TRANSFERS TO
36 THE WILDLIFE CASH FUND REPORTED BY THE DIRECTOR OF THE DIVISION TO
37 THE STATE TREASURER PURSUANT TO THIS SUBSECTION (5)(c)(II) MUST BE
38 EQUAL TO THE TOTAL AMOUNT TRANSFERRED FROM THE WILDLIFE CASH
39 FUND PURSUANT TO SUBSECTION (5)(c)(I) OF THIS SECTION.

40 (III) THIS SUBSECTION (5)(c) IS REPEALED, EFFECTIVE JULY 1,
41 2030."
