1 Amend the Judiciary Committee Report, dated March 11, 2025, page 4,
2 before line 11, insert:

3 "Page 13 of the reengrossed bill, before line 7, insert:

4 "(6) IF THE REVISOR OF STATUTES RECEIVES NOTICE PURSUANT TO
5 SECTION 33-9-115 (6), SUBSECTIONS (1) TO (5) OF THIS SECTION BECOME
6 EFFECTIVE UPON THE DATE IDENTIFIED IN THE NOTICE THAT THE DIRECTOR
7 RECEIVED THE LETTER FROM THE UNITED STATE FISH AND WILDLIFE
8 SERVICE OR, IF THE NOTICE DOES NOT SPECIFY THAT DATE, UPON THE DATE
9 OF THE NOTICE TO THE REVISOR OF STATUTES."."

10 Page 6 of the report, after line 12, insert:

11 "Page 15 of the bill, before line 20, insert:

12 "(6) THE DIRECTOR OF LEGISLATIVE COUNCIL SHALL REQUEST A
13 LETTER FROM THE UNITED STATES FISH AND WILDLIFE SERVICE THAT THE
14 PROVISIONS OF SENATE BILL 25-003 WILL NOT RESULT IN THE LOSS OF
15 FEDERAL FUNDING. THIS SECTION, SECTION 18-12-116, AND SECTION
16 24-35-112 WILL TAKE EFFECT ONLY IF THE DIRECTOR OF RESEARCH
17 RECEIVES THE LETTER. THE DIRECTOR OF RESEARCH OF THE LEGISLATIVE
18 COUNCIL OF THE GENERAL ASSEMBLY SHALL NOTIFY THE REVISOR OF
19 STATUTES IN WRITING IF THE DIRECTOR RECEIVES THE LETTER BY
20 EMAILING THE NOTICE TO REVISOROFSTATUTES.GA@COLEG.GOV. THIS
21 SECTION, SECTION 18-12-116, AND SECTION 24-35-112 ARE EFFECTIVE
22 UPON THE DATE IDENTIFIED IN THE NOTICE THAT THE DIRECTOR RECEIVED
23 THE LETTER OR, IF THE NOTICE DOES NOT SPECIFY THAT DATE, UPON THE
24 DATE OF THE NOTICE TO THE REVISOR OF STATUTES."."

25 Page 6 of the report, line 16, before "THE" insert "(1)".

26 Page 6 of the report, strike line 25 and substitute "APPLIES.

27 (2) IF THE REVISOR OF STATUTES RECEIVES NOTICE PURSUANT TO
28 SECTION 33-9-115 (6), SUBSECTION (1) OF THIS SECTION BECOMES
29 EFFECTIVE UPON THE DATE IDENTIFIED IN THE NOTICE THAT THE DIRECTOR
30 RECEIVED THE LETTER FROM THE UNITED STATE FISH AND WILDLIFE
31 SERVICE OR, IF THE NOTICE DOES NOT SPECIFY THAT DATE, UPON THE DATE
32 OF THE NOTICE TO THE REVISOR OF STATUTES."."

33 Page 18 of the bill, strike lines 13 through 15 and substitute:

34 "**SECTION 10. Effective date.** This section; sections 11 and 12
35 of this act; and section 18-12-116 (6), section 33-9-115- (6), and section
36 24-35-122, Colorado Revised Statutes, as enacted in sections 2, 3, and 7
37 of this act, respectively, take effect upon passage; and the remainder of
38 this act takes effect on the date the revisor of statutes receives the notice
39 required by section 33-9-115 (6), Colorado Revised Statutes, as enacted
40 in section 3 of this act."
