

## SENATE FLOOR AMENDMENT

Second Reading

1 Amend reengrossed bill, page 16, after line 22 insert:

2           **"SECTION 14.** In Colorado Revised Statutes, 1-3-103, **amend**  
3 (5) and (6) as follows:

4           **1-3-103. Party committees.**

5           (5) (a) When a state senatorial district is comprised of one or more  
6 whole counties or of a part of one county and all or a part of one or more  
7 other counties, a state senatorial central committee shall consist of ~~the~~  
8 ~~elected precinct committee persons~~, the chairpersons, vice-chairpersons,  
9 and secretary of the several party county central committees, who reside  
10 within the state senatorial district. If any of those officers do not reside in  
11 the state senatorial district, replacements shall be provided who do reside  
12 in the district. The state senatorial central committee shall also include the  
13 elected state senator of the party for the state senatorial district, the state  
14 representatives of the party who reside within the state senatorial district,  
15 and a chairperson, vice-chairperson, and secretary of the state senatorial  
16 central committee, who may or may not be elected from among, but shall  
17 be elected by, the chairpersons, vice-chairpersons, and secretary, the state  
18 senator, and the state representatives.

19           (b) When a state senatorial district is comprised of a portion of  
20 one county, a state senatorial central committee shall consist of ~~the~~  
21 ~~elected precinct committee persons~~, the elected state senator, the elected  
22 state representatives, and a chairperson, vice-chairperson, and secretary  
23 of the state senatorial central committee, all of whom are of the party and  
24 reside in that senatorial district. In addition, the chairperson,  
25 vice-chairperson, and secretary of the party county central committee  
26 shall be members of each state senatorial central committee, who reside  
27 within the senatorial district. The chairperson, vice-chairperson, and  
28 secretary of the state senatorial central committee may or may not be  
29 elected from among, but shall be elected by, the state senatorial central  
30 committee. The committee shall meet on the same date and select a  
31 chairperson and vice-chairperson in the same manner as the party county  
32 central committee.

33           (6) (a) When a state representative district is comprised of one or  
34 more whole counties or of a part of one county and all or a part of one or  
35 more other counties, a state representative central committee shall consist  
36 of ~~the elected precinct committee persons~~, the chairpersons,  
37 vice-chairpersons, and secretary of the several party county central  
38 committees, who reside within the state representative district. If any of  
39 those officers do not reside in the state representative district,  
40 replacements shall be provided who do reside in the district. The state

1 representative central committee shall also include the elected state  
2 representative of the party for the state representative district, each state  
3 senator of the party who resides within that representative district, and a  
4 chairperson, vice-chairperson, and secretary of the state representative  
5 central committee, who may or may not be elected from among, but shall  
6 be elected by, the chairpersons, vice-chairpersons, and secretary, the state  
7 representative, and the state senators.

8 (b) When a state representative district is comprised of a portion  
9 of one county, a state representative central committee shall consist of ~~the~~  
10 ~~elected precinct committee persons~~, the elected state representative, the  
11 elected state senators, and a chairperson, vice-chairperson, and secretary  
12 of the state representative central committee, all of whom are of the party  
13 and reside in that state representative district. In addition, the chairperson,  
14 vice-chairperson, and secretary of the party county central committee,  
15 who reside within the state representative district, shall be members of the  
16 state representative central committee. The chairperson, vice-chairperson,  
17 and secretary of the state representative district central committee may or  
18 may not be elected from among, but shall be elected by, the state  
19 representative central committee. The committee shall meet on the same  
20 date and select a chairperson and vice-chairperson in the same manner as  
21 the party county central committee."
