BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the "Extreme Risk Protection Order Implementation Working Group Congressional Review Emergency Amendment Act of 2021". Sec. 2. Title X of the Firearms Control Regulations Act of 1975, effective May 10, 2019 (D.C. Law 22-314; D.C. Official Code § 7–2501.01 et seq.), is amended by adding a new section 1013 to read as follows: "Sec. 1013. Extreme Risk Protection Order Implementation Working Group. "(a) There is established an Extreme Risk Protection Order Implementation Working Group ("Working Group"), which shall be composed of the following individuals: "(1) District government members, or their designees: "(A) The Chairperson of the Council's Committee on the Judiciary and Public Safety; "(B) The Deputy Mayor for Public Safety and Justice; "(C) The Deputy Mayor for Health and Human Services;

79 Sec. 3. Fiscal impact statement.

The Council adopts the fiscal impact statement of the Budget Director as the fiscal impact statement required by section 4a of the General Legislative Procedures Act of 1975, approved October 16, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).

Sec. 4. Effective date.

This act shall take effect following approval by the Mayor (or in the event of veto by the Mayor, action by the Council to override the veto), and shall remain in effect for no longer than 90 days, as provided for emergency acts of the Council of the District of Columbia in section 412(a) of the District of Columbia Home Rule Act, approved December 24, 1973 (87 Stat. 788; D.C. Official Code § 1-204.12(a)).
