

SENATE BILL No. 484

DIGEST OF INTRODUCED BILL

Citations Affected: IC 6-6-10; IC 10-14; IC 13-11-2; IC 13-25; IC 21-39-7-7.

Synopsis: Fire and emergency response issues. Creates the intrastate mutual aid compact to complement existing mutual aid agreements. Allows the Indiana department of homeland security (IDHS) to deploy a national urban search and rescue response system task force as a state resource during Indiana emergencies and disasters, in conformance with federal requirements, through an agreement with a political subdivision that is a sponsoring agency of a task force. Repeals the interstate emergency management and disaster compact. Repeals the local emergency planning and right to know fund administered by the department of state revenue. Creates the local emergency planning and right to know fund administered by the IDHS, for the purpose of providing each county with funds to help implement the Superfund Amendments and Reauthorization Act of 1986 (SARA). Requires fees paid by facilities submitting tier II emergency and hazardous chemical inventories to be paid to the Indiana emergency response commission for deposit in the local emergency planning and right to know fund. Provides that on July 1, 2015, any remaining balance of the local emergency planning and right to know fund administered by the department of state revenue is transferred to the local emergency planning and right to know fund administered by the IDHS.

SENATE BILL No. 484

A BILL FOR AN ACT to amend the Indiana Code concerning public safety.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 6-6-10 IS REPEALED [EFFECTIVE JULY 1,
- 2 2015]. (Local Emergency Planning and Right to Know Fund).
- 3 SECTION 2. IC 10-14-3-9 IS AMENDED TO READ AS
- 4 FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 9. (a) The agency shall
- 5 prepare and maintain a current state emergency operations plan. The
- 6 plan may provide for the following:
- 7 (1) Prevention and minimization of injury and damage caused by
- 8 disaster.
- 9 (2) Prompt and effective response to disaster.
- 10 (3) Emergency relief.
- 11 (4) Identification of areas particularly vulnerable to disaster.
- 12 (5) Recommendations for:
- 13 (A) zoning;
- 14 (B) building;
- 15 (C) other land use controls;
- 16 (D) safety measures for securing mobile homes or other



- 1 nonpermanent or semipermanent structures; and
 2 (E) other preventive and preparedness measures designed to
 3 eliminate or reduce disaster or its impact;
 4 that must be disseminated to both the fire prevention and building
 5 safety commission and local authorities.
 6 (6) Assistance to local officials in designing local emergency
 7 action plans.
 8 (7) Authorization and procedures for the erection or other
 9 construction of temporary works designed to protect against or
 10 mitigate danger, damage, or loss from flood, conflagration, or
 11 other disaster.
 12 (8) Preparation and distribution to the appropriate state and local
 13 officials of state catalogs of federal, state, and private assistance
 14 programs.
 15 (9) Organization of manpower and chains of command.
 16 (10) Coordination of federal, state, and local disaster activities.
 17 (11) Coordination of the state disaster plan with the disaster plans
 18 of the federal government.
 19 (12) Other necessary matters.
 20 (b) The agency shall take an integral part in the development and
 21 revision of local and interjurisdictional disaster plans prepared under
 22 section 17 of this chapter. The agency shall employ or otherwise secure
 23 the services of professional and technical personnel capable of
 24 providing expert assistance to political subdivisions, a political
 25 subdivision's disaster agencies, and interjurisdictional planning and
 26 disaster agencies. These personnel:
 27 (1) shall consult with subdivisions and government agencies on
 28 a regularly scheduled basis;
 29 (2) shall make field examinations of the areas, circumstances, and
 30 conditions to which particular local and interjurisdictional
 31 disaster plans are intended to apply; and
 32 (3) may suggest revisions.
 33 (c) In preparing and revising the state disaster plan, the agency shall
 34 seek the advice and assistance of local government, business, labor,
 35 industry, agriculture, civic and volunteer organizations, and community
 36 leaders. In advising local and interjurisdictional agencies, the agency
 37 shall encourage local and interjurisdictional agencies to seek advice
 38 from the sources specified in this subsection.
 39 (d) The state disaster plan or any part of the plan may be
 40 incorporated in rules of the agency or by executive orders.
 41 (e) The agency shall do the following:
 42 (1) Determine requirements of the state and political subdivisions



- 1 for food, clothing, and other necessities in the event of an
 2 emergency.
- 3 (2) Procure and pre-position supplies, medicines, materials, and
 4 equipment.
- 5 (3) Adopt standards and requirements for local and
 6 interjurisdictional disaster plans.
- 7 (4) Provide for mobile support units.
- 8 (5) Assist political subdivisions, political subdivisions' disaster
 9 agencies, and interjurisdictional disaster agencies to establish and
 10 operate training programs and public information programs.
- 11 (6) Make surveys of industries, resources, and facilities in
 12 Indiana, both public and private, necessary to carry out this
 13 chapter.
- 14 (7) Plan and make arrangements for the availability and use of
 15 any private facilities, services, and property, and if necessary and
 16 if the private facilities, services, or property is used, provide for
 17 payment for the use under agreed upon terms and conditions.
- 18 (8) Establish a register of persons with types of training and skills
 19 important in emergency prevention, preparedness, response, and
 20 recovery.
- 21 (9) Establish a register of mobile and construction equipment and
 22 temporary housing available for use in a disaster emergency.
- 23 (10) Prepare, for issuance by the governor, executive orders,
 24 proclamations, and regulations necessary or appropriate in coping
 25 with disaster.
- 26 (11) Cooperate with the federal government and any public or
 27 private agency or entity in achieving any purpose of this chapter
 28 and in implementing programs for disaster prevention,
 29 preparation, response, and recovery.
- 30 (12) Do other things necessary, incidental, or appropriate to
 31 implement this chapter.
- 32 (f) The agency shall ascertain the rapid and efficient
 33 communications that exist in times of disaster emergencies. The agency
 34 shall consider the desirability of supplementing these communications
 35 resources or of integrating these resources into a comprehensive
 36 intrastate or state-federal telecommunications or other communications
 37 system or network. In studying the character and feasibility of any
 38 system, the agency shall evaluate the possibility of multipurpose use of
 39 the system for general state and local governmental purposes. The
 40 agency shall make appropriate recommendations to the governor.
- 41 (g) The agency shall ~~develop a statewide mutual aid program to~~
 42 ~~implement the statewide mutual aid agreement.~~ **assist political**



1 **subdivisions in implementing the intrastate mutual aid compact**
 2 **created by section 10.8 of this chapter.**

3 SECTION 3. IC 10-14-3-10.6 IS REPEALED [EFFECTIVE JULY
 4 1, 2015]. Sec. 10.6. (a) As used in this section, "participating unit"
 5 refers to a unit that does not opt out under subsection (c) from
 6 participating in the statewide mutual aid program.

7 (b) As used in this section, "unit" means the following:

8 (1) A unit (as defined in IC 36-1-2-23);

9 (2) A fire protection district established under IC 36-8-11;

10 (3) A provider unit (as defined in IC 36-8-19-3) acting on behalf
 11 of a fire protection territory established under IC 36-8-19;

12 (4) A fire department established by the board of trustees of a
 13 state educational institution (as defined in IC 21-7-13-32);
 14 including a fire department established by the board of trustees of
 15 Purdue University under IC 21-39-7.

16 (c) A unit may choose not to participate in the statewide mutual aid
 17 program if the unit:

18 (1) adopts an ordinance or a resolution declaring that the unit will
 19 not participate in the statewide mutual aid program; and

20 (2) provides a copy of the ordinance or resolution to:

21 (A) the local emergency management organization that serves
 22 the unit; and

23 (B) the department.

24 (d) Each participating unit shall establish an incident management
 25 system and a unified command system to be used in a response to a
 26 disaster or an emergency.

27 (e) A participating unit may request the assistance of at least one (1)
 28 other participating unit to:

29 (1) manage disaster response or recovery; or

30 (2) conduct disaster response or recovery related exercises;
 31 testing; or training.

32 The participating unit that requests assistance shall provide a copy of
 33 the request to the emergency operations center within the division of
 34 emergency response and recovery not more than forty-eight (48) hours
 35 after making the request.

36 (f) A request for assistance to a participating unit under subsection
 37 (e) shall be made by and to the executive of the unit or the executive's
 38 authorized representative. A request may be oral or in writing. A
 39 written request shall be made on forms developed by the department.
 40 An oral request shall be confirmed in writing not later than twenty-four
 41 (24) hours after the oral request is made.

42 (g) A request must include the following information:



- 1 (1) A description of the disaster response and recovery functions
 2 for which assistance is needed, including the following:
 3 (A) Fire:
 4 (B) Law enforcement:
 5 (C) Emergency medical:
 6 (D) Transportation:
 7 (E) Communications:
 8 (F) Public works and engineering:
 9 (G) Building inspection:
 10 (H) Planning and information assistance:
 11 (I) Mass care:
 12 (J) Resource support:
 13 (K) Health and other medical services:
 14 (L) Search and rescue:
 15 (2) The amount and type of services; equipment; supplies;
 16 materials; personnel; and other resources needed and a reasonable
 17 estimate of the length of time they will be needed.
 18 (3) The specific place and time for staging of the assisting
 19 participating unit's provision of assistance and a point of contact
 20 at that location.
 21 (4) A statement that the request for assistance is being made
 22 through the statewide mutual aid program.
 23 (h) A participating unit that is requested to render assistance shall
 24 take the necessary action to provide and make available the requested
 25 services; equipment; supplies; materials; personnel; and other
 26 resources.
 27 (i) A participating unit's obligation to provide assistance is subject
 28 to the following restrictions:
 29 (1) A participating unit's request to receive assistance is effective
 30 only:
 31 (A) upon declaration of a local disaster emergency by the
 32 principal executive officer of the unit under section 29 of this
 33 chapter; or
 34 (B) upon the commencement of the exercises; testing; or
 35 training:
 36 (2) The assistance shall continue as long as:
 37 (A) the state of emergency remains in effect and the loaned
 38 resources are required by the receiving participating unit or the
 39 loaned resources remain in the receiving participating unit; or
 40 (B) the exercises; testing; or training is in progress.
 41 (3) The participating unit rendering the assistance may withhold
 42 resources or recall loaned resources to the extent necessary to



1 provide for the participating unit's own reasonable protection.

2 (4) Emergency forces providing assistance shall continue under
3 the command and control of their regular leaders; but
4 operationally those forces shall be under the control of the
5 incident commander or unified commander designated by the
6 requesting participating unit.

7 SECTION 4. IC 10-14-3-10.7 IS REPEALED [EFFECTIVE JULY
8 1, 2015]. Sec. 10.7. (a) As used in this section, "participating unit" has
9 the meaning set forth in section 10.6(a) of this chapter.

10 (b) Each participating unit shall provide for the payment of
11 compensation and benefits to:

12 (1) an injured member; and

13 (2) a representative of a deceased member;

14 of the participating unit's emergency forces if the member is injured or
15 killed while rendering assistance under section 10.6 of this chapter in
16 the same manner and on the same terms as if the injury or death were
17 sustained while the member was rendering assistance for or within the
18 member's own unit. Expenses incurred under this subsection are not
19 reimbursable under subsection (c):

20 (c) A participating unit that complies with subsection (b) and
21 renders assistance for disaster response or recovery to another
22 participating unit under section 10.6 of this chapter shall be reimbursed
23 by the participating unit receiving the assistance for the following:

24 (1) A loss of, damage to, or expense incurred in the operation of
25 any equipment in answering the request for assistance; to the
26 extent the loss, damage, or expense is not covered by a
27 reimbursement from insurance to the participating unit rendering
28 assistance.

29 (2) An expense incurred in the provision of a service in answering
30 the request for assistance; to the extent the expense is not covered
31 by a reimbursement from insurance to the participating unit
32 rendering assistance.

33 (3) An expense incurred in answering the request for assistance;
34 to the extent the expense is not covered by a reimbursement from
35 insurance to the participating unit rendering assistance.

36 (4) An amount equal to the deductible portion of an insurance
37 policy used to reimburse all or part of an expense or other cost
38 described in subdivisions (1) through (3):

39 (d) Except as provided by an agreement entered into under
40 subsection (c); the following labor and equipment reimbursement rates
41 apply to reimbursement under subsection (c):

42 (1) The labor reimbursement rates are as follows:



- 1 (A) The straight time costs of the labor force of the
 2 participating unit rendering assistance shall be reimbursed at
 3 the normal pay rates for responding personnel.
 4 (B) The overtime costs of the labor force of the participating
 5 unit rendering assistance shall be reimbursed at one hundred
 6 fifty percent (150%) of the normal pay rates for the responding
 7 personnel if it is the normal practice of the requesting unit to
 8 pay these personnel overtime.
- 9 (2) The equipment reimbursement rates are the lesser of the
 10 following:
 11 (A) The rates for equipment costs reimbursement established
 12 by the Federal Emergency Management Agency or its
 13 successor agency.
 14 (B) The equipment costs established by the participating unit
 15 rendering assistance.
- 16 (e) At least two (2) participating units may enter into agreements
 17 establishing a different allocation of loss, damage, expense, or costs
 18 among themselves than that specified in subsections (c) and (d).
 19 (f) Officers and employees of a participating unit rendering
 20 assistance to another participating unit under this section shall be
 21 considered agents of the requesting participating unit for the purpose
 22 of tort liability and immunity.
 23 (g) This section does not prevent any participating unit from
 24 entering into a mutual aid or other agreement with another unit, fire
 25 protection district, or provider unit (as defined in IC 36-8-19-3) acting
 26 on behalf of a fire protection territory, or affect any other agreement to
 27 which a unit, a fire protection district, or a fire protection territory is a
 28 party, including an agreement entered into under this chapter or
 29 IC 36-1-7.
 30 (h) A participating unit rendering assistance that seeks
 31 reimbursement under subsection (e) must submit to the participating
 32 unit receiving assistance, not more than thirty (30) days after the date
 33 on which the assistance is rendered, an itemized statement of the
 34 expenses described in subsection (e) for which the participating unit
 35 rendering assistance seeks reimbursement.
- 36 SECTION 5. IC 10-14-3-10.8 IS ADDED TO THE INDIANA
 37 CODE AS A NEW SECTION TO READ AS FOLLOWS
 38 [EFFECTIVE JULY 1, 2015]: **Sec. 10.8. (a) The following definitions**
 39 **apply to this section:**
 40 (1) "Chief executive" means:
 41 (A) the chief executive of a participant, or the chief
 42 executive's designee, for purposes of the intrastate mutual



- 1 aid compact created under this section; or
 2 (B) if the participant does not have a chief executive, a
 3 member of the participant's governing body or the
 4 governing body's designee for purposes of the intrastate
 5 mutual aid compact created under this section.
 6 (2) "Emergency management agency" means an organization
 7 for emergency management established under this chapter.
 8 (3) "Participant" means any of the following:
 9 (A) A political subdivision.
 10 (B) A volunteer fire department.
 11 (C) A fire department established by the board of trustees
 12 of a state educational institution (as defined in
 13 IC 21-7-13-32), including a fire department established by
 14 the board of trustees of Purdue University under
 15 IC 21-39-7.
 16 The term does not include an entity under clause (A), (B), or
 17 (C) that chooses to reject participation in the intrastate
 18 mutual aid program by adopting an ordinance or resolution
 19 declaring that the entity will not participate in the intrastate
 20 mutual aid program and provides a copy of the appropriate
 21 ordinance or resolution to the agency and to the emergency
 22 management agency serving the entity.
 23 (4) "Planned event" means a scheduled nonemergency
 24 activity. Planned event includes a sporting event, concert, or
 25 parade.
 26 (5) "Provider participant" means a participant that provides
 27 assistance or aid to a requesting participant under the
 28 intrastate mutual aid compact created under this section.
 29 (6) "Requesting participant" means a participant that receives
 30 assistance or aid from a provider participant under the
 31 intrastate mutual aid compact created under this section.
 32 (7) "Volunteer fire department" has the meaning set forth in
 33 IC 36-8-12-2.
 34 (b) This section creates an intrastate mutual aid program to be
 35 known as Indiana's intrastate mutual aid compact to complement
 36 existing mutual aid agreements. This program has the following
 37 two (2) purposes:
 38 (1) Provide for mutual assistance or aid among participants
 39 for purposes of preparing for, responding to, and recovering
 40 from any incident, disaster, exercise, training activity, or
 41 planned event that requires additional resources.
 42 (2) Establish a method by which a participant may seek



- 1 assistance or aid that:
- 2 (A) resolves many of the common issues facing political
- 3 subdivisions before, during, and after an incident, disaster,
- 4 exercise, training activity, or planned event, any of which
- 5 requires additional resources; and
- 6 (B) ensures, to the extent possible, eligibility for available
- 7 state and federal disaster assistance or other funding.
- 8 (c) Each participant shall, to the extent practicable, identify and
- 9 inventory the current services, equipment, supplies, personnel, and
- 10 other resources related to the preparedness, response, and
- 11 recovery activities of the participant. The participant shall perform
- 12 the identification and inventory in coordination with, to the extent
- 13 feasible, all departments, divisions, boards, commissions, agencies,
- 14 and other instrumentalities within the participant.
- 15 (d) A participant that is impacted by any incident, disaster,
- 16 exercise, training activity, or planned event that requires
- 17 additional resources may request mutual assistance or aid from
- 18 any other participant. This request shall be made by the chief
- 19 executive of the requesting participant to the chief executive of a
- 20 provider participant. If the request is made orally, the requesting
- 21 participant shall provide the provider participant with written
- 22 confirmation of the request not later than seventy-two (72) hours
- 23 after the oral request is made. A request must provide the
- 24 following information:
- 25 (1) A description of the incident, disaster, exercise, training
- 26 activity, or planned event.
- 27 (2) A description of the assistance or aid needed.
- 28 (3) An estimate of the length of time the assistance or aid will
- 29 be needed.
- 30 (4) The specific place and time for staging of the assistance or
- 31 aid and a point of contact at that location.
- 32 (5) A statement that the request for assistance is being made
- 33 through the intrastate mutual aid compact.
- 34 (e) A provider participant shall provide assistance or aid to a
- 35 requestor participant subject to the following:
- 36 (1) The provider participant may withhold resources the
- 37 provider participant determines to be necessary to provide for
- 38 the provider participant's own protection.
- 39 (2) Personnel of the provider participant shall continue under
- 40 the personnel's local command and control structure, but
- 41 shall be under the operational control of the appropriate
- 42 officials within the incident management system of the



- 1 **requesting participant.**
- 2 **(3) Law enforcement officers rendering assistance or aid**
- 3 **under this section have the same powers and duties as law**
- 4 **enforcement officers of the requesting participant, but only**
- 5 **for the period the law enforcement officers are engaged in**
- 6 **activities authorized by the requesting participant, and are**
- 7 **subject to the law as if the law enforcement officers were**
- 8 **providing services within the law enforcement officer's own**
- 9 **jurisdiction.**
- 10 **(f) Each provider participant shall provide for the payment of**
- 11 **compensation and benefits to:**
- 12 **(1) an injured member; and**
- 13 **(2) a representative of a deceased member;**
- 14 **of the provider participant's emergency forces, if the member is**
- 15 **injured or killed while rendering assistance under this section in**
- 16 **the same manner and on the same terms as if the injury or death**
- 17 **were sustained while the member was rendering assistance for or**
- 18 **within the member's own jurisdiction.**
- 19 **(g) Personnel of a provider participant shall be considered,**
- 20 **while rendering assistance or aid, or while en route to or from**
- 21 **rendering assistance or aid, to a requesting participant, to be**
- 22 **agents of the provider participant for purposes of tort liability and**
- 23 **immunity from tort liability under state law.**
- 24 **(h) If a person:**
- 25 **(1) holds a license, certificate, or other permit issued by a**
- 26 **participant evidencing qualification in a professional,**
- 27 **mechanical, or other skill; and**
- 28 **(2) provides assistance or aid at the request of a provider**
- 29 **participant;**
- 30 **the person shall be considered to be licensed or certified in or**
- 31 **permitted by the requesting participant to render the assistance or**
- 32 **aid.**
- 33 **(i) Subject to subsection (k) and except as provided in subsection**
- 34 **(j), a provider participant shall be reimbursed by the requesting**
- 35 **participant for the following:**
- 36 **(1) Any loss of or damage to, or expense incurred in the**
- 37 **operation of, any equipment used in rendering the assistance**
- 38 **or aid. To avoid duplication of payments, insurance proceeds**
- 39 **available to cover any loss of or damage to equipment of a**
- 40 **provider participant shall be considered in the reimbursement**
- 41 **by the requesting participant.**
- 42 **(2) Any expense incurred in the provision of any service used**



- 1 **in rendering the assistance or aid.**
- 2 **(3) All other costs incurred in responding to the request for**
- 3 **assistance or aid.**
- 4 **(j) A provider participant may not be reimbursed for:**
- 5 **(1) the first twelve (12) hours of mutual assistance or aid**
- 6 **provided to the requesting participant; or**
- 7 **(2) expenses the provider participant incurs under subsection**
- 8 **(f).**
- 9 **(k) A provider participant may do any of the following:**
- 10 **(1) Assume, in whole or in part, any loss, damage, expense, or**
- 11 **cost the provider participant incurs in rendering the**
- 12 **assistance or aid.**
- 13 **(2) Loan, without charge, any equipment, or donate any**
- 14 **service, to the requesting participant.**
- 15 **(3) Enter into agreements with one (1) or more other**
- 16 **participants to establish different allocations of losses,**
- 17 **damages, expenses, or costs among the participants.**
- 18 **(l) Nothing in this section does any of the following:**
- 19 **(1) Prohibits a private company from participating in the**
- 20 **provision of mutual assistance or aid under the intrastate**
- 21 **mutual aid compact created under this section if:**
- 22 **(A) the participant approves the participation; and**
- 23 **(B) the contract with the private company allows for the**
- 24 **participation.**
- 25 **(2) Precludes a participant from entering into a mutual aid or**
- 26 **other agreement with another political subdivision or**
- 27 **participant.**
- 28 **(3) Affects any other agreement to which a participant may be**
- 29 **a party or any request for assistance or aid that may be made,**
- 30 **under any other state statute.**
- 31 **SECTION 6. IC 10-14-3-19.5 IS ADDED TO THE INDIANA**
- 32 **CODE AS A NEW SECTION TO READ AS FOLLOWS**
- 33 **[EFFECTIVE JULY 1, 2015]: Sec. 19.5. (a) The following definitions**
- 34 **apply to this section:**
- 35 **(1) "Activates" or "activated" refers to the status of a task**
- 36 **force or a task force resource placed at the direction, control,**
- 37 **and funding of the agency in accordance with an agreement**
- 38 **entered into in accordance with this section.**
- 39 **(2) "Task force" means a United States Department of**
- 40 **Homeland Security national urban search and rescue**
- 41 **response system task force established under 44 CFR 208.**
- 42 **(b) The agency may enter into an agreement with a political**



1 subdivision that is a sponsoring agency of a task force to establish
 2 the terms and conditions that would be applicable if the agency
 3 activates the task force as a state resource in anticipation of or in
 4 response to an emergency or disaster. Under this agreement, the
 5 agency may reimburse the political subdivision for allowable costs
 6 and at the rates established under 44 CFR 208 and may reimburse
 7 the political subdivision for all payments for death, disability, or
 8 injury of an individual incurred in the course of duty while the
 9 individual is serving as an activated member of an activated task
 10 force.

11 (c) While an individual is serving as an activated member of an
 12 activated task force:

13 (1) if the individual is an employee of the state or a political
 14 subdivision of the state, whether serving within or outside the
 15 political subdivision, the individual:

16 (A) has the:

17 (i) powers;

18 (ii) duties;

19 (iii) rights;

20 (iv) privileges; and

21 (v) immunities;

22 that are provided for an employee of the state or a political
 23 subdivision of the state and are incidental to the
 24 individual's employment; and

25 (B) shall receive the compensation and benefits incidental
