## ENGROSSED HOUSE BILL No. 1004

---

A BILL FOR AN ACT concerning human services.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. [EFFECTIVE UPON PASSAGE] (a) **As used in this**  
2 **SECTION, "commission" refers to the prekindergarten and early**  
3 **learning study commission established by subsection (b).**  
4 (b) **The prekindergarten and early learning study commission**  
5 **is established.**  
6 (c) **The legislative council established by IC 2-5-1.1-1 shall**  
7 **determine the number of members to appoint to the commission.**  
8 **The members of the commission may consist of legislators and lay**  
9 **members. The legislative council shall specify the number of**  
10 **legislative members and lay members. The lay members must have**  
11 **expertise in the area of education, business, childhood**  
12 **development, or social services. At least one (1) lay member must**  
13 **be a member of the early learning advisory committee established**  
14 **under IC 12-17.2-3.6-8.**  
15 (d) **The chairman of the legislative council shall appoint the**  
16 **chairperson of the commission. The vice chairman of the legislative**

1 council shall appoint a member of the commission to serve as vice  
2 chairperson of the commission. The chairman and vice chairman  
3 of the legislative council each shall appoint one-half (1/2) of the  
4 remaining members of the commission. If there is an odd number  
5 of members of the commission, the chairman of the legislative  
6 council appoints one (1) more member than the vice chairman of  
7 the legislative council.

8 (e) If a vacancy occurs on the commission, the legislative council  
9 shall appoint an individual to fill the vacancy.

10 (f) The commission shall do the following:

11 (1) Study the feasibility of obtaining a block grant and  
12 necessary waivers under the federal Head Start program  
13 under 42 U.S.C. 9831 et seq. to establish an early learning  
14 scholarship program or another type of alternative program.

15 (2) Study the feasibility of obtaining a Child Care and  
16 Development Block Grant under 42 U.S.C. 9858 et seq. or  
17 other federal funds to fund prekindergarten or early learning  
18 education programs in Indiana.

19 (3) Study options for funding prekindergarten or early  
20 learning programs, including opportunities to partner with  
21 businesses, philanthropic, or community leaders.

22 (4) Review whether other states have developed rigorous  
23 accountability standards for prekindergarten or early  
24 learning programs.

25 (5) Study parental involvement opportunities to prepare  
26 children for education outside the educational environment,  
27 including the benefits of reading to a child.

28 (6) Study opportunities to equip parents with skills necessary  
29 to improve the parent's ability to contribute to their child's  
30 early education.

31 (7) Study the economic benefits of prekindergarten or early  
32 learning programs.

33 (8) Study the appropriate state agency or entity to oversee and  
34 develop early learning accountability standards.

35 (9) Determine the appropriate income standard to use to  
36 determine whether a parent is eligible to receive assistance  
37 from the state for prekindergarten or early learning  
38 programs.

39 (10) Study opportunities to partner with an investment group  
40 or entity to establish an investment fund or vehicle to finance  
41 early education in Indiana.

42 (g) The commission shall submit a final report of the results of



- 1 its study and any recommendations to the legislative council before  
2 November 1, 2014. The report must be in an electronic format  
3 under IC 5-14-6.
- 4 (h) The legislative services agency shall provide staff support to  
5 the commission.
- 6 (i) The affirmative votes of a majority of the members  
7 appointed to the commission are required for the commission to  
8 take action on any measure, including a final report.
- 9 (j) Except as otherwise specifically provided in this SECTION,  
10 the commission shall operate under the rules of the legislative  
11 council.
- 12 (k) This SECTION expires January 1, 2015.  
13 SECTION 2. An emergency is declared for this act.

**"(5) Determine a passage rate on the kindergarten readiness assessment selected under subsection (b) that must be achieved by the children who attend an eligible provider for the eligible provider to continue to participate in the early education scholarship pilot program under IC 12-17.2-7."**

Page 3, line 26, strike "(5)" and insert "(6)".

Page 6, line 7, after "division." insert "**The counties chosen must include both rural and urban counties.**".

Page 6, line 24, delete "may receive" and insert "**is not prohibited from receiving**".

Page 7, line 27, delete "less than seventy percent (70%) of children who attend an" and insert "**the percentage of children who:**

**(1) attend an eligible provider; and**

**(2) pass the kindergarten readiness assessment selected under IC 12-17.2-3.6-9(b);**

**is less than the passage rate determined by the early learning advisory committee under IC 12-17.2-3.6-9(a)(5),"**

Page 7, delete lines 28 through 29.

Page 7, line 30, delete "IC 12-17.2-3.6-9,".

Page 7, line 33, delete "less than seventy" and insert "**the**



percentage of children who:

**(1) attend the eligible provider; and**

**(2) pass the kindergarten readiness assessment selected under IC 12-17.2-3.6-9(b);**

**is less than the passage rate determined by the early learning advisory committee under IC 12-17.2-3.6-9(a)(5)."**

Page 7, delete lines 34 through 36.
