DIGEST OF HB 1370 (Updated March 21, 2017 9:37 am - DI 84)

Citations Affected: IC 36-8.

Synopsis: Completion of training by volunteer firefighters. Requires a volunteer firefighter to successfully complete certain minimum basic training requirements before performing the emergency response duties of a volunteer firefighter.

Effective: July 1, 2017.

- (b) A volunteer firefighter must successfully complete the minimum basic training requirements established by this chapter before performing the emergency response duties of a volunteer firefighter.
- (b) (c) A volunteer firefighter who has successfully completed the minimum basic training requirements established by this chapter may be elected or appointed to membership in more than one (1) volunteer fire department.
