The response period shall be extended an additional thirty (30) calendar days upon the certificate holder's written request submitted to the board;
- (c) Within ten (10) business days of the receipt of the certificate holder's response or the end of the response period established in paragraph (b) of this subsection, board staff shall conduct another review of the complaint to determine if sufficient evidence exists to support a violation.
