12	N. No concealed handgun may be carried into and no concealed handgun		
13	permit issued pursuant to this Section shall authorize or entitle a permittee to carry		
14	a concealed handgun in any of the following:

17	governmental entity, unless the permittee annually completes an eight-hour tactical		
18	training in addition to the training requirements set forth in Subsection D of this

Abstract: Authorizes a concealed handgun permit holder to carry a concealed handgun at a parade or certain demonstrations, if the permit holder annually completes an additional eight-hour tactical training.

<u>Present law</u> provides for the issuance of a concealed handgun permit for a person who meets certain eligibility and training requirements.

<u>Present law</u> provides that a concealed handgun permit does not authorize or entitle the permit holder to carry a concealed handgun in certain places, including at a parade or demonstration for which a permit is issued by a governmental entity.

<u>Proposed law</u> amends <u>present law</u> to authorize a concealed handgun permit holder to carry a concealed handgun at a parade or demonstration for which a permit is issued by a governmental entity, if the permit holder annually completes an eight-hour tactical training in addition to the training requirements set forth in <u>present law</u>.
