(ii) A valid driver's license issued by the state of Louisiana displaying the 16 17 word "Veteran" pursuant to R.S. 32:412(K). (iii) A valid special identification card issued by the state of Louisiana 18 19 displaying the word "Veteran" pursuant to R.S. 40:1321(K). (iv) For a member released from service who does not qualify to have the 20 21 word "Veteran" displayed on a state issued driver's license or special 22 identification card, a Department of Defense Form 214 (DD-214) indicating the 23 character of service as "Honorable" or "Under Honorable Conditions (General)" and a valid driver's license or special identification card issued by 24 25 the state of Louisiana."
