2	To designate Tuesday, May 5, 2015, as Bankers Day at the state capitol.
3	WHEREAS, since 1900, the Louisiana Bankers Association (LBA) has diligently
4	represented the interests of banks and thrifts operating in the state of Louisiana; and
5	WHEREAS, LBA is a member-driven organization with a Government Relations
6	Council that includes representation from all members; such representation assists the LBA's
7	Board of Directors in the development of the association's positions regarding important
8	banking issues; and
9	WHEREAS, LBA's current membership is comprised of one hundred forty-one banks
10	and thrifts, which includes both state and federal charters and small and large institutions;
11	LBA's membership is primarily comprised of locally based community banks; and
