AN ACT

CIVIL/VENUE: Provides relative to civil actions against firearm manufacturers

2	To amend and reenact R.S. 40:1799(A), relative to actions against a firearm or ammunition
3	manufacturers; to provide for proper venue and jurisdiction; and to provide for
4	related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 40:1799(A) is hereby amended and reenacted to read as follows:
7	§1799. Preemption of state law; liability of manufacturer, trade association, or
8	dealer of firearms and ammunition
9	A.(1) The governing authority of any political subdivision or local or other
10	governmental authority of the state is precluded and preempted from bringing suit
11	to recover against any firearms or ammunition manufacturer, trade association, or
12	dealer for damages for injury, death, or loss or to seek other injunctive relief
13	resulting from or relating to the lawful design, manufacture, marketing, or sale of
14	firearms or ammunition. The authority to bring such actions as may be authorized
15	by law shall be reserved exclusively to the state.
16	(2) Notwithstanding any other law to the contrary, the Nineteenth Judicial
17	District Court for the state of Louisiana shall have exclusive jurisdiction and venue
18	of any suit or action of any nature brought by the state against a firearms or
19	ammunition manufacturer, trade association, or dealer.

Abstract: Provides the proper jurisdiction and venue of an action against a firearms or ammunition manufacturer, trade association, or dealer shall be in the 19th Judicial District Court.

<u>Present law</u> precludes and preempts the governing authority of any political subdivision or local or other governmental authority of the state from bringing suit to recover against any firearms or ammunition manufacturer, trade association, or dealer for damages for injury, death, or loss or to seek other injunctive relief resulting from or relating to the lawful design, manufacture, marketing, or sale of firearms or ammunition.

<u>Present law</u> reserves exclusive authority to bring such actions to the state.

<u>Proposed law</u> provides that the 19th JDC shall have exclusive jurisdiction and venue of any suit or action of any nature brought by the state against a firearm or ammunition manufacturer.
