1.7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.8	Section 1. [245.9901] GUN VIOLENCE PROTECTIVE ORDERS.
1.9	Subdivision 1. Definitions. As used in sections 245.9901 to 245.9908, the term "family
1.10	or household members" has the meaning given in section 518B.01, subdivision 2.
1.11	Subd. 2. Court jurisdiction. An application for relief under this section may be filed
1.12	in the county of residence of either party. There are no residency requirements that apply
1.13	to a petition for a gun violence protective order. Actions under this section shall be given
1.14	docket priorities by the court.
1.15	Subd. 3. Information on petitioner's location or residence. Upon the petitioner's
1.16	request, information maintained by the court regarding the petitioner's location or residence
1.17	is not accessible to the public and may be disclosed only to court personnel or law
1.18	enforcement for purposes of service of process, conducting an investigation, or enforcing
1.19	an order.
1.20	Subd. 4. Generally. (a) There shall exist an action known as a petition for a gun violence
1.21	protective order for protection from gun violence, which order shall enjoin and prohibit the
1.22	respondent from possessing firearms for a fixed period.

2.4	(c) A petition for relief shall allege that the respondent poses a significant danger of
2.5	bodily injury to self or to other persons by possessing a firearm, and shall allege that less
2.6	restrictive alternatives are inadequate or inappropriate to the circumstances. The petition

2.17	administrator shall verify the terms of any existing order governing the parties. The court
2.18	may not delay granting relief because of the existence of a pending action between the
2.19	parties or the necessity of verifying the terms of an existing order. A petition for relief may
2.20	be granted whether or not there is a pending action between the parties.

2.22	would also allow for the issuance of an order under chapter 518B, the petitioner must either

2.25	(g) A petition for relief must describe, to the best of the petitioner's knowledge, the types
2.26	and location of any firearms believed by the petitioner to be possessed by the respondent.
2.27	(h) The court shall provide simplified forms and clerical assistance to help with the

2.29	(i) The state court administrator shall create all forms necessary under sections 245.9901

   under section 245.9902 on an earlier date, in which case the order shall expire upon a judge's

(a) Upon issuance of a gun violence protective order, the court shall direct the respondent 7.17 to transfer any firearms the person possesses, within 24 hours, to a federally licensed firearms 7.18 dealer, a law enforcement agency, or third party. The transfer may be permanent or 7.19 temporary. A temporary firearm transfer only entitles the receiving party to possess the 7.20 7.21 firearm and does not transfer ownership or title. If the respondent makes a temporary transfer, a federally licensed firearms dealer or law enforcement agency may charge the respondent 7.22 a reasonable fee to store the firearms and may establish policies for disposal of abandoned 7.23 firearms, provided these policies require that the respondent be notified prior to disposal of 7.24 abandoned firearms. If a respondent permanently transfers the respondent's firearms to a 7.25 law enforcement agency, the agency is not required to compensate the respondent and may 7.26 charge the respondent a reasonable processing fee. A law enforcement agency is not required 7.27 7.28 to accept a respondent's firearm under this section. (b) The respondent must file proof of transfer as provided in this paragraph. 7.29 7.30 (1) A law enforcement agency or federally licensed firearms dealer accepting transfer of a firearm pursuant to this section shall provide proof of transfer to the respondent. The 7.31

- 7.32 proof of transfer must specify whether the firearms were permanently or temporarily
- 7.33 <u>transferred and must include the name of the respondent, date of transfer, and the serial</u>
- 7.34 <u>number</u>, manufacturer, and model of all transferred firearms. If transfer is made to a federally

licensed firearms dealer, the respondent shall, within two business days after being served 8.1 with the order, file a copy of proof of transfer with the law enforcement agency, and attest 8.2 8.3 that all firearms owned or possessed at the time of the order have been transferred in accordance with this section and that the person currently does not possess any firearms. If 8.4 the respondent claims not to own or possess firearms, the respondent shall file a declaration 8.5 of nonpossession with the law enforcement agency attesting that, at the time of the order, 8.6 the respondent neither owned nor possessed any firearms, and that the respondent currently 8.7 8.8 neither owns nor possesses any firearms. 8.9 (2) If the transfer is made to a third party, the third party must sign an affidavit under oath before a notary public either acknowledging that the respondent permanently transferred 8.10 the abusing party's firearms to the third party or agreeing to temporarily store the abusing 8.11 party's firearms until such time as the respondent is legally permitted to possess firearms. 8.12 The affidavit shall indicate the serial number, make, and model of all firearms transferred 8.13 by the abusing party to the third party. The third party shall acknowledge in the affidavit 8.14 that the third party may be held criminally and civilly responsible under section 624.7144 8.15 if the respondent gains access to a transferred firearm while the firearm is in the custody of 8.16 the third party. The respondent shall provide the law enforcement agency with a signed and 8.17 notarized affidavit as described in this section within two business days of the firearms 8.18 8.19 transfer. (3) The court shall seal affidavits, proofs of transfer, and declarations of nonpossession 8.20 filed pursuant to this paragraph. 8.21 (c) If a court issues an emergency order under section 245.9904, or makes a finding of 8.22 immediate and present danger under section 245.9902, subdivision 2, paragraph (e), the 8.23 court shall issue a search warrant to the local law enforcement agency to take immediate 8.24 possession of all firearms in the respondent's possession if there is probable cause to show 8.25 the types and location of firearms in the respondent's possession. dangerous to the public, as defined in section 253B.02, to a treatment facility, or who has
ever been found incompetent to stand trial or not guilty by reason of mental illness, unless
the person's ability to possess a firearm and ammunition has been restored under subdivision
4;

(4) a person who has been convicted in Minnesota or elsewhere of a misdemeanor or
gross misdemeanor violation of chapter 152, unless three years have elapsed since the date
of conviction and, during that time, the person has not been convicted of any other such
violation of chapter 152 or a similar law of another state; or a person who is or has ever
been committed by a judicial determination for treatment for the habitual use of a controlled
substance or marijuana, as defined in sections 152.01 and 152.02, unless the person's ability
to possess a firearm and ammunition has been restored under subdivision 4;

(5) a person who has been committed to a treatment facility in Minnesota or elsewhere
by a judicial determination that the person is chemically dependent as defined in section
253B.02, unless the person has completed treatment or the person's ability to possess a
firearm and ammunition has been restored under subdivision 4. Property rights may not be
abated but access may be restricted by the courts;

(6) a peace officer who is informally admitted to a treatment facility pursuant to section
253B.04 for chemical dependency, unless the officer possesses a certificate from the head
of the treatment facility discharging or provisionally discharging the officer from the
treatment facility. Property rights may not be abated but access may be restricted by the
courts;

(7) a person, including a person under the jurisdiction of the juvenile court, who has
been charged with committing a crime of violence and has been placed in a pretrial diversion
program by the court before disposition, until the person has completed the diversion program
and the charge of committing the crime of violence has been dismissed;

(8) except as otherwise provided in clause (9), a person who has been convicted in
another state of committing an offense similar to the offense described in section 609.224,
subdivision 3, against a family or household member or section 609.2242, subdivision 3,
unless three years have elapsed since the date of conviction and, during that time, the person

has not been convicted of any other violation of section 609.224, subdivision 3, or 609.2242, 12.1 subdivision 3, or a similar law of another state; 12.2 (9) a person who has been convicted in this state or elsewhere of assaulting a family or 12.3 household member and who was found by the court to have used a firearm in any way 12.4 during commission of the assault is prohibited from possessing any type of firearm or 12.5 ammunition for the period determined by the sentencing court; 12.6 (10) a person who: 12.7 (i) has been convicted in any court of a crime punishable by imprisonment for a term 12.8 exceeding one year; 12.9 (ii) is a fugitive from justice as a result of having fled from any state to avoid prosecution 12.10 for a crime or to avoid giving testimony in any criminal proceeding; 12.11 (iii) is an unlawful user of any controlled substance as defined in chapter 152; 12.12 (iv) has been judicially committed to a treatment facility in Minnesota or elsewhere as 12.13 a person who is mentally ill, developmentally disabled, or mentally ill and dangerous to the 12.14 public, as defined in section 253B.02; 12.15 (v) is an alien who is illegally or unlawfully in the United States; 12.16 (vi) has been discharged from the armed forces of the United States under dishonorable 12.17 conditions; 12.18 (vii) has renounced the person's citizenship having been a citizen of the United States; 12.19 12.20 or (viii) is disqualified from possessing a firearm under United States Code, title 18, section 12.21 922(g)(8) or (9), as amended through March 1, 2014; 12.22 (11) a person who has been convicted of the following offenses at the gross misdemeanor 12.23 level, unless three years have elapsed since the date of conviction and, during that time, the 12.24 person has not been convicted of any other violation of these sections: section 609.229 12.25 12.26 (crimes committed for the benefit of a gang); 609.2231, subdivision 4 (assaults motivated by bias); 609.255 (false imprisonment); 609.378 (neglect or endangerment of a child); 12.27 609.582, subdivision 4 (burglary in the fourth degree); 609.665 (setting a spring gun); 609.71 12.28 (riot); or 609.749 (stalking). For purposes of this paragraph, the specified gross misdemeanor 12.29 convictions include crimes committed in other states or jurisdictions which would have 12.30 been gross misdemeanors if conviction occurred in this state; 12.31
