1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. Minnesota Statutes 2020, section 624.714, subdivision 2a, is amended to read:
1.6	Subd. 2a. Training in safe use of a pistol. (a) An applicant must present evidence that
1.7	the applicant received training in the safe use of a pistol within one year of the date of an
1.8	original or renewal application. Training may be demonstrated by:
1.9	(1) employment as a peace officer in the state of Minnesota within the past year; or
1.10	(2) completion of a firearms safety or training course providing basic training in the safe
1.11	use of a pistol and conducted by a certified instructor.
1.12	(b) Basic training must include:
1.13	(1) instruction in the fundamentals of pistol use;
1.14	(2) successful completion of an actual shooting qualification exercise; and
1.15	(3) instruction in the fundamental legal aspects of pistol possession, carry, and use,
1.16	including self-defense and the restrictions on the use of deadly force.
1.17	(c) The certified instructor must issue a certificate to a person who has completed a
1.18	firearms safety or training course described in paragraph (b). The certificate must be signed
1.19	by the instructor and attest that the person attended and completed the course.

- (d) A person qualifies as a certified instructor if the person is certified as a firearms instructor within the past five years by an organization or government entity that has been approved by the Department of Public Safety in accordance with the department's standards. (e) A sheriff must accept the training described in this subdivision as meeting the requirement in subdivision 2, paragraph (b), for training in the safe use of a pistol. A sheriff may also accept other satisfactory evidence of training in the safe use of a pistol. Sec. 2. Minnesota Statutes 2020, section 624.714, subdivision 3, is amended to read: Subd. 3. Form and contents of application. 3.5 (d) In addition to the other application materials, a person who is otherwise ineligible
3.6 for a permit due to a criminal conviction but who has obtained a pardon or expungement
3.7 setting aside the conviction, sealing the conviction, or otherwise restoring applicable rights,

3.9 (e) Applications must be submitted in person.

(f) The sheriff may charge <u>a new an</u> application processing fee in an amount not to
exceed the actual and reasonable direct cost of processing the application or \$100, whichever
is less. Of this amount, \$10 must be submitted to the commissioner and deposited into the
general fund.

(g) This subdivision prescribes the complete and exclusive set of items an applicant is
required to submit in order to apply for a new or renewal permit to carry. The applicant
must not be asked or required to submit, voluntarily or involuntarily, any information, fees,
or documentation beyond that specifically required by this subdivision. This paragraph does
not apply to alternate training evidence accepted by the sheriff under subdivision 2a,
paragraph (d).

3.20 (h) Forms for new and renewal applications must be available at all sheriffs' offices and
3.21 the commissioner must make the forms available on the Internet.

(i) Application forms must clearly display a notice that a permit, if granted, is void and
must be immediately returned to the sheriff if the permit holder is or becomes prohibited
by law from possessing a firearm. The notice must list the applicable state criminal offenses
and civil categories that prohibit a person from possessing a firearm.

3.26 (j) Upon receipt of an application packet and any required fee, the sheriff must provide
3.27 a signed receipt indicating the date of submission.

3.29 Subd. 7. **Permit card contents**; <u>no</u> **expiration**; **renewal**. (a) Permits to carry must be 3.30 on an official, standardized permit card adopted by the commissioner, containing only the 3.31 name, residence, and driver's license number or state identification card number of the 3.32 permit holder, if any.

4.1 (b) The permit card must also identify the issuing sheriff and state the expiration date
4.2 of the permit. The permit card must clearly display a notice that a permit, if granted, is void
4.3 and must be immediately returned to the sheriff if the permit holder becomes prohibited by
4.4 law from possessing a firearm.

4.5 (c) A permit to carry a pistol issued under this section expires five years after the date
4.6 of issue. It may be renewed in the same manner and under the same criteria which the
4.7 original permit was obtained, subject to the following procedures: does not expire. Permit
4.8 cards issued after August 1, 2022, must prominently state that the permit does not expire.

(1) no earlier than 90 days prior to the expiration date on the permit, the permit holder
may renew the permit by submitting to the appropriate sheriff the application packet described
in subdivision 3 and a renewal processing fee not to exceed the actual and reasonable direct
cost of processing the application or \$75, whichever is less. Of this amount, \$5 must be
submitted to the commissioner and deposited into the general fund. The sheriff must process
the renewal application in accordance with subdivisions 4 and 6; and

4.27 currently eligible to renew their permit.

4.28 (b) Paragraph (a) does not apply to records or data concerning an applicant or permit

- 5.2 A person with a valid permit to carry a handgun issued under Minnesota Statutes, section
- 5.3 624.714, prior to August 1, 2022, shall request a replacement permit card that conforms
- 5.4 with the requirements of Minnesota Statutes, section 624.714, subdivision 7, paragraph (c),
- 5.5 prior to the expiration date listed on the permit holder's card. The issuing sheriff may charge
- 5.6 up to \$10 to issue a replacement card under this section.
