1.7	Section 1. Minnesota Statutes 2022, section 624.712, subdivision 7, is amended to read:
1.8	Subd. 7. Semiautomatic military-style assault weapon. (a) "Semiautomatic
1.9	military-style assault weapon" means:
1.10	(1) any of the following firearms:
1.11	(i) Avtomat Kalashnikov (AK-47) semiautomatic rifle type;
1.12	(ii) Beretta AR-70 and BM-59 semiautomatic rifle types;
1.13	(iii) Colt AR-15 semiautomatic rifle type;

- 2.3 (xiii) Steyr AUG semiautomatic rifle type;
- 2.4 (xiv) Street Sweeper and Striker-12 revolving-cylinder shotgun types;
- 2.5 (xv) USAS-12 semiautomatic shotgun type;
- 2.6 (xvi) Uzi semiautomatic pistol and carbine types; or
- 2.7 (xvii) Valmet M76 and M78 semiautomatic rifle types;

(2) any firearm that is another model made by the same manufacturer as one of the
firearms listed in clause (1), and has the same action design as one of the listed firearms,
and is a redesigned, renamed, or renumbered version of one of the firearms listed in clause
(1), or has a slight modification or enhancement, including but not limited to a folding or
retractable stock; adjustable sight; case deflector for left-handed shooters; shorter barrel;
wooden, plastic, or metal stock; larger clip size; different caliber; or a bayonet mount; and

(3) any firearm that has been manufactured or sold by another company under a licensing
agreement with a manufacturer of one of the firearms listed in clause (1) entered into after
the effective date of Laws 1993, chapter 326, to manufacture or sell firearms that are identical
or nearly identical to those listed in clause (1), or described in clause (2), regardless of the
company of production or country of origin.

2.19 The weapons listed in clause (1), except those listed in items (iii), (ix), (x), (xiv), and (xv),
2.20 are the weapons the importation of which was barred by the Bureau of Alcohol, Tobacco,
2.21 and Firearms of the United States Department of the Treasury in July 1989.

2.22 Except as otherwise specifically provided in paragraph (d), a firearm is not a

2.23 "semiautomatic military-style assault weapon" if it is generally recognized as particularly

2.24 suitable for or readily adaptable to sporting purposes under United States Code, title 18,

2.25 section 925, paragraph (d)(3), or any regulations adopted pursuant to that law.

2.26 (b) Semiautomatic military-style assault weapon also includes any:

4.2	TRANSFER PROHIBITED.
4.3	Subdivision 1. Definition. As used in this section, "transfer" means a sale, gift, loan,
4.4	assignment, or other delivery to another, whether or not for consideration.
4.5	Subd. 2. Prohibition. It is unlawful for a person to transfer a semiautomatic military-style
4.6	assault weapon.
4.7	Subd. 3. Exceptions. Subdivision 2 does not apply to a transfer:
4.8	(1) between any government officer, agent, or employee; member of the armed forces
4.9	of the United States; or peace officer for official use by the recipient; or
4.10	(2) by a dealer that is properly licensed under applicable laws to any branch of the armed
4.11	forces of the United States or to a law enforcement agency within Minnesota for use by that
4.12	agency or its employees for law enforcement.
4.13	Subd. 4. Penalty. A person who violates subdivision 2 is guilty of a felony and may be
4.14	sentenced to imprisonment for not more than five years or to payment of a fine of not more
4.15	<u>than \$25,000, or both.</u>
4.16	<b>EFFECTIVE DATE.</b> This section is effective August 1, 2023, and applies to crimes

4.18 4.19	Sec. 3. <u>SEMIAUTOMATIC MILITARY-STYLE ASSAULT WEAPON BUYBACK</u> PROGRAM; APPROPRIATION.
4.20	Subdivision 1. Program established. The commissioner of public safety shall establish
4.21	a statewide buyback program to purchase semiautomatic military-style assault weapons.
4.22	The program must accept any semiautomatic military-style assault weapon offered, regardless
4.23	of the weapon's physical condition, and pay reimbursement at a rate set by the commissioner.
4.24	To implement this section, the commissioner may collaborate with state and local law
4.25	enforcement agencies to provide buyback locations throughout the state.
4.26	Subd. 2. Appropriation. \$ in fiscal year 2024 and \$ in fiscal year 2025 are
4.27	appropriated from the general fund to the commissioner of public safety to implement this
