1.9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.10 **ARTICLE 1**

1.11 **PROHIBITION ON POSSESSION OF CERTAIN FIREARMS**

1.12 Section 1. Minnesota Statutes 2024, section 624.712, subdivision 7, is amended to read:

1.13 Subd. 7. **Semiautomatic military-style assault weapon.** (a) "Semiautomatic

1.14 military-style assault weapon" means:

1.15 (1) any of the following firearms:

1.16 (i) Avtomat Kalashnikov (AK-47) semiautomatic rifle type;

1.17 (ii) Beretta AR-70 and BM-59 semiautomatic rifle types;

1.18 (iii) Colt AR-15 semiautomatic rifle type;

1.19 (iv) Daewoo Max-1 and Max-2 semiautomatic rifle types;

1.20 (v) Famas MAS semiautomatic rifle type;

1.21 (vi) Fabrique Nationale FN-LAR and FN-FNC semiautomatic rifle types;

1.22 (vii) Galil semiautomatic rifle type;

- 2.1 (viii) Heckler & Koch HK-91, HK-93, and HK-94 semiautomatic rifle types;
- 2.2 (ix) Ingram MAC-10 and MAC-11 semiautomatic pistol and carbine types;
- 2.3 (x) Intratec TEC-9 semiautomatic pistol type;
- 2.4 (xi) Sigarms SIG 550SP and SIG 551SP semiautomatic rifle types;
- 2.5 (xii) SKS with detachable magazine semiautomatic rifle type;
- 2.6 (xiii) Steyr AUG semiautomatic rifle type;
- 2.7 (xiv) Street Sweeper and Striker-12 revolving-cylinder shotgun types;
- 2.8 (xv) USAS-12 semiautomatic shotgun type;
- 2.9 (xvi) Uzi semiautomatic pistol and carbine types; or
- 2.10 (xvii) Valmet M76 and M78 semiautomatic rifle types;

2.11 (2) any firearm that is another model made by the same manufacturer as one of the
 2.12 firearms listed in clause (1), and has the same action design as one of the listed firearms,
 2.13 and is a redesigned, renamed, or renumbered version of one of the firearms listed in clause
 2.14 (1), or has a slight modification or enhancement, including but not limited to a folding or
 2.15 retractable stock; adjustable sight; case deflector for left-handed shooters; shorter barrel;
 2.16 wooden, plastic, or metal stock; larger clip size; different caliber; or a bayonet mount; and

2.17 (3) any firearm that has been manufactured or sold by another company under a licensing
 2.18 agreement with a manufacturer of one of the firearms listed in clause (1) entered into after
 2.19 the effective date of Laws 1993, chapter 326, to manufacture or sell firearms that are identical
 2.20 or nearly identical to those listed in clause (1), or described in clause (2), regardless of the
 2.21 company of production or country of origin.

2.22 The weapons listed in clause (1), except those listed in items (iii), (ix), (x), (xiv), and
 2.23 (xv), are the weapons the importation of which was barred by the Bureau of Alcohol,
 2.24 Tobacco, and Firearms of the United States Department of the Treasury in July 1989.

2.25 ~~Except as otherwise specifically provided in paragraph (d), a firearm is not a~~
 2.26 ~~"semiautomatic military-style assault weapon" if it is generally recognized as particularly~~
 2.27 ~~suitable for or readily adaptable to sporting purposes under United States Code, title 18,~~
 2.28 ~~section 925, paragraph (d)(3), or any regulations adopted pursuant to that law.~~

2.29 (b) Semiautomatic military-style assault weapon also includes any:

2.30 (1) semiautomatic rifle that has the capacity to accept a detachable magazine and has
 2.31 one or more of the following:

- 3.1 (i) a pistol grip or thumbhole stock;
- 3.2 (ii) any feature capable of functioning as a protruding grip that can be held by the
- 3.3 nontrigger hand;
- 3.4 (iii) a folding or telescoping stock;
- 3.5 (iv) a shroud attached to the barrel, or that partially or completely encircles the barrel,
- 3.6 allowing the bearer to hold the firearm with the nontrigger hand without being burned, but
- 3.7 excluding a slide that encloses the barrel; or
- 3.8 (v) a flash suppressor;
- 3.9 (2) semiautomatic pistol or any semiautomatic, centerfire, or rimfire rifle with a fixed
- 3.10 magazine that has the capacity to accept more than ten rounds of ammunition;
- 3.11 (3) semiautomatic pistol that has the capacity to accept a detachable magazine and has
- 3.12 one or more of the following:
- 3.13 (i) any feature capable of functioning as a protruding grip that can be held by the
- 3.14 nontrigger hand;
- 3.15 (ii) a folding, telescoping, or thumbhole stock;
- 3.16 (iii) a shroud attached to the barrel, or that partially or completely encircles the barrel,
- 3.17 allowing the bearer to hold the firearm with the nontrigger hand without being burned, but
- 3.18 excluding a slide that encloses the barrel;
- 3.19 (iv) the capacity to accept a detachable magazine at any location outside of the pistol
- 3.20 grip; or
- 3.21 (v) a threaded barrel capable of accepting a barrel extension, flash suppressor, forward
- 3.22 hand grip, or silencer;
- 3.23 (4) semiautomatic shotgun that has one or more of the following:
- 3.24 (i) a pistol grip or thumbhole stock;
- 3.25 (ii) any feature capable of functioning as a protruding grip that can be held by the
- 3.26 nontrigger hand;
- 3.27 (iii) a folding or telescoping stock;
- 3.28 (iv) a fixed magazine capacity in excess of ten rounds; or
- 3.29 (v) an ability to accept a detachable magazine;
- 3.30 (5) shotgun with a revolving cylinder; or

4.1 (6) conversion kit, part, or combination of parts from which a semiautomatic military-style
 4.2 assault weapon can be assembled if those parts are in the possession or under the control
 4.3 of the same person.

4.4 (c) Semiautomatic military-style assault weapon does not mean any firearm described
 4.5 in this paragraph that has been made permanently inoperable.

4.6 **Sec. 2. [624.7145] SEMIAUTOMATIC MILITARY-STYLE ASSAULT WEAPONS;**
 4.7 **PROHIBITION.**

4.8 Subdivision 1. **Definitions.** For purposes of this section:

4.9 (1) "appropriate law enforcement agency" means the organized full-time police
 4.10 department of the municipality where the person resides or the county sheriff if there is no
 4.11 municipal police department where the person resides; and

4.12 (2) "transfer" means a sale, gift, loan, assignment, or other delivery to another, whether
 4.13 or not for consideration.

4.14 Subd. 2. **Prohibition.** It is unlawful for a person to transfer, own, or possess
 4.15 semiautomatic military-style assault weapons.

4.16 Subd. 3. **Exceptions.** Subdivision 2 does not apply to:

4.17 (1) any government officer, agent, or employee; member of the armed forces of the
 4.18 United States; or peace officer, to the extent that the person is otherwise authorized to acquire
 4.19 or possess a semiautomatic military-style assault weapon and does so while acting within
 4.20 the scope of the person's duties;

4.21 (2) the manufacture of a semiautomatic military-style assault weapon by a firearms
 4.22 manufacturer for the purpose of sale to any branch of the armed forces of the United States
 4.23 or to a law enforcement agency within Minnesota for use by that agency or the agency's
 4.24 employees, provided the manufacturer is properly licensed under applicable laws; or

4.25 (3) the transfer of a semiautomatic military-style assault weapon by a dealer that is
 4.26 properly licensed under applicable laws to any branch of the armed forces of the United
 4.27 States or to a law enforcement agency within Minnesota for use by that agency or the
 4.28 agency's employees for law enforcement, provided that the dealer does not have the
 4.29 semiautomatic military-style assault weapon in possession for more than 120 days from the
 4.30 date of acquisition to the date of delivery to the armed forces or law enforcement purchaser.

4.31 Subd. 4. **Current owners; certification of ownership of semiautomatic military-style**
 4.32 **assault weapons.** (a) A person who legally owned or possessed a semiautomatic

5.1 military-style assault weapon before January 1, 2027, and who desires to keep ownership
5.2 or possession of the device must request certification of ownership of the device from the
5.3 Bureau of Criminal Apprehension and appropriate law enforcement agency by May 1, 2027.
5.4 The Bureau of Criminal Apprehension and appropriate law enforcement agency must provide
5.5 the person with a duplicate copy of their request for certification.

5.6 (b) A person described in paragraph (a) must:

5.7 (1) safely and securely store the device pursuant to the regulations adopted by the Bureau
5.8 of Criminal Apprehension;

5.9 (2) agree to allow the appropriate law enforcement agency to inspect the storage of the
5.10 device to ensure compliance with this subdivision;

5.11 (3) renew the certification of ownership every three years;

5.12 (4) possess the device only on property owned or immediately controlled by the person,
5.13 while engaged in the legal use of the device at a duly licensed firing range, or while
5.14 transporting the item in compliance with applicable law; and

5.15 (5) report the loss or theft of the device to the appropriate law enforcement agency within
5.16 48 hours of the time the discovery of the loss or theft was made or should have been made.

5.17 (c) Semiautomatic military-style assault weapons regulated under this subdivision must
5.18 not be transferred, except for transfer to the appropriate law enforcement agency for the
5.19 purpose of surrendering the item for destruction.

5.20 (d) The certified owner or possessor of a semiautomatic military-style assault weapon
5.21 must not purchase or receive additional semiautomatic military-style assault weapons.

5.22 (e) The appropriate law enforcement agency may charge a fee for each certification and
5.23 certification renewal pursuant to this subdivision.

5.24 (f) Persons acquiring semiautomatic military-style assault weapons by inheritance,
5.25 bequest, or succession must, within 120 days of acquiring title, do one of the following:

5.26 (1) surrender the device to the appropriate law enforcement agency for destruction;

5.27 (2) modify the device to render it permanently inoperable; or

5.28 (3) remove the device from the state.

5.29 (g) A person who owns or possesses a semiautomatic military-style assault weapon
5.30 before January 1, 2027, who does not elect to certify ownership of the device as required
5.31 in this subdivision must do one of the following before January 1, 2027:

6.1 (1) surrender the device to the appropriate law enforcement agency for destruction;

6.2 (2) modify the device to render it permanently inoperable; or

6.3 (3) remove the device from the state.

6.4 (h) The superintendent of the Bureau of Criminal Apprehension must:

6.5 (1) adopt regulations specifying how a person who lawfully owns a semiautomatic
6.6 military-style assault weapon must safely and securely store the device when the device is
6.7 not being used; and

6.8 (2) implement a certification system.

6.9 Subd. 5. Penalties. (a) A person who violates subdivision 2 or 4, paragraph (a) or (g),
6.10 is guilty of a felony and may be sentenced to imprisonment for not more than five years or
6.11 to payment of a fine of not more than \$25,000, or both.

6.12 (b) A person who knowingly violates subdivision 4, paragraph (b), (c), (d), or (f), is
6.13 guilty of a gross misdemeanor. A person who is convicted of a second or subsequent violation
6.14 is guilty of a felony.

6.15 (c) Notwithstanding sections 609.035 and 609.04, a prosecution or conviction for violation
6.16 of this section is not a bar to conviction of, or punishment for, any other crime.

6.17 **EFFECTIVE DATE.** This section is effective August 1, 2026, and applies to crimes
6.18 committed on or after that date.

6.19 **ARTICLE 2**

6.20 **CONFORMING AMENDMENTS**

6.21 Section 1. Minnesota Statutes 2024, section 609.66, subdivision 1f, is amended to read:

6.22 Subd. 1f. **Gross misdemeanor; transferring firearm without background check.** A
6.23 person, other than a federally licensed firearms dealer, who transfers a pistol ~~or semiautomatic~~
6.24 ~~military-style assault weapon~~ to another without complying with the transfer requirements
6.25 of section 624.7132; is guilty of a gross misdemeanor if the transferee possesses or uses the
6.26 weapon within one year after the transfer in furtherance of a felony crime of violence, and
6.27 if:

6.28 (1) the transferee was prohibited from possessing the weapon under section 624.713 at
6.29 the time of the transfer; or

6.30 (2) it was reasonably foreseeable at the time of the transfer that the transferee was likely
6.31 to use or possess the weapon in furtherance of a felony crime of violence.

7.1 Sec. 2. Minnesota Statutes 2024, section 624.713, subdivision 1, is amended to read:

7.2 Subdivision 1. **Ineligible persons.** The following persons shall not be entitled to possess
7.3 ammunition or a pistol or semiautomatic military-style assault weapon or, except for clause
7.4 (1), any other firearm:

7.5 (1) a person under the age of 18 years except that a person under 18 may possess
7.6 ammunition designed for use in a firearm that the person may lawfully possess and may
7.7 carry or possess a pistol or semiautomatic military-style assault weapon (i) ~~in the actual~~
7.8 ~~presence or under the direct supervision of the person's parent or guardian,~~ (ii) for the
7.9 purpose of military drill under the auspices of a legally recognized military organization
7.10 and under competent supervision, ~~(iii)~~ or (ii) for the purpose of instruction, competition, or
7.11 target practice on a firing range approved by the chief of police or county sheriff in whose
7.12 jurisdiction the range is located and under direct supervision; ~~or (iv).~~ A person under 18
7.13 may possess ammunition designed for use in a firearm that the person may lawfully possess
7.14 and may carry or possess a pistol if the person (i) has successfully completed a course
7.15 designed to teach marksmanship and safety with a pistol ~~or semiautomatic military-style~~
7.16 ~~assault weapon~~ and approved by the commissioner of natural resources, or (ii) is in the
7.17 actual presence or under the direct supervision of the person's parent or guardian;

7.18 (2) except as otherwise provided in clause (9), a person who has been convicted of, or
7.19 adjudicated delinquent or convicted as an extended jurisdiction juvenile for committing, in
7.20 this state or elsewhere, a crime of violence. For purposes of this section, crime of violence
7.21 includes crimes in other states or jurisdictions which would have been crimes of violence
7.22 as herein defined if they had been committed in this state;

7.23 (3) a person who is or has ever been committed in Minnesota or elsewhere by a judicial
7.24 determination that the person is mentally ill, developmentally disabled, or mentally ill and
7.25 dangerous to the public, as defined in section 253B.02, to a treatment facility, or who has
7.26 ever been found incompetent to stand trial or not guilty by reason of mental illness, unless
7.27 the person's ability to possess a firearm and ammunition has been restored under subdivision
7.28 4;

7.29 (4) a person who has been convicted in Minnesota or elsewhere of a misdemeanor or
7.30 gross misdemeanor violation of chapter 152, unless three years have elapsed since the date
7.31 of conviction and, during that time, the person has not been convicted of any other such
7.32 violation of chapter 152 or a similar law of another state; or a person who is or has ever
7.33 been committed by a judicial determination for treatment for the habitual use of a controlled

8.1 substance or marijuana, as defined in sections 152.01 and 152.02, unless the person's ability
8.2 to possess a firearm and ammunition has been restored under subdivision 4;

8.3 (5) a person who has been committed to a treatment facility in Minnesota or elsewhere
8.4 by a judicial determination that the person is chemically dependent as defined in section
8.5 253B.02, unless the person has completed treatment or the person's ability to possess a
8.6 firearm and ammunition has been restored under subdivision 4. Property rights may not be
8.7 abated but access may be restricted by the courts;

8.8 (6) a peace officer who is informally admitted to a treatment facility pursuant to section
8.9 253B.04 for chemical dependency, unless the officer possesses a certificate from the head
8.10 of the treatment facility discharging or provisionally discharging the officer from the
8.11 treatment facility. Property rights may not be abated but access may be restricted by the
8.12 courts;

8.13 (7) a person, including a person under the jurisdiction of the juvenile court, who has
8.14 been charged with committing a crime of violence and has been placed in a pretrial diversion
8.15 program by the court before disposition, until the person has completed the diversion program
8.16 and the charge of committing the crime of violence has been dismissed;

8.17 (8) except as otherwise provided in clause (9), a person who has been convicted in
8.18 another state of committing an offense similar to the offense described in section 609.224,
8.19 subdivision 3, against a family or household member or section 609.2242, subdivision 3,
8.20 unless three years have elapsed since the date of conviction and, during that time, the person
8.21 has not been convicted of any other violation of section 609.224, subdivision 3, or 609.2242,
8.22 subdivision 3, or a similar law of another state;

8.23 (9) a person who has been convicted in this state or elsewhere of assaulting a family or
8.24 household member and who was found by the court to have used a firearm in any way
8.25 during commission of the assault is prohibited from possessing any type of firearm or
8.26 ammunition for the period determined by the sentencing court;

8.27 (10) a person who:

8.28 (i) has been convicted in any court of a crime punishable by imprisonment for a term
8.29 exceeding one year;

8.30 (ii) is a fugitive from justice as a result of having fled from any state to avoid prosecution
8.31 for a crime or to avoid giving testimony in any criminal proceeding;

8.32 (iii) is an unlawful user of any controlled substance as defined in chapter 152. The use
8.33 of medical cannabis flower or medical cannabinoid products by a patient enrolled in the

9.1 registry program or the use of adult-use cannabis flower, adult-use cannabis products,
9.2 lower-potency hemp edibles, or hemp-derived consumer products by a person 21 years of
9.3 age or older does not constitute the unlawful use of a controlled substance under this item;

9.4 (iv) has been judicially committed to a treatment facility in Minnesota or elsewhere as
9.5 a person who is mentally ill, developmentally disabled, or mentally ill and dangerous to the
9.6 public, as defined in section 253B.02;

9.7 (v) is an alien who is illegally or unlawfully in the United States;

9.8 (vi) has been discharged from the armed forces of the United States under dishonorable
9.9 conditions;

9.10 (vii) has renounced the person's citizenship having been a citizen of the United States;

9.11 or

9.12 (viii) is disqualified from possessing a firearm under United States Code, title 18, section
9.13 922(g)(8) or (9), as amended through March 1, 2014;

9.14 (11) a person who has been convicted of the following offenses at the gross misdemeanor
9.15 level, unless three years have elapsed since the date of conviction and, during that time, the
9.16 person has not been convicted of any other violation of these sections: section 609.229
9.17 (crimes committed for the benefit of a gang); 609.2231, subdivision 4 (assaults motivated
9.18 by bias); 609.255 (false imprisonment); 609.378 (neglect or endangerment of a child);
9.19 609.582, subdivision 4 (burglary in the fourth degree); 609.665 (setting a spring gun); 609.71
9.20 (riot); or 609.749 (harassment or stalking). For purposes of this paragraph, the specified
9.21 gross misdemeanor convictions include crimes committed in other states or jurisdictions
9.22 which would have been gross misdemeanors if conviction occurred in this state;

9.23 (12) a person who has been convicted of a violation of section 609.224 if the court
9.24 determined that the assault was against a family or household member in accordance with
9.25 section 609.2242, subdivision 3 (domestic assault), unless three years have elapsed since
9.26 the date of conviction and, during that time, the person has not been convicted of another
9.27 violation of section 609.224 or a violation of a section listed in clause (11);

9.28 (13) a person who is subject to an order for protection as described in section 260C.201,
9.29 subdivision 3, paragraph (d), or 518B.01, subdivision 6, paragraph (g); or

9.30 (14) a person who is subject to an extreme risk protection order as described in section
9.31 624.7172 or 624.7174.

10.1 A person who issues a certificate pursuant to this section in good faith is not liable for
10.2 damages resulting or arising from the actions or misconduct with a firearm or ammunition
10.3 committed by the individual who is the subject of the certificate.

10.4 The prohibition in this subdivision relating to the possession of firearms other than
10.5 pistols and semiautomatic military-style assault weapons does not apply retroactively to
10.6 persons who are prohibited from possessing a pistol or semiautomatic military-style assault
10.7 weapon under this subdivision before August 1, 1994.

10.8 The lifetime prohibition on possessing, receiving, shipping, or transporting firearms and
10.9 ammunition for persons convicted or adjudicated delinquent of a crime of violence in clause
10.10 (2), applies only to offenders who are discharged from sentence or court supervision for a
10.11 crime of violence on or after August 1, 1993.

10.12 Participation as a patient in the registry program or use of adult-use cannabis flower,
10.13 adult-use cannabis products, lower-potency hemp edibles, or hemp-derived consumer
10.14 products by a person 21 years of age or older does not disqualify the person from possessing
10.15 firearms and ammunition under this section.

10.16 For purposes of this section, "judicial determination" means a court proceeding pursuant
10.17 to sections 253B.07 to 253B.09 or a comparable law from another state.

10.18 Sec. 3. Minnesota Statutes 2025 Supplement, section 624.7131, subdivision 1, is amended
10.19 to read:

10.20 Subdivision 1. **Information.** Any person may apply for a transferee permit by providing
10.21 the following information in writing to the chief of police of an organized full time police
10.22 department of the municipality in which the person resides or to the county sheriff if there
10.23 is no such local chief of police:

10.24 (1) the name, residence, telephone number, and driver's license number or
10.25 nonqualification certificate number, if any, of the proposed transferee;

10.26 (2) the sex, date of birth, height, weight, and color of eyes, and distinguishing physical
10.27 characteristics, if any, of the proposed transferee;

10.28 (3) a statement that the proposed transferee authorizes the release to the local police
10.29 authority of commitment information about the proposed transferee maintained by the Direct
10.30 Care and Treatment executive board, to the extent that the information relates to the proposed
10.31 transferee's eligibility to possess a pistol ~~or semiautomatic military-style assault weapon~~

11.3 The statements shall be signed and dated by the person applying for a permit. At the
 11.4 time of application, the local police authority shall provide the applicant with a dated receipt
 11.5 for the application. The statement under clause (3) must comply with any applicable
 11.6 requirements of Code of Federal Regulations, title 42, sections 2.31 to 2.35, with respect
 11.7 to consent to disclosure of alcohol or drug abuse patient records.
