1.23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.24 **ARTICLE 1**

1.25 **ELECTION ADMINISTRATION**

1.26 Section 1. Minnesota Statutes 2014, section 123B.09, subdivision 1, is amended to read:

1.27 Subdivision 1. **School board membership.** The care, management, and control of
 1.28 independent districts is vested in a board of directors, to be known as the school board.
 1.29 The term of office of a member shall be four years commencing on the first Monday in
 1.30 January and until a successor qualifies. The membership of the board shall consist of six
 1.31 elected directors together with such ex officio member as may be provided by law. The

2.1 board may submit to the electors at any school election the question whether the board
2.2 shall consist of seven members. If a majority of those voting on the proposition favor a
2.3 seven-member board, a seventh member shall be elected at the next election of directors
2.4 for a four-year term and thereafter the board shall consist of seven members.

2.5 Those districts with a seven-member board may submit to the electors at any school
2.6 election at least 150 days before the next election of three members of the board the
2.7 question whether the board shall consist of six members. If a majority of those voting on
2.8 the proposition favor a six-member board instead of a seven-member board, ~~two~~ three
2.9 members instead of ~~three~~ four members shall be elected at the next election of the board of
2.10 directors and thereafter the board shall consist of six members.

2.11 Sec. 2. Minnesota Statutes 2014, section 200.02, subdivision 7, is amended to read:

2.12 Subd. 7. **Major political party.** (a) "Major political party" means a political party
2.13 that maintains a party organization in the state, political division or precinct in question
2.14 and that has presented at least one candidate for election to the office of:

2.15 (1) governor and lieutenant governor, secretary of state, state auditor, or attorney
2.16 general at the last preceding state general election for those offices; or

2.17 (2) presidential elector or U.S. senator at the last preceding state general election for
2.18 presidential electors; and

2.19 whose candidate received votes in each county in that election and received votes
2.20 from not less than five percent of the total number of individuals who voted in that election.

2.21 (b) "Major political party" also means a political party that maintains a party
2.22 organization in the state, political subdivision, or precinct in question and that has
2.23 presented at least 45 candidates for election to the office of state representative, 23
2.24 candidates for election to the office of state senator, four candidates for election to
2.25 the office of representative in Congress, and one candidate for election to each of the
2.26 following offices: governor and lieutenant governor, attorney general, secretary of state,
2.27 and state auditor, at the last preceding state general election for those offices.

2.28 (c) "Major political party" also means a political party that maintains a party
2.29 organization in the state, political subdivision, or precinct in question and whose members
2.30 present to the secretary of state at any time before the close of filing for the state partisan
2.31 primary ballot a petition for a place on the state partisan primary ballot, which petition
2.32 contains valid signatures of a number of the party members equal to at least five percent
2.33 of the total number of individuals who voted in the preceding state general election. A
2.34 signature is valid only if signed no more than one year prior to the date the petition was filed.

3.1 (d) A political party whose candidate receives a sufficient number of votes at a state
3.2 general election described in paragraph (a) or a political party that presents candidates at
3.3 an election as required by paragraph (b) becomes a major political party as of January
3.4 1 following that election and retains its major party status for at least two state general
3.5 elections even if the party fails to present a candidate who receives the number and
3.6 percentage of votes required under paragraph (a) or fails to present candidates as required
3.7 by paragraph (b) at subsequent state general elections.

3.8 (e) A major political party whose candidates fail to receive the number and
3.9 percentage of votes required under paragraph (a) and that fails to present candidates as
3.10 required by paragraph (b) at each of two consecutive state general elections described by
3.11 paragraph (a) or (b), respectively, loses major party status as of December 31 following
3.12 the later of the two consecutive state general elections.

3.13 Sec. 3. Minnesota Statutes 2014, section 200.02, subdivision 23, is amended to read:

3.14 Subd. 23. **Minor political party.** (a) "Minor political party" means a political party
3.15 that has adopted a state constitution, designated a state party chair, held a state convention
3.16 in the last two years, filed with the secretary of state no later than December 31 following
3.17 the most recent state general election a certification that the party has met the foregoing
3.18 requirements, and met the requirements of paragraph (b) or (e), as applicable.

3.19 (b) To be considered a minor party in all elections statewide, the political party must
3.20 have presented at least one candidate for election to the office of:

3.21 (1) governor and lieutenant governor, secretary of state, state auditor, or attorney
3.22 general, at the last preceding state general election for those offices; or

3.23 (2) presidential elector or U.S. senator at the preceding state general election for
3.24 presidential electors; and

3.25 (3) who received votes in each county that in the aggregate equal at least one percent
3.26 of the total number of individuals who voted in the election, or its members must have
3.27 presented to the secretary of state at any time before the close of filing for the state
3.28 partisan primary ballot a nominating petition in a form prescribed by the secretary of state
3.29 containing the valid signatures of party members in a number equal to at least one percent
3.30 of the total number of individuals who voted in the preceding state general election. A
3.31 signature is valid only if signed no more than one year prior to the date the petition was filed.

3.32 (c) A political party whose candidate receives a sufficient number of votes at a
3.33 state general election described in paragraph (b) becomes a minor political party as of
3.34 January 1 following that election and retains its minor party status for at least two state

4.1 general elections even if the party fails to present a candidate who receives the number
4.2 and percentage of votes required under paragraph (b) at subsequent state general elections.

4.3 (d) A minor political party whose candidates fail to receive the number and
4.4 percentage of votes required under paragraph (b) at each of two consecutive state general
4.5 elections described by paragraph (b) loses minor party status as of December 31 following
4.6 the later of the two consecutive state general elections.

4.7 (e) A minor party that qualifies to be a major party loses its status as a minor party
4.8 at the time it becomes a major party. Votes received by the candidates of a major party
4.9 must be counted in determining whether the party received sufficient votes to qualify as a
4.10 minor party, notwithstanding that the party does not receive sufficient votes to retain its
4.11 major party status. To be considered a minor party in an election in a legislative district,
4.12 the political party must have presented at least one candidate for a legislative office in that
4.13 district who received votes from at least ten percent of the total number of individuals
4.14 who voted for that office, or its members must have presented to the secretary of state a
4.15 nominating petition in a form prescribed by the secretary of state containing the valid
4.16 signatures of party members in a number equal to at least ten percent of the total number of
4.17 individuals who voted in the preceding state general election for that legislative office. A
4.18 signature is valid only if signed no more than one year prior to the date the petition was filed.

4.19 Sec. 4. Minnesota Statutes 2014, section 200.02, is amended by adding a subdivision
4.20 to read:

4.21 Subd. 27. **Partisan offices.** "Partisan offices" means federal offices, presidential
4.22 electors, constitutional offices, and legislative offices.

4.23 Sec. 5. Minnesota Statutes 2014, section 200.02, is amended by adding a subdivision
4.24 to read:

4.25 Subd. 28. **Nonpartisan offices.** "Nonpartisan offices" means all judicial, county,
4.26 municipal, school district, and special district offices.

4.27 Sec. 6. Minnesota Statutes 2014, section 201.071, subdivision 1, is amended to read:

4.28 Subdivision 1. **Form.** Both paper and electronic voter registration applications must
4.29 contain the same information unless otherwise provided by law. A voter registration
4.30 application must contain spaces for the following required information: voter's first name,
4.31 middle name, and last name; voter's previous name, if any; voter's current address; voter's
4.32 previous address, if any; voter's date of birth; voter's municipality and county of residence;
4.33 voter's telephone number, if provided by the voter; date of registration; current and valid

5.1 Minnesota driver's license number or Minnesota state identification number, or if the voter
5.2 has no current and valid Minnesota driver's license or Minnesota state identification, the
5.3 last four digits of the voter's Social Security number; and voter's signature. The paper
5.4 registration application may include the voter's e-mail address, if provided by the voter.
5.5 The electronic voter registration application must include the voter's e-mail address. The
5.6 registration application may include the voter's interest in serving as an election judge,
5.7 if indicated by the voter. The application must also contain the following certification
5.8 of voter eligibility:

5.9 "I certify that I:

5.10 (1) will be at least 18 years old on election day;

5.11 (2) am a citizen of the United States;

5.12 (3) will have resided in Minnesota for 20 days immediately preceding election day;

5.13 (4) maintain residence at the address given on the registration form;

5.14 (5) am not under court-ordered guardianship in which the court order revokes my
5.15 right to vote;

5.16 (6) have not been found by a court to be legally incompetent to vote;

5.17 (7) have the right to vote because, if I have been convicted of a felony, my felony
5.18 sentence has expired (been completed) or I have been discharged from my sentence; and

5.19 (8) have read and understand the following statement: that giving false information
5.20 is a felony punishable by not more than five years imprisonment or a fine of not more
5.21 than \$10,000, or both."

5.22 The certification must include boxes for the voter to respond to the following
5.23 questions:

5.24 "(1) Are you a citizen of the United States?" and

5.25 "(2) Will you be 18 years old on or before election day?"

5.26 And the instruction:

5.27 "If you checked 'no' to either of these questions, do not complete this form."

5.28 ~~A paper voter registration application must be of suitable size and weight for~~

5.29 ~~mailing.~~ The form of the voter registration application and the certification of voter

5.30 eligibility must be as provided in this subdivision and approved by the secretary of state.

5.31 Voter registration forms authorized by the National Voter Registration Act must also be

5.32 accepted as valid. The federal postcard application form must also be accepted as valid if

5.33 it is not deficient and the voter is eligible to register in Minnesota.

5.34 An individual may use a voter registration application to apply to register to vote in
5.35 Minnesota or to change information on an existing registration.

6.1 Sec. 7. Minnesota Statutes 2014, section 201.158, is amended to read:

6.2 **201.158 USE OF DEPARTMENT OF PUBLIC SAFETY DATA.**

6.3 As required by the Help America Vote Act of 2002, Public Law 107-252, the
6.4 commissioner of public safety shall make electronic data on citizenship available to the
6.5 secretary of state. The secretary of state must determine whether the data newly indicates
6.6 that any individuals who have active records in the statewide voter registration system
6.7 are not citizens. The secretary of state shall prepare a list of those voters for each county
6.8 auditor at least monthly. The county auditor shall change the status of those registrants in
6.9 the statewide voter registration system to reflect that they are challenged based upon their
6.10 citizenship and must notify the county attorney.

6.11 ~~In 2010, the secretary of state must make the determination and provide lists~~
6.12 ~~to the county auditors between 30 and 60 days before the general election and again~~
6.13 ~~between six and ten weeks after the election. In 2011, the secretary of state must make~~
6.14 ~~this determination again as part of the annual list maintenance. By August 1, 2012, the~~
6.15 ~~secretary of state must provide electronic lists to the counties at least monthly.~~

6.16 Sec. 8. Minnesota Statutes 2014, section 201.275, is amended to read:

6.17 **201.275 INVESTIGATIONS; PROSECUTIONS.**

6.18 (a) A law enforcement agency that is notified by affidavit of an alleged violation of
6.19 this chapter shall promptly investigate. Upon receiving an affidavit alleging a violation
6.20 of this chapter, a county attorney shall promptly forward it to a law enforcement agency
6.21 with jurisdiction for investigation. If there is probable cause for instituting a prosecution,
6.22 the county attorney shall proceed by complaint or present the charge, with whatever
6.23 evidence has been found, to the grand jury according to the generally applicable standards
6.24 regarding the prosecutorial functions and duties of a county attorney, provided that
6.25 the county attorney is not required to proceed with the prosecution if the complainant
6.26 withdraws the allegation. A county attorney who refuses or intentionally fails to faithfully
6.27 perform this or any other duty imposed by this chapter is guilty of a misdemeanor and
6.28 upon conviction shall forfeit office. ~~The county attorney, under the penalty of forfeiture of~~
6.29 ~~office, shall prosecute all violations of this chapter except violations of this section; if,~~
6.30 ~~however, a complainant withdraws an allegation under this chapter, the county attorney is~~
6.31 ~~not required to proceed with the prosecution.~~

6.32 (b) Willful violation of this chapter by any public employee constitutes just cause for
6.33 suspension without pay or dismissal of the public employee.

6.34 (c) Where the matter relates to a voter registration application submitted
6.35 electronically through the secure Web site established in section 201.061, subdivision 1,

7.1 alleged violations of this chapter may be investigated and prosecuted in the county in
7.2 which the individual registered or attempted to register.

7.3 **EFFECTIVE DATE.** This section is effective the day following final enactment.

7.4 Sec. 9. Minnesota Statutes 2014, section 203B.07, subdivision 1, is amended to read:

7.5 Subdivision 1. **Delivery of envelopes, directions.** The county auditor or the
7.6 municipal clerk shall prepare, print, and transmit a return envelope, a ballot envelope, and
7.7 a copy of the directions for casting an absentee ballot to each applicant whose application
7.8 for absentee ballots is accepted pursuant to section 203B.04. The county auditor or
7.9 municipal clerk shall provide first class postage for the return envelope. The directions
7.10 for casting an absentee ballot shall be printed in at least 14-point bold type with heavy
7.11 leading and may be printed on the ballot envelope. When a person requests the directions
7.12 in Braille or on ~~eassette-tape~~ audio file, the county auditor or municipal clerk shall provide
7.13 them in the form requested. The secretary of state shall prepare Braille and ~~eassette~~ audio
7.14 file copies and make them available.

7.15 When a voter registration application is sent to the applicant as provided in section
7.16 203B.06, subdivision 4, the directions or registration application shall include instructions
7.17 for registering to vote.

7.18 Sec. 10. Minnesota Statutes 2014, section 203B.08, subdivision 1, is amended to read:

7.19 Subdivision 1. **Marking and return by voter.** An eligible voter who receives
7.20 absentee ballots as provided in this chapter shall mark them in the manner specified in the
7.21 directions for casting the absentee ballots. The return envelope containing marked ballots
7.22 may be mailed as provided in the directions for casting the absentee ballots or may be
7.23 left with the county auditor or municipal clerk who transmitted the absentee ballots to the
7.24 voter. If delivered in person ~~by an agent~~, the return envelope must be submitted to the
7.25 county auditor or municipal clerk by 3:00 p.m. on election day.

7.26 The voter may designate an agent to deliver in person the sealed absentee ballot
7.27 return envelope to the county auditor or municipal clerk or to deposit the return envelope
7.28 in the mail. An agent may deliver or mail the return envelopes of not more than three
7.29 voters in any election. Any person designated as an agent who tampers with either the
7.30 return envelope or the voted ballots or does not immediately mail or deliver the return
7.31 envelope to the county auditor or municipal clerk is guilty of a misdemeanor.

7.32 Sec. 11. Minnesota Statutes 2014, section 203B.08, subdivision 3, is amended to read:

8.1 Subd. 3. **Procedures on receipt of ballots.** When absentee ballots are returned to a
8.2 county auditor or municipal clerk, that official shall stamp or initial and date the return
8.3 envelope and place it in a secure location with other return envelopes received by that
8.4 office. Within five days after receipt, the county auditor or municipal clerk shall deliver to
8.5 the ballot board all ballots received, except that during the 14 days immediately preceding
8.6 an election, the county auditor or municipal clerk shall deliver all ballots received to the
8.7 ballot board within three days. Ballots received on election day either (1) after 3:00 p.m.,
8.8 if delivered by an agent in person; or (2) after the last mail delivery 8 p.m., if delivered by
8.9 another method mail or a package delivery service, shall be marked as received late by the
8.10 county auditor or municipal clerk, and must not be delivered to the ballot board.

8.11 Sec. 12. Minnesota Statutes 2014, section 203B.121, subdivision 2, is amended to read:

8.12 Subd. 2. **Duties of ballot board; absentee ballots.** (a) The members of the ballot
8.13 board shall take possession of all return envelopes delivered to them in accordance with
8.14 section 203B.08. Upon receipt from the county auditor, municipal clerk, or school district
8.15 clerk, two or more members of the ballot board shall examine each return envelope and
8.16 shall mark it accepted or rejected in the manner provided in this subdivision. Election
8.17 judges performing the duties in this section must be of different major political parties,
8.18 unless they are exempt from that requirement under section 205.075, subdivision 4, or
8.19 section 205A.10, subdivision 2.

8.20 (b) The members of the ballot board shall mark the return envelope "Accepted" and
8.21 initial or sign the return envelope below the word "Accepted" if a majority of the members
8.22 of the ballot board examining the envelope are satisfied that:

8.23 (1) the voter's name and address on the return envelope are the same as the
8.24 information provided on the absentee ballot application;

8.25 (2) the voter signed the certification on the envelope;

8.26 (3) the voter's Minnesota driver's license, state identification number, or the last four
8.27 digits of the voter's Social Security number are the same as ~~the~~ a number provided on the
8.28 voter's absentee ballot application for ballots or voter record. If the number does not
8.29 match ~~the number as submitted on the application, or if a number was not submitted on~~
8.30 ~~the application~~, the election judges must compare the signature provided by the applicant
8.31 to determine whether the ballots were returned by the same person to whom they were
8.32 transmitted;

8.33 (4) the voter is registered and eligible to vote in the precinct or has included a
8.34 properly completed voter registration application in the return envelope;

9.1 (5) the certificate has been completed as prescribed in the directions for casting an
9.2 absentee ballot; and

9.3 (6) the voter has not already voted at that election, either in person or, if it is after the
9.4 close of business on the seventh day before the election, by absentee ballot.

9.5 The return envelope from accepted ballots must be preserved and returned to the
9.6 county auditor.

9.7 (c)(1) If a majority of the members of the ballot board examining a return envelope
9.8 find that an absentee voter has failed to meet one of the requirements provided in
9.9 paragraph (b), they shall mark the return envelope "Rejected," initial or sign it below the
9.10 word "Rejected," list the reason for the rejection on the envelope, and return it to the
9.11 county auditor. There is no other reason for rejecting an absentee ballot beyond those
9.12 permitted by this section. Failure to place the ballot within the security envelope before
9.13 placing it in the outer white envelope is not a reason to reject an absentee ballot.

9.14 (2) If an envelope has been rejected at least five days before the election, the
9.15 envelope must remain sealed and the official in charge of the ballot board shall provide the
9.16 voter with a replacement absentee ballot and return envelope in place of the rejected ballot.

9.17 (3) If an envelope is rejected within five days of the election, the envelope must
9.18 remain sealed and the official in charge of the ballot board must attempt to contact the
9.19 voter by telephone or e-mail to notify the voter that the voter's ballot has been rejected.
9.20 The official must document the attempts made to contact the voter.

9.21 (d) The official in charge of the absentee ballot board must mail the voter a written
9.22 notice of absentee ballot rejection between six and ten weeks following the election. If the
9.23 official determines that the voter has otherwise cast a ballot in the election, no notice is
9.24 required. If an absentee ballot arrives after the deadline for submission provided by this
9.25 chapter, the notice must be provided between six to ten weeks after receipt of the ballot. A
9.26 notice of absentee ballot rejection must contain the following information:

9.27 (1) the date on which the absentee ballot was rejected or, if the ballot was received
9.28 after the required deadline for submission, the date on which the ballot was received;

9.29 (2) the reason for rejection; and

9.30 (3) the name of the appropriate election official to whom the voter may direct further
9.31 questions, along with appropriate contact information.

9.32 (e) An absentee ballot return envelope marked "Rejected" may not be opened or
9.33 subject to further review except in an election contest filed pursuant to chapter 209.

9.34 Sec. 13. Minnesota Statutes 2014, section 203B.17, subdivision 1, is amended to read:

10.1 Subdivision 1. **Submission of application.** (a) An application for absentee ballots
10.2 for a voter described in section 203B.16 must be in writing and may be submitted in
10.3 person, by mail, by electronic facsimile device, by electronic mail, or electronically
10.4 through a secure Web site that shall be maintained by the secretary of state for this
10.5 purpose, upon determination by the secretary of state that security concerns have been
10.6 adequately addressed. An application for absentee ballots for a voter described in section
10.7 203B.16 may be submitted by that voter or by that voter's parent, spouse, sister, brother, or
10.8 child over the age of 18 years. ~~For purposes of an application under this subdivision, a~~
10.9 ~~person's Social Security number, no matter how it is designated, qualifies as the person's~~
10.10 ~~military identification number if the person is in the military.~~

10.11 (b) An application for a voter described in section 203B.16, subdivision 1, shall be
10.12 submitted to the county auditor of the county where the voter maintains residence or
10.13 through the secure Web site maintained by the secretary of state.

10.14 (c) An application for a voter described in section 203B.16, subdivision 2, shall be
10.15 submitted to the county auditor of the county where the voter last maintained residence in
10.16 Minnesota or through the secure Web site maintained by the secretary of state.

10.17 (d) An application for absentee ballots shall be valid for any primary, special
10.18 primary, general election, or special election from the time the application is received
10.19 through the end of that calendar year.

10.20 (e) There shall be no limitation of time for filing and receiving applications for
10.21 ballots under sections 203B.16 to 203B.27.

10.22 Sec. 14. Minnesota Statutes 2014, section 204B.06, subdivision 1b, is amended to read:

10.23 Subd. 1b. **Address and telephone number.** (a) An affidavit of candidacy must
10.24 state a telephone number where the candidate can be contacted. An affidavit must also
10.25 state the candidate's address of residence as determined under section 200.031, or at the
10.26 candidate's request in accordance with paragraph (c), the candidate's campaign contact
10.27 address. The form for the affidavit of candidacy must allow the candidate to request, if
10.28 eligible, that the candidate's address of residence be classified as private data, and to
10.29 provide the certification required under paragraph (c) for classification of that address.

10.30 (b) For an office whose residency requirement must be satisfied by the close of the
10.31 filing period, a registered voter in this state may request in writing that the filing officer
10.32 receiving the affidavit of candidacy review the address as provided in this paragraph, at
10.33 any time up to one day after the last day for filing for office. If requested, the filing officer
10.34 must determine whether the address provided in the affidavit of candidacy is within the
10.35 area represented by the office the candidate is seeking. If the filing officer determines

Subd. 4. **Folding ballots.** After marking the ballots, the voter shall fold each of them separately to conceal the face and all marks on it, and to expose only the initials of the election judges on the back of the ballot.

204C.30 ELECTION RETURNS; ADDITIONAL DUTIES OF COUNTY AUDITOR.

Subdivision 1. **Delivery of summary statements to secretary of state.** The county auditor shall promptly deliver to the secretary of state one of the sets of summary statements received from each precinct.

208.07 CERTIFICATE OF ELECTORS.

Immediately after the vacancies have been filled, the original electors and alternates present shall certify to the governor the names of the persons elected to complete their number, and the governor shall at once cause written notice to be given to each person elected to fill a vacancy. The persons so chosen shall be presidential electors and shall meet and act with the other electors.

208.08 ELECTORS TO MEET AT STATE CAPITOL.

The original, alternate, and substituted presidential electors, at 12:00 M., shall meet in the executive chamber at the State Capitol and shall perform all the duties imposed upon them as electors by the Constitution and laws of the United States and this state.

Each elector, as a condition of having been chosen under the name of the party of a presidential and a vice presidential candidate, is obligated to vote for those candidates. The elector shall speak aloud or affirm in a nonverbal manner the name of the candidate for president and for vice president for whom the elector is voting and then confirm that vote by written public ballot.

If an elector fails to cast a ballot for the presidential or vice presidential candidate of the party under whose name the elector was chosen, the elector's vote or abstention is invalidated and an alternate presidential elector, chosen by lot from among the alternates, shall cast a ballot in the name of the elector for the presidential and vice presidential candidate of the party under whose name the elector was chosen. The invalidation of an elector's vote or abstention on the ballot for president or vice president does not apply if the presidential candidate under whose party's name the elector was chosen has without condition released the elector or has died or become mentally disabled.

383A.555 ELECTION; BALLOT.

Subdivision 1. **Procedure; notice.** Upon delivery of the proposed charter to the board of county commissioners, the board shall submit it to the voters at the general election in 1990. The election shall be conducted as nearly as possible in accordance with chapter 372, provided that the polls shall remain open until 8:00 p.m. The notice of election must contain the complete charter and must be published once a week for two successive weeks in a qualified newspaper of general circulation within the county.

Subd. 2. **Ballot form.** The ballot must be in the following form:

"Shall the proposed new county charter be adopted?"
