2. Except as provided in subsections 4 and 5 of this section, the registered sexual offender
and registered violent offender search shall make it possible for any person using the internet to
search for and find the information specified in subsection 4 of this section, if known, on offenders
registered in this state pursuant to sections 589.400 to 589.425 or section 589.437.
3. The registered sexual offender <u>and registered violent offender</u> search shall include the capability to search for sexual offenders by name, by zip code, and by typing in an address and
specifying a search within a certain number of miles radius from that address. The search shall also
have the capability to filter results by sexual offenders or violent offenders.
4. Only the information listed in this subsection shall be provided to the public in the
registered sexual offender and registered violent offender search:
(1) The name and any known aliases of the offender;
(1) The name and any known alias dates of birth of the offender;(2) The date of birth and any known alias dates of birth of the offender;
(2) The date of onth and any known and adde of onth of the offender;(3) A physical description of the offender;
(4) The residence, temporary, work, and school addresses of the offender, including the
street address, city, county, state, and zip code;
(5) Any photographs of the offender;
(6) A physical description of the offender's vehicles, including the year, make, model, color,
and license plate number;
(7) The nature and dates of all offenses qualifying the offender to register, including the tier
level assigned to the offender under sections 589.400 to 589.425;
(8) The date on which the offender was released from the department of mental health,
prison, or jail[,] or placed on parole, supervised release, or probation for the offenses qualifying the
offender to register;
(9) Compliance status of the <u>sexual or violent</u> offender with the provisions of [section]
