13	court program shall be dismissed; however, the defendant shall be required to pay any associated
14	costs prior to the dismissal of the charges.
15	3. This section shall apply if there is a nexus to a drug offense and only to misdemeanants or
16	first-time felony offenders; except that, this section shall not apply to sexual offenses or to
17	dangerous felonies as defined in section 556.061.

22	decision based on information presented in the meeting.

medication-assisted treatment under the care of a physician licensed in this state to practice
medicine. A treatment court participant shall not be required to refrain from using medicationassisted treatment as a term or condition of successful completion of the treatment court program.

A treatment court participant assigned to a treatment program for opioid or other
 substance misuse or dependence shall not be in violation of the terms or conditions of the treatment
 court on the basis of his or her participation in medication-assisted treatment under the care of a
