# **LEGISLATIVE BILL 116**

Introduced by McCollister, 20.

Read first time January 07, 2021

## Committee:

- 1 A BILL FOR AN ACT relating to firearms; to amend sections 69-2404, 2 69-2405, 69-2406, 69-2426, and 69-2432, Reissue Revised Statutes of 3 Nebraska; to change provisions relating to handgun transfer 4 certificates; to change a fee; to provide for dissemination of 5 information regarding firearm safety and suicide prevention and 6 require suicide prevention training; to change provisions relating 7 to appeals; to provide penalties; to define a term; to harmonize 8 provisions; and to repeal the original sections.
- 9 Be it enacted by the people of the State of Nebraska,

Section 1. Section 69-2404, Reissue Revised Statutes of Nebraska, is amended to read:

3 69-2404 Any person desiring to purchase, lease, rent, or receive transfer of a handgun shall apply with the chief of police or sheriff of 4 the applicant's place of residence for a certificate. The application may 5 be made in person or by mail. The application form and certificate shall 6 be made on forms approved by the Superintendent of Law Enforcement and 7 Public Safety. The application shall include the applicant's full name, 8 9 address, date of birth, and country of citizenship. If the applicant is 10 not a United States citizen, the application shall include the applicant's place of birth and his or her alien or admission number. If 11 the application is made in person, the applicant shall also present a 12 current Nebraska motor vehicle operator's license, state identification 13 card, or military identification card, or if the application is made by 14 mail, the application form shall describe the license or card used for 15 identification and be notarized by a notary public who has verified the 16 identification of the applicant through such a license or card. An 17 applicant shall receive a certificate if he or she is twenty-one years of 18 age or older and is not prohibited from purchasing or possessing a 19 handgun by 18 U.S.C. 922. A fee of  $\underline{\text{ten}}$  five dollars shall be charged for 20 each application for a certificate to cover the cost of a criminal 21 22 history record check.

Sec. 2. Section 69-2405, Reissue Revised Statutes of Nebraska, is amended to read:

25 (1) Upon the receipt of an application for a certificate,
26 the chief of police or sheriff shall issue a certificate or deny a
27 certificate and furnish the applicant the specific reasons for the denial
28 in writing. The chief of police or sheriff shall be permitted up to <u>five</u>
29 three days in which to conduct an investigation to determine whether the
30 applicant is prohibited by law from purchasing or possessing a handgun.
31 If the certificate or denial is mailed to the applicant, it shall be

- 1 mailed to the applicant's address by first-class mail within the <u>five-day</u>
- 2 three-day period but no sooner than forty-eight hours after receipt of
- 3 the application. If it is determined that the purchase or possession of a
- 4 handgun by the applicant would be in violation of applicable federal,
- 5 state, or local law, the chief of police or sheriff shall deny the
- 6 certificate.
- 7 (2) In computing the <u>five-day</u> three-day period, the day of receipt
- 8 of the application shall not be included and the last day of the <u>five-day</u>
- 9 three-day period shall be included. The five-day three-day period shall
- 10 expire at 11:59 p.m. of the fifth third day unless it is a Saturday,
- 11 Sunday, or legal holiday in which event the period shall run until 11:59
- 12 p.m. of the next day which is not a Saturday, Sunday, or legal holiday.
- 13 (3)(a) Subject to subdivision (3)(b) of this section, no No later
- 14 than the end of the <u>five-day</u> three-day period the chief of police or
- 15 sheriff shall issue or deny such certificate and, if the certificate is
- 16 denied, furnish the applicant the specific reasons for denial in writing.
- 17 <u>(b) A certificate shall not be issued sooner than forty-eight hours</u>
- 18 after receipt of the application.
- 19 (4) When issuing any certificate under this section, the chief of
- 20 police or sheriff shall include with the certificate informational
- 21 materials regarding suicide prevention and firearm safety. Such materials
- 22 shall provide evidence-based information aligned with best practices in
- 23 <u>suicide prevention.</u>
- 24 (5) No civil liability shall arise to any law enforcement agency if
- 25 such law enforcement agency complies with sections 69-2401, 69-2403 to
- 26 69-2408, and 69-2409.01.
- 27 Sec. 3. Section 69-2406, Reissue Revised Statutes of Nebraska, is
- 28 amended to read:
- 29 69-2406 Any person who is denied a certificate, whose certificate is
- 30 revoked, or who has not been issued a certificate upon expiration of the
- 31 five-day three-day period in section 69-2405 may appeal within ten days

- 1 of receipt of the denial or revocation to the county court of the county
- 2 of the applicant's place of residence. The appeal shall be filed within
- 3 ten days after receipt of the denial or revocation or, in the case of a
- 4 certificate not issued within the five-day period in section 69-2405,
- 5 within ten days after expiration of such period. The applicant shall file
- 6 with the court the specific reasons for the denial or revocation by the
- 7 chief of police or sheriff and pay a filing fee of ten dollars in lieu of
- 8 any other filing fee required by law. The court shall issue its decision
- 9 within thirty days of the filing of the appeal.
- Sec. 4. Section 69-2426, Reissue Revised Statutes of Nebraska, is
- 11 amended to read:
- 12 69-2426 (1) Any firearm dealer licensed pursuant to 18 U.S.C. 923:
- 13 (a) Shall Dealers of firearms shall distribute to all firearm
- 14 purchasers information developed by the Department of Health and Human
- 15 Services regarding the dangers of leaving loaded firearms unattended
- 16 around children; and -
- 17 <u>(b) May distribute to any firearm purchaser other informational</u>
- 18 materials regarding suicide prevention and firearm safety, including
- 19 <u>materials that provide evidence-based information aligned with best</u>
- 20 <u>practices in suicide prevention.</u>
- 21 (2) There is hereby created the Firearm Information Fund. Private
- 22 contributions shall be credited by the State Treasurer to such fund for
- 23 the implementation of the provisions of this section.
- Sec. 5. Section 69-2432, Reissue Revised Statutes of Nebraska, is
- 25 amended to read:
- 26 69-2432 (1) The Nebraska State Patrol shall prepare and publish
- 27 minimum training and safety requirements for and adopt and promulgate
- 28 rules and regulations governing handgun training and safety courses and
- 29 handgun training and safety course instructors. Minimum safety and
- 30 training requirements for a handgun training and safety course shall
- 31 include, but not be limited to:

- 1 (a) Knowledge and safe handling of a handgun;
- 2 (b) Knowledge and safe handling of handgun ammunition;
- 3 (c) Safe handgun shooting fundamentals;
- 4 (d) A demonstration of competency with a handgun with respect to the
- 5 minimum safety and training requirements;
- 6 (e) Knowledge of federal, state, and local laws pertaining to the
- 7 purchase, ownership, transportation, and possession of handguns;
- 8 (f) Knowledge of federal, state, and local laws pertaining to the
- 9 use of a handgun, including, but not limited to, use of a handgun for
- 10 self-defense and laws relating to justifiable homicide and the various
- 11 degrees of assault;
- 12 (g) Knowledge of ways to avoid a criminal attack and to defuse or
- 13 control a violent confrontation; and
- 14 (h) Knowledge of proper storage practices for handguns and
- 15 ammunition, including storage practices which would reduce the
- 16 possibility of accidental injury to a child; and -
- 17 <u>(i) Suicide prevention training. Such training shall consist of</u>
- 18 evidenced-based information aligned with best practices in suicide
- 19 prevention.
- 20 (2) A person or entity conducting a handgun training and safety
- 21 course and the course instructors shall be approved by the patrol before
- 22 operation. The patrol shall issue a certificate evidencing its approval.
- 23 (3) A certificate of completion of a handgun training and safety
- 24 course shall be issued by the person or entity conducting a handgun
- 25 training and safety course to persons successfully completing the course.
- 26 The certificate of completion shall also include certification from the
- 27 instructor that the person completing the course does not suffer from a
- 28 readily discernible physical infirmity that prevents the person from
- 29 safely handling a handgun.
- 30 (4) Any fee for participation in a handgun training and safety
- 31 course is the responsibility of the applicant.
