- 1 A BILL FOR AN ACT relating to elections; to amend sections 32-103, 2 32-202, 32-813, 32-914, 32-916, 32-936, 32-938, 32-949, 32-950, 3 32-954, 32-1006, 32-1027, and 32-1030, Reissue Revised Statutes of 4 Nebraska, and sections 32-101, 32-809, 32-816, 32-902, 32-915, 32-942, 32-947, 32-953, 32-957, and 32-1002, Revised Statutes 5 6 Cumulative Supplement, 2014; to require voter identification for 7 purposes of voting as prescribed; to require secret-ballot envelopes 8 for certain ballots; to change provisions relating to voting and counting votes; to harmonize provisions; to provide an operative 9 date; and to repeal the original sections. 10

- 20 <u>(c) An expiration date no earlier than five years prior to the date</u>
- 21 of the election for which the identification is being presented; or
- 22 (3) A document issued by an official Indian tribe in the United
- 23 States which shows:
- 24 (a) The name of the individual to whom the document was issued and
- 25 the name conforms to the name in the voter's voter registration record;
- 26 (b) A photograph of the individual to whom the document was issued;

- 28 <u>(c) An expiration date no earlier than five years prior to the date</u>
- 29 of the election for which the identification is being presented.
- 30 Sec. 4. Return envelope means the envelope delivered to a voter in
- 31 which he or she places the secret-ballot envelope and accompanying

- 1 materials.
- 2 <u>Sec. 5. Secret-ballot envelope means a ballot sleeve open only on</u>
- 3 one end or an envelope, which sleeve or envelope (1) is provided to the
- 4 voter by the election commissioner or county clerk, (2) bears no
- 5 characteristics which would identify the voter, (3) may be used by a
- 6 registered voter to insert his or her voted ballot before placing it in
- 7 the return envelope to return the ballot to the election commissioner or
- 8 county clerk, and (4) has a notch, cutout, window, or other design that
- 9 permits the examination of the ballot for the presence of the authorized
- 10 signature required for ballots for early voting or the authorized
- 11 <u>initials required for provisional ballots cast at the polling place</u>
- 12 <u>without requiring the removal of the ballot or the revelation of any vote</u>
- 13 <u>marked on the ballot.</u>

- 15 amended to read:
- 16 32-202 In addition to any other duties prescribed by law, the
- 17 Secretary of State shall:
- 18 (1) Supervise the conduct of primary and general elections in this
- 19 state;
- 20 (2) Provide training for election commissioners, county clerks, and
- 21 other election officials in providing for registration of voters and the
- 22 conduct of elections;
- 23 (3) Enforce the Election Act;
- 24 (4) With the assistance and advice of the Attorney General, make
- 25 uniform interpretations of the act;
- 26 (5) Provide periodic training for the agencies and their agents and
- 27 contractors in carrying out their duties under sections 32-308 to 32-310;
- 28 (6) Develop and print forms for use as required by sections 32-308,

- 29 2014, is amended to read:
- 30 32-809 (1) The form of the official ballot at the statewide primary
- 31 election shall be prescribed by the Secretary of State. At the top of the

- 1 ballot and over all else shall be printed in boldface type the name of
- 2 the political party, Official Ballot, Primary Election 20...
- 3 Each division containing the names of the office and a list of candidates
- 4 for such office shall be separated from other groups by a bold line. The
- 5 ballot shall list at-large candidates and subdistrict candidates under
- 6 appropriate headings.
- (2) All proposals for constitutional amendments, candidates for 7 delegates to the national political party conventions, and candidates on 8 9 the nonpartisan ballot shall be submitted on a ballot where bold lines separate one office or issue from another. Proposals for constitutional 10 amendments proposed by the Legislature shall be placed on the ballot as 11 provided in sections 49-201 to 49-211. Each candidate for delegate to the 12 national political party convention shall have his or her preference for 13 the candidacy for the office of President of the United States or the 14 fact that he or she is uncommitted shown on the ballot in parenthesis and 15 16 indented on the line immediately below the name of the candidate. All 17 constitutional amendments shall be placed on a separate ballot when a paper ballot is used which requires the ballot after being voted to be 18 folded before being deposited in a ballot box. When an optical-scan 19 ballot is used which requires a secret-ballot envelope or ballot envelope 20 or sleeve in which the ballot after being voted is placed before being 21 deposited in a ballot box, constitutional amendments may be printed on 22 either side of the ballot and shall be separated from other offices or 23 24 issues by a bold line. Constitutional amendments so arranged shall 25 constitute a separate ballot.
- (3) Except as otherwise provided in section 32-811, the statewide primary election ballot shall contain the name of every candidate filing or recognized under subsection (1) of section 32-606 and sections 32-611, 32-613, and 32-614 and no other names. No name of a candidate for member of the Legislature or an elective office described in Article IV, section 1, of the Constitution of Nebraska shall appear on any ballot or any

- 1 series of ballots at any primary election more than once except for the
- 2 names of candidates for the office of delegate to a county, state, or
- 3 national political party convention. When two or more of the last names
- 4 of candidates for the same office at the primary election are the same in
- 5 spelling or sound, the official ballots may, on the request of any such
- 6 candidate, have his or her address printed immediately below his or her
- 7 name in capital and lowercase letters in lightface type of the same size
- 8 as the type in which the name of the candidate is printed.
- 9 Sec. 8. Section 32-813, Reissue Revised Statutes of Nebraska, is
- 10 amended to read:
- 11 32-813 (1) The names of all candidates and all proposals to be voted
- 12 upon at the general election shall be arranged upon the ballot in parts
- 13 separated from each other by bold lines in the order the offices and
- 14 proposals are set forth in this section. If any office is not subject to
- 15 the upcoming election, the office shall be omitted from the ballot and
- 16 the remaining offices shall move up so that the same relative order is
- 17 preserved. The order of any offices may be altered to allow for the best
- 18 utilization of ballot space in order to avoid printing a second ballot
- 19 when one ballot would be sufficient if an optical-scan ballot is used.
- 20 All proposals on the ballot shall remain separate from the offices, and
- 21 the proposals shall follow all offices on the ballot.
- 22 (2)(a) If the election is in a year in which a President of the
- 23 United States is to be elected, the names and spaces for voting for
- 24 candidates for President and Vice President shall be entitled
- 25 Presidential Ticket in boldface type.
- 26 (b) The names of candidates for President and Vice President for
- 27 each political party shall be grouped together, and each group shall be
- 28 enclosed with brackets with the political party name next to the brackets
- 29 and one square or oval opposite the names in which the voter indicates
- 30 his or her choice.
- 31 (c) The names of candidates for President and Vice President who

- 1 have successfully petitioned on the ballot for the general election shall
- 2 be grouped together with the candidates appearing on the same petition
- 3 being grouped together, and each group shall be enclosed with brackets
- 4 with the words "By Petition" next to the brackets and one square or oval
- 5 opposite the names in which the voter indicates his or her choice.
- 6 (d) Beneath the names of the candidates for President and Vice
- 7 President certified by the officers of the national political party
- 8 conventions pursuant to section 32-712 and beneath the names of all
- 9 candidates for President and Vice President placed on the general
- 10 election ballot by petition, two write-in lines shall be provided in
- 11 which the voter may fill in the names of the candidates of his or her
- 12 choice. The lines shall be enclosed with brackets with one square or oval
- 13 opposite the names in which the voter indicates his or her choice. The
- 14 name appearing on the top line shall be considered to be the candidate
- 15 for President, and the name appearing on the second line shall be
- 16 considered to be the candidate for Vice President.
- 17 (3) The names and spaces for voting for candidates for United States
- 18 Senator if any are to be elected shall be entitled United States
- 19 Senatorial Ticket in boldface type.
- 20 (4) The names and spaces for voting for candidates for
- 21 Representatives in Congress shall be entitled Congressional Ticket in
- 22 boldface type. Above the candidates' names, the office shall be
- 23 designated For Representative in Congress District.
- 24 (5) The names and spaces for voting for candidates for the various
- 25 state officers shall be entitled State Ticket in boldface type. Each set
- 26 of candidates shall be separated by lines across the column, and above
- 27 each set of candidates shall be designated the office for which they are
- 28 candidates, arranged in the order prescribed by the Secretary of State.
- 29 The candidates for Governor of each political party receiving the highest
- 30 number of votes in the primary election shall be grouped together with
- 31 their respective candidates for Lieutenant Governor. Each group shall be

- 1 enclosed with brackets with the political party name next to the brackets
- 2 and one square or oval opposite the names in which the voter indicates
- 3 his or her choice for Governor and Lieutenant Governor jointly. The
- 4 candidates for Governor and Lieutenant Governor who have successfully
- 5 petitioned on the general election ballot shall be grouped together with
- 6 the candidates appearing on the same petition being grouped together.
- 7 Each group shall be enclosed with brackets with the words "By Petition"
- 8 next to the brackets and one square or oval opposite the names in which
- 9 the voter indicates his or her choice for Governor and Lieutenant
- 10 Governor jointly. Beneath the names of the candidates for Governor
- 11 nominated at a primary election by political party and their respective
- 12 candidates for Lieutenant Governor and beneath the names of all
- 13 candidates for Governor and Lieutenant Governor placed on the general
- 14 election ballot by petition, one write-in line shall be provided in which
- 15 the registered voter may fill in the name of the candidate for Governor
- of his or her choice and one square or oval opposite the line in which
- 17 the voter indicates his or her choice for Governor.
- 18 (6) The names and spaces for voting for nonpartisan candidates shall
- 19 be entitled Nonpartisan Ticket in boldface type. The names of all
- 20 nonpartisan candidates shall appear in the order listed in this
- 21 subsection, except that when using an optical-scan ballot, the order of
- 22 offices may be altered to allow for the best utilization of ballot space
- 23 to avoid printing a second ballot when one ballot would be sufficient:
- 24 (a) Legislature;
- 25 (b) State Board of Education;
- 26 (c) Board of Regents of the University of Nebraska;
- 27 (d) Chief Justice of the Supreme Court;
- 28 (e) Judge of the Supreme Court;
- 29 (f) Judge of the Court of Appeals;

- 1 (i) Judge of the Separate Juvenile Court;

- 5 (7) The names and spaces for voting for the various county offices and for measures submitted to the county vote only or in only a part of 6 the county shall be entitled County Ticket in boldface type. If the 7 election commissioner or county clerk deems it advisable, the measures 8 9 may be submitted on a separate ballot if using a paper ballot or on 10 either side of an optical-scan ballot if the ballot is placed in a secret-ballot envelope or ballot envelope or sleeve before being 11 deposited in a ballot box. 12
- (8) The candidates for office in the precinct only or in the city or village only shall be printed on the ballot, except that if the election commissioner or county clerk deems it advisable, candidates for these offices may be submitted on a separate ballot if using a paper ballot or on either side of an optical-scan ballot if the ballot is placed in a secret-ballot envelope or ballot envelope or sleeve before being deposited in a ballot box.
- (9) All proposals submitted by initiative or referendum and 20 proposals for constitutional amendments shall be placed on a separate 21 ballot when a paper ballot is used which requires that the ballot after 22 being voted be folded before being deposited in a ballot box. When an 23 24 optical-scan ballot is used which requires a secret-ballot envelope or ballot envelope or sleeve in which the ballot after being voted is placed 25 before being deposited in a ballot box, initiative or referendum 26 proposals and proposals for constitutional amendments may be placed on 27 either side of the ballot, shall be separated by a bold line, and shall 28 follow all other offices placed on the same side of the ballot. 29 Initiative or referendum proposals and constitutional amendments so 30 arranged shall constitute a separate ballot. Proposals for constitutional 31

amendments proposed by the Legislature shall be placed on the ballot as 1

- 2 provided in sections 49-201 to 49-211.
- 3 Sec. 9. Section 32-816, Revised Statutes Cumulative Supplement,
- 4 2014, is amended to read:
- 5 32-816 (1) A blank space shall be provided at the end of each office
- division on the ballot for registered voters to fill in the name of any 6
- 7 person for whom they wish to vote and whose name is not printed upon the
- ballot, except that at the primary election there shall be no write-in 8
- 9 space for delegates to the county political party convention or delegates
- 10 to the national political party convention. A square or oval shall be
- printed opposite each write-in space similar to the square or oval placed 11
- opposite other candidates and issues on the ballot. The square or oval 12
- shall be marked to vote for a write-in candidate whose name appears in 13
- the write-in space provided. 14
- (2) The Secretary of State shall approve write-in space for optical-15
- scan ballots and electronic voting systems. Adequate provision shall be 16
- 17 made for write-in votes sufficient to allow one write-in space for each

- 32-902 (1) The election commissioner or county clerk shall cause 27
- instructions for the guidance of registered voters in preparing their 28
- ballots to be printed in large, clear type on cards in English. He or she 29
- shall furnish at least five such cards to each polling place in each 30
- precinct at the same time and in the same manner as the printed ballots. 31

- 1 The judges or clerks of election shall post such cards in each voting
- 2 booth on the day of election. The card shall contain full instructions on
- 3 preparing and casting ballots, including how to cast a write-in vote. The
- 4 form and contents of the cards shall be approved by the Secretary of

- 24 32-914 (1) Official ballots shall be used at all elections. No
- 25 person shall receive a ballot or be entitled to vote unless and until he
- 26 or she is registered as a voter except as provided in section 32-914.01,
- 27 32-914.02, 32-915, 32-915.01, or 32-936.
- 28 (2) Except as otherwise specifically provided, no ballot shall be
- 29 handed to any voter at any election until:
- 30 (a) He or she announces his or her name and address to the clerk of
- 31 election;

- 1 (b) The clerk has found that he or she is a registered voter at the
- 2 address as shown by the precinct list of registered voters unless
- 3 otherwise entitled to vote in the precinct under section 32-328,

- 9 at the polling place for the precinct in which he or she resides at a
- 10 different residence address as described in section 32-914.02, or whose
- 11 name appears with a notation that he or she received a ballot for early
- 12 voting, or who does not present identification or documentation required
- 13 <u>under subdivision (2)(c), (d), or (e) of section 32-914</u> may vote a
- 14 provisional ballot if he or she:

- 28 penalty of election falsification. Election falsification is a Class IV
- 29 felony and may be punished by up to five years imprisonment, a fine of up
- 30 to ten thousand dollars, or both.

- 1 registered voters for the polling place and the judge or clerk of
- 2 election determines that the person's residence address is located in
- 3 another precinct within the same county, the judge or clerk of election
