Committee:

- 1 A BILL FOR AN ACT relating to postsecondary education; to create and
- 2 provide duties for the Higher Education Affordability Commission.
- 3 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. (1) The Higher Education Affordability Commission is
- 2 <u>created. The executive committee of the commission shall consist of the</u>
- 3 following voting members:
- 4 <u>(a) The Speaker of the Legislature;</u>
- 5 (b) A member of the Education Committee of the Legislature,
- 6 appointed by the Executive Board of the Legislative Council;
- 7 (c) A member of the Appropriations Committee of the Legislature,
- 8 appointed by the Executive Board of the Legislative Council;
- 9 (c) A member of the Revenue Committee of the Legislature, appointed
- 10 by the Executive Board of the Legislative Council; and
- 11 (e) Two at-large members of the Legislature, appointed by the
- 12 <u>Executive Board of the Legislative Council.</u>
- 13 The voting members of the executive committee shall choose a
- 14 <u>chairperson and vice-chairperson from among the voting members.</u>
- 15 (2)(a) The President of the University of Nebraska or his or her
- 16 designee, the Chancellor of the Nebraska State College System or his or
- 17 her designee, a representative of the private, not for profit colleges
- 18 and universities in Nebraska, and a representative of the Nebraska
- 19 community colleges shall be nonvoting ex officio members of the executive
- 20 committee of the commission.
- 21 (b) The executive committee may appoint up to two additional
- 22 nonvoting members of the commission.
- 23 Sec. 2. (1) The Higher Education Affordability Commission shall:
- 24 (a) Share, examine, and analyze data and information regarding
- 25 affordability of postsecondary education in Nebraska with a primary focus
- 26 on innovative ways to reduce the expense for students and families;
- 27 (b) Encourage participation and input from academic experts,
- 28 students, college financial aid advisers, members of the banking
- 29 community, and others in exploring strategies and solutions to the ever-
- 30 increasing cost of postsecondary education and the financial burden on
- 31 students and families; and

- 1 (c) Research best practices utilized by other states in addressing
- 2 college affordability, including loan forgiveness programs that allow
- 3 students to attend a postsecondary educational institution at no cost.
- 4 (2) To accomplish its duties, the commission may request and receive
- 5 from any postsecondary educational institution information relating to
- 6 costs of postsecondary education, including tuition and all fees.
- 7 (3) On or before December 1, 2015, the commission shall submit a
- 8 report of its findings and recommendations electronically to the
- 9 Executive Board of the Legislative Council, the Education Committee of
- 10 the Legislature, and the Appropriations Committee of the Legislature. The
- 11 report shall include:
- 12 (a) A ten-year plan to address college affordability;
- 13 (b) A legislative proposal to create a pilot program to address
- 14 <u>affordability of postsecondary education from the best and innovative</u>
- 15 practices in other states; and
- 16 (c) Other recommendations of the commission to address the overall
- 17 <u>issue of access to and affordability of postsecondary education in</u>
- 18 Nebraska.
