- 1 A BILL FOR AN ACT relating to education; to amend sections 73-106, 2 79-215, 79-301, 79-318, 79-420, 79-760.01, 79-760.02, 79-760.06, 3 79-1205, 79-1315, 79-2204, and 79-2205, Reissue Revised Statutes of Revised 4 Nebraska, and section 71-1962, Statutes Cumulative Supplement, 2014; to change provisions relating to the Nebraska 5 6 Early Childhood Professional Record System, advertising for bids, 7 admission of homeless students, the deputy commissioner of education, academic content standards, adjustment of educational 8 9 service unit boundaries, and the State Council on Educational Opportunity for Military Children; to eliminate provisions relating 10 to annual school meetings as prescribed; to harmonize provisions; 11 12 and to repeal the original sections.

1 Section 1. Section 71-1962, Revised Statutes Cumulative Supplement,

- 2 2014, is amended to read:
- 3 71-1962 (1) Not later than March 1, 2014, the State Department of
- 4 Education shall create and operate the Nebraska Early Childhood
- 5 Professional Record System. The system shall be designed in order to:
- 6 (a) Establish a data base of Nebraska's early childhood education 7 workforce;
- 8 (b) Verify educational degrees and professional credentials held and
- 9 relevant training completed by employees of participating applicable
- 10 child care and early childhood education programs; and

- 23 (3) Any child care or early childhood education provider residing or
- 24 working in Nebraska may report his or her educational degrees and
- 25 professional credentials held, relevant training completed, and work
- 26 history to the Nebraska Early Childhood Professional Record System.
- 27 Sec. 2. Section 73-106, Reissue Revised Statutes of Nebraska, is
- 28 amended to read:
- 29 73-106 Whenever any public school district in the state expends
- 30 public funds for the construction, remodeling, or repair of any school-
- 31 owned building or for site improvements, other than those expenditures

- 1 authorized by section 79-10,104 for facilities which are not to be owned
- 2 by the district following their completion, the school board or its
- 3 representative shall advertise for bids in the regular manner established
- 4 by the board and accept or reject bids pursuant to section 73-101, except
- 5 that nothing in this section applies to such construction, remodeling,
- 6 repair, or site improvements when the contemplated expenditure for the
- 7 complete project does not exceed one hundred forty thousand dollars. This
- 8 section does not apply to (a) the acquisition of existing buildings,
- 9 purchase of new sites, or site expansions by the school district or (b)

- 15 amended to read:
- 16 79-215 (1) Except as otherwise provided in this section, a student
- 17 is a resident of the school district where he or she resides and shall be
- 18 admitted to any such school district upon request without charge.
- 19 (2) A school board shall admit a student upon request without charge
- 20 if at least one of the student's parents resides in the school district.
- 21 (3) A school board shall admit any homeless student upon request
- 22 without charge if the district is the district in which the student (i)
- 23 <u>is currently located, (ii) attended when permanently housed, or (iii) was</u>
- 24 <u>last enrolled</u>.
- 25 (4) A school board may allow a student whose residency in the
- 26 district ceases during a school year to continue attending school in such
- 27 district for the remainder of that school year.
- 28 (5) A school board may admit nonresident students to the school
- 29 district pursuant to a contract with the district where the student is a
- 30 resident and shall collect tuition pursuant to the contract.
- 31 (6) A school board may admit nonresident students to the school

- 1 district pursuant to the enrollment option program as authorized by 2 sections 79-232 to 79-246, and such admission shall be without charge.
- 3 (7) A school board of any school district that is a member of a 4 learning community shall admit nonresident students to the school 5 district pursuant to the open enrollment provisions of a diversity plan 6 in a learning community as authorized by section 79-2110, and such 7 admission shall be without charge.
- 8 (8) A school board may admit a student who is a resident of another
 9 state to the school district and collect tuition in advance at a rate
 10 determined by the school board.
- (9) When a student as a ward of the state or as a ward of any court 11 (a) has been placed in a school district other than the district in which 12 13 he or she resided at the time he or she became a ward and such ward does not reside in a foster family home licensed or approved by the Department 14 of Health and Human Services or a foster home maintained or used pursuant 15 to section 83-108.04 or (b) has been placed in any institution which 16 maintains a special education program which has been approved by the 17 State Department of Education and such institution is not owned or 18 operated by the district in which he or she resided at the time he or she 19 became a ward, the cost of his or her education and the required 20 transportation costs associated with the student's education shall be 21 paid by the state, but not in advance, to the receiving school district 22 or approved institution under rules and regulations prescribed by the 23 24 Department of Health and Human Services and the student shall remain a 25 resident of the district in which he or she resided at the time he or she became a ward. Any student who is a ward of the state or a ward of any 26 court who resides in a foster family home licensed or approved by the 27 Department of Health and Human Services or a foster home maintained or 28 used pursuant to section 83-108.04 shall be deemed a resident of the 29 district in which he or she resided at the time he or she became a foster 30 child, unless it is determined under section 43-1311 or 43-1312 that he 31

4 (10)(a) When a student is not a ward of the state or a ward of any court and is residing in a residential setting located in Nebraska for 5 reasons other than to receive an education and the residential setting is 6 7 operated by a service provider which is certified or licensed by the Department of Health and Human Services or is enrolled in the medical 8 9 assistance program established pursuant to the Medical Assistance Act and Title XIX or XXI of the federal Social Security Act, as amended, the 10 student shall remain a resident of the district in which he or she 11 resided immediately prior to residing in such residential setting. The 12 13 resident district for a student who is not a ward of the state or a ward of any court does not change when the student moves from one residential 14 15 setting to another.

(b) If a student is residing in a residential setting as described in subdivision (10)(a) of this section and such residential setting does not maintain an interim-program school as defined in section 79-1119.01 or an approved or accredited school, the resident school district shall contract with the district in which such residential setting is located for the provision of all educational services, including all special education services and support services as defined in section 79-1125.01, unless a parent or guardian and the resident school district agree that an appropriate education will be provided by the resident school district while the student is residing in such residential setting. If the resident school district is required to contract, the district in which such residential setting is located shall contract with the resident district and provide all educational services, including all special education services, to the student. If the two districts cannot agree on the amount of the contract, the State Department of Education shall determine the amount to be paid by the resident district to the district 1 in which such residential setting is located based on the needs of the

- 2 student, approved special education rates, the department's general
- 3 experience with special education budgets, and the cost per student in
- 4 the district in which such residential setting is located. Once the
- 5 contract has been entered into, all legal responsibility for special
- 6 education and related services shall be transferred to the school
- 7 district in which the residential setting is located.
- 8 (c) If a student is residing in a residential setting as described
- 9 in subdivision (10)(a) of this section and such residential setting
- 10 maintains an interim-program school as defined in section 79-1119.01 or
- 11 an approved or accredited school, the department shall reimburse such
- 12 residential setting for the provision of all educational services,
- 13 including all special education services and support services, with the
- 14 amount of payment for all educational services determined pursuant to the
- 15 average per pupil cost of the service agency as defined in section
- 16 79-1116. The resident school district shall retain responsibility for
- 17 such student's individualized education plan, if any. The educational
- 18 services may be provided through (i) such interim-program school or
- 19 approved or accredited school, (ii) a contract between the residential
- 20 setting and the school district in which such residential setting is
- 21 located, (iii) a contract between the residential setting and another
- 22 service agency as defined in section 79-1124, or (iv) a combination of
- 23 such educational service providers.
- 24 (d) If a school district pays a school district in which a
- 25 residential setting is located for educational services provided pursuant
- 26 to subdivision (10)(b) of this section and it is later determined that a
- 27 different school district was the resident school district for such
- 28 student at the time such educational services were provided, the school
- 29 district that was later determined to be the resident school district
- 30 shall reimburse the school district that initially paid for the
- 31 educational services one hundred ten percent of the amount paid.

- (e) A student residing in a residential setting described in this subsection shall be defined as a student with a handicap pursuant to Article VII, section 11, of the Constitution of Nebraska, and as such the state and any political subdivision may contract with institutions not wholly owned or controlled by the state or any political subdivision to provide the educational services to the student if such educational services are nonsectarian in nature.
- (11) In the case of any individual eighteen years of age or younger 8 9 who is a ward of the state or any court and who is placed in a county detention home established under section 43-2,110, the cost of his or her 10 education shall be paid by the state, regardless of the district in which 11 he or she resided at the time he or she became a ward, to the agency or 12 13 institution which: (a) Is selected by the county board with jurisdiction over such detention home; (b) has agreed or contracted with such county 14 board to provide educational services; and (c) has been approved by the 15 16 State Department of Education pursuant to rules and regulations 17 prescribed by the State Board of Education.
- 18 (12) No tuition shall be charged for students who may be by law 19 allowed to attend the school without charge.
- (13) On a form prescribed by the State Department of Education, an 20 adult with legal or actual charge or control of a student shall provide 21 the name of the student, the name of the adult with legal or actual 22 charge or control of the student, the address where the student is 23 24 residing, and the telephone number and address where the adult may generally be reached during the school day. If the student is homeless or 25 if the adult does not have a telephone number and address where he or she 26 may generally be reached during the school day, those parts of the form 27 may be left blank and a box may be marked acknowledging that these are 28 the reasons these parts of the form were left blank. The adult with legal 29 or actual charge or control of the student shall also sign the form. 30
 - (14) The department may adopt and promulgate rules and regulations

- 4 79-301 (1) The State Department of Education provided for in Article
- 5 VII, section 2, of the Constitution of Nebraska shall consist of a State
- 6 Board of Education and a Commissioner of Education. The State Department
- 7 of Education shall have general supervision and administration of the
- 8 school system of the state and of such other activities as the
- 9 Legislature may direct.
- 10 (2) The State Board of Education, acting as a unit, shall be the
- 11 policy-forming, planning, and evaluative body for the state school
- 12 program. Except in the appointment of a Commissioner of Education, the
- 13 board shall deliberate and take action with the professional advice and
- 14 counsel of the Commissioner of Education.
- 15 (3) The Commissioner of Education shall be the executive officer of

- 10 such devise, donation, or bequest is for the best interest of the center
- 11 or the students receiving services from the center, or both, and irrigate
- or otherwise improve any such real estate when in the board's judgment it
- 13 would be advisable to do so;
- 14 (14) Accept, in order to administer the Interstate Compact on
- 15 Educational Opportunity for Military Children, any devise, donation, or
- 16 bequest received by the State Department of Education pursuant to section
- 17 79-2206; and
- 18 (15) Upon acceptance of any devise, donation, or bequest as provided

1 79-420 Within thirty days after the creation of a new school 2 district pursuant to sections 79-413 to 79-419, the State Committee for the Reorganization of School Districts shall appoint from among the legal 3 voters of the new school district created the number of members necessary 4 to constitute a school board of the class in which the new school 5 district has been classified. Members of the first board shall be 6 appointed so that their terms will expire in accord with provisions of 7 law governing school districts of the class involved. The board so 8 appointed shall organize at once in the manner prescribed by law. A 9 reorganized school district shall be formed, organized, and have a 10 governing board not later than June April 1 following the last legal 11 action, as prescribed in section 79-413, necessary to effect the changes 12 in boundaries as set forth in the petition, although the physical 13 reorganization of such reorganized school district may not take effect 14 until the commencement of the following school year. The standards shall cover the subject areas of reading, writing, mathematics, science, and 25 social studies. The standards adopted shall be sufficiently clear and 26 measurable to be used for testing student performance with respect to 27 mastery of the content described in the state standards. The State Board 28 of Education shall develop a plan to review and update standards for each 29 30 subject area every seven five years. The state board shall review and update the standards in reading by July 1, 2009, the standards in 31

- 1 mathematics by July 1, 2010, and the standards in all other subject areas
- 2 by July 1, 2013. The state board plan shall include a review of commonly
- 3 accepted standards adopted by school districts.
- 4 Sec. 8. Section 79-760.02, Reissue Revised Statutes of Nebraska, is
- 5 amended to read:
- 6 79-760.02 In accordance with timelines that are adopted by the State
- 7 Board of Education, but in no event later than one year following the
- 8 adoption or modification of state standards, each school district shall
- 9 adopt measurable quality academic content standards in the subject areas
- 10 of reading, writing, mathematics, science, and social studies. The
- 11 standards may be the same as, or may be equal to or exceed in rigor, the
- 12 measurable academic content standards adopted by the state board and
- 13 shall cover at least the same grade levels. School districts may work
- 14 collaboratively with educational service units, with learning
- 15 communities, or through interlocal agreements to develop such standards.
- 16 Educational service units and learning communities shall develop a
- 17 composite set of standards shared by member school districts.
