3 "(1) ~~Disclose the automatic renewal clause clearly and conspicuously in the~~
4 ~~contract or contract offer.~~Provide a disclosure statement that provides notice
5 of all of the following clearly and conspicuously in at least 12 point type and
6 in bold print:

7 a. That the contract will be automatically renewed unless the consumer
8 gives notice to the seller of the consumer's intention to terminate the
9 contract prior to the renewal date. There shall be a space beside this
10 disclosure to be initialed by the consumer acknowledging the
11 consumer's specific consent to this provision of the contract."

13 and on page 1, lines 28-29, by rewriting the lines to read:

15 "(1a) Impose no charge for an automatic renewal if the consumer did not initial the
16 space provided beside the disclosure required in sub-subdivision (a)(1)a. of
17 this section.";

22 ~~Statutes, or to banks, trust companies, savings and loan associations, savings banks, or credit~~
23 ~~unions licensed or organized under the laws of any state or the United States, or any foreign bank~~
24 ~~maintaining a branch or agency licensed under the laws of the United States, or any subsidiary~~
25 ~~or affiliate thereof, nor does this section apply to any entity subject to regulation by the Federal~~
26 ~~Communications Commission under Title 47 of the United States Code or by the North Carolina~~
27 ~~Utilities Commission under Chapter 62 of the General Statutes, or to any entity doing business~~
28 ~~directly or through an affiliate pursuant to a franchise, license, certificate, or other authorization~~
