- 2 Century Code, relating to juvenile court petitions, fitness to proceed in juvenile court
- 3 proceedings, and collateral consequences the juvenile court may order; to amend and reenact

4 sections 12.1-04.1-01, 12.1-04.1-20, and 12.1-17-01.2, subsection 2 of section 12.1-17-07.2,

5 section 12.1-20-01, subsections 2 and 6 of section 12.1-31-03, sections 12.1-32-15 and

6 15.1-09-33.4, subsection 6 of section 27-20.2-01, subsection 3 of section 27-20.2-09,

8 27-20.4-20, and section 62.1-02-01 of the North Dakota Century Code, relating to lack of

9 criminal responsibility, court jurisdiction, distribution of intimate images without consent,

10 domestic violence, criminality of a child regarding sex offenses, sale and use of tobacco by an

11 individual under the age of twenty-one, child registration requirements, restitution, probation of a

12 delinquent child, extracurricular activities for students, and persons not allowed to possess a

13 firearm; to repeal sections 27-20.4-12, 27-20.4-13, and 27-20.4-19 of the North Dakota Century

14 Code, relating to delinquency; to provide an appropriation; and to provide a penalty.

15 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

16 SECTION 1. AMENDMENT. Section 12.1-04.1-01 of the North Dakota Century Code is

17 amended and reenacted as follows:

18 **12.1-04.1-01. Standard for lack of criminal responsibility.**

An individual is not criminally responsible for criminal conduct if, as a result of mental
 disease or defect existing at the time the conduct occurs:

1		a. The individual lacks substantial capacity to comprehend the harmful nature or
2		consequences of the conduct, or the conduct is the result of a loss or serious
3		distortion of the individual's capacity to recognize reality; and
4		b. It is an essential element of the crime charged that the individual act willfully.
5	2.	For purposes of this chapter, repeated criminal or similar antisocial conduct, or
6		impairment of mental condition caused primarily by voluntary use of alcoholic
7		beverages or controlled substances immediately before or contemporaneously with
8		the alleged offense, does not constitute in itself mental illness or defect at the time of
9		the alleged offense. Evidence of the conduct or impairment may be probative in
10		conjunction with other evidence to establish mental illness or defect.
11	<u>3.</u>	An individual ten years of age or older may be assessed for criminal responsibility
12		under this chapter.
13	SEC	TION 2. AMENDMENT. Section 12.1-04.1-20 of the North Dakota Century Code is
14	amende	d and reenacted as follows:
15	12.1	-04.1-20. Jurisdiction of court.
16	1.	Unless earlier discharged by order of the court pursuant to section 12.1-04.1-22,
17		12.1-04.1-24, or 12.1-04.1-25, an individual found not guilty by reason of lack of
18		criminal responsibility is subject to the jurisdiction of the court for a period equal to the
19		maximum term of imprisonment that could have been imposed for the most serious
20		crime of which the individual was charged but found not guilty by reason of lack of
21		criminal responsibility. In a juvenile proceeding, a child not adjudicated by reason of
22		lack of criminal responsibility is subject to the jurisdiction of the court for one year.
23	2.	Upon expiration of its jurisdiction under this chapter or earlier discharge by its order,
24		the court may order that a proceeding for involuntary commitment be initiated pursuant
25		to chapter 25-03.1. In a juvenile proceeding, the court may order an investigation into
26		whether a child in need of protection proceedings should be initiated.
27	SEC	TION 3. AMENDMENT. Section 12.1-17-01.2 of the North Dakota Century Code is
28	amende	d and reenacted as follows:

30	1.	For purposes of this section "family or household member" means family or household
31		member as defined in section 14-07.1-01.

1	2.	A pe	erson is guilty of an offense if that person willfully causes:

3		b.	Substantial bodily injury to the actor's family or household member; or
4		C.	Serious bodily injury to the actor's family or household member.

6		a.	A class B misdemeanor for the first offense under subdivision a of subsection 2
7			and a class A misdemeanor for a second or subsequent offense under this

19	<u>5.</u>	<u>This</u>	section applies to an individual under the age of eighteen only if the:

28			person to distribute the intimate image;
29		b.	The intimate image was created by or provided to the person under
30			circumstances in which the individual has a reasonable expectation of privacy;

- c. Actual emotional distress or harm is caused to the individual as a result of the
 distribution under this section.
- 3 SECTION 5. AMENDMENT. Section 12.1-20-01 of the North Dakota Century Code is
 4 amended and reenacted as follows:
- 5 **12.1-20-01.** General provisions.
- 6 In sections 12.1-20-03 through 12.1-20-08:
- 7 1. When the criminality of conduct depends on a child'schild being below the age of
 8 fifteen, it is no defense that the actor did not know the child's age, or reasonably
 9 believed the child to be older than fourteen.
- When criminality depends on the victim being a minor, it is an affirmative defense that
 the actor reasonably believed the victim to be an adult.
- When criminality depends on the victim being a minor fifteen years of age or older, the
 actor is guilty of an offense only if the actor is at least three years older than the minor.
- 4. When criminality depends on the victim being below the age of fifteen, and the actor is
 a minor, the actor is guilty of an offense only if the actor is at least three years older
 then the victim
- 16 <u>than the victim.</u>

17 SECTION 6. AMENDMENT. Subsection 2 of section 12.1-31-03 of the North Dakota

18 Century Code is amended and reenacted as follows:

19 2. It is a noncriminal offense for an individual under twenty-oneeighteen years of age or 20 older but under twenty-one years of age, and an infraction for an individual fourteen 21 years of age or older but under eighteen years of age, to purchase, possess, smoke, 22 or use cigarettes, cigars, cigarette papers, snuff, tobacco in any other form in which it 23 may be utilized for smoking or chewing, electronic smoking devices, or alternative 24 nicotine products. However, an individual under twenty-one years of age may 25 purchase and possess tobacco, electronic smoking devices, or alternative nicotine 26 products as part of a compliance survey program when acting with the permission of 27 the individual's parent or guardian and while acting under the supervision of any law 28 enforcement authority. A state agency, city, county, board of health, tobacco, electronic 29 smoking devices, or alternative nicotine products retailer, or association of tobacco, 30 electronic smoking devices, or alternative nicotine products retailers may also conduct compliance surveys, after coordination with the appropriate local law enforcement
 authority.

3 SECTION 7. AMENDMENT. Subsection 6 of section 12.1-31-03 of the North Dakota
4 Century Code is amended and reenacted as follows:

- 6. An individual fourteen years of age or older <u>but under eighteen years of age</u> found to
 have violated subsection 2 or 4 must pay a fee of twenty-five dollarshas committed an
 infraction and must be sent to juvenile court. An individual eighteen years of age or
 older but under twenty-one years of age found to have violated subsection 2 or 4 must
 pay a fee of twenty-five dollars.
- 10 a. Any individual who has been cited for a violation of subsection 2 or 4 may appear 11 before a court of competent jurisdiction and pay the fee by the time scheduled for 12 a hearing, or if bond has been posted, may forfeit the bond by not appearing at 13 the scheduled time. An individual appearing at the time scheduled in the citation 14 may make a statement in explanation of that individual's action and the judge 15 may waive, reduce, or suspend the fee or bond, or both. If the individual cited 16 follows the procedures of this subdivision, that individual has admitted the 17 violation and has waived the right to a hearing on the issue of commission of the 18 violation. The bond required to secure appearance before the court must be 19 identical to the fee. This subdivision does not allow a citing officer to receive the 20 fee or bond.
- 21 b. If an individual cited for a violation of subsection 2 or 4 does not choose to follow 22 the procedures provided under subdivision a, that individual may request a 23 hearing on the issue of the commission of the violation cited. The hearing must 24 be held at the time scheduled in the citation or at some future time, not to exceed 25 ninety days later, set at that first appearance. At the time of a request for a 26 hearing on the issue on commission of the violation, the individual cited shall 27 deposit with the court an appearance bond equal to the fee for the violation cited. 28 The failure to post bond or to pay an assessed fee is punishable as a contempt of C.

29 court, except an individual may not be imprisoned for the contempt.

30 SECTION 8. AMENDMENT. Section 12.1-32-15 of the North Dakota Century Code is
 31 amended and reenacted as follows:

13		C.	"Homeless" means an individual who is physically present in this state, but is
14			living in a park, under a bridge, on the streets, in a vehicle or camper, or is
15			otherwise without a traditional dwelling, and also one who resides in this state but
16			does not maintain a permanent address. The term does not include individuals
17			who are temporarily domiciled or individuals residing in public or private shelters
18			that provide temporary living accommodations.
19		d.	"Mental abnormality" means a congenital or acquired condition of an individual
20			that affects the emotional or volitional capacity of the individual in a manner that
21			predisposes that individual to the commission of criminal sexual acts to a degree
22			that makes the individual a menace to the health and safety of other individuals.
23		e.	"Predatory" means an act directed at a stranger or at an individual with whom a
24			relationship has been established or promoted for the primary purpose of
25			victimization.
26		f.	"Reside" means to live permanently or be situated for a considerable time in a
27			home or a particular place.
28		g.	"Sexual offender" means a person who has pled guilty to or been found guilty,
29			including juvenile delinquent adjudications, of a violation of section 12.1-20-03,
30			12.1-20-03.1, 12.1-20-04, 12.1-20-05, 12.1-20-05.1, 12.1-20-06, 12.1-20-06.1,
31			12.1-20-07 except for subdivision a of subsection 1, 12.1-20-11, 12.1-20-12.1,

1			12.1-20-12.2, 12.1-20-12.3 except for subdivision a of subsection 1 and
2			subdivision b of subsection 1 if the offense involves only a demand for money,
3			chapter 12.1-27.2, subsection 2 of section 12.1-22-03.1, subdivision b of
4			subsection 1 of section 12.1-41-02, section 12.1-41-04, 12.1-41-05, or
5			12.1-41-06, or an equivalent offense from another court in the United States, a
6			tribal court, or court of another country, or an attempt or conspiracy to commit
7			these offenses.
8		h.	"Sexually dangerous individual" means an individual who meets the definition
9			specified in section 25-03.3-01.
10		i.	"Temporarily domiciled" means staying or being physically present in this state for
11			more than thirty days in a calendar year or at a location for longer than ten
12			consecutive days, attending school for longer than ten days, or maintaining
13			employment in the jurisdiction for longer than ten days, regardless of the state of
14			the residence.
15	2.	The	court shall impose, in addition to any penalty provided by law, a requirement that
16		the	individual register, within three days of coming into a county in which the individual
17		resi	des, is homeless, or within the period identified in this section that the individual
18		bec	omes temporarily domiciled. The individual must register with the chief of police of
19		the	city of the individual's place of residence, or the sheriff of the county if the
20		indi	vidual resides in an area other than a city. A homeless individual shall register
21		eve	ry three days with the sheriff or chief of police of the jurisdiction in which the
22		indi	vidual is physically present. The court shall require an individual to register by
23		stat	ing this requirement on the court records, if that individual:
24		a.	Has pled guilty or nolo contendere to, or been found guilty as a felonious sexual
25			offender or an attempted felonious sexual offender, including juvenile delinquent-
26			adjudications of equivalent offenses unless the offense is listed in subdivision c.
27		b.	Has pled guilty or nolo contendere to, or been found guilty as a sexual offender
28			for, a misdemeanor or attempted misdemeanor. The court may deviate from
29			requiring an individual to register if the court first finds the individual is no more
30			than three years older than the victim if the victim is a minor, the individual has
31			not previously been convicted as a sexual offender or of a crime against a child,

1		and the individual did not exhibit mental abnormality or predatory conduct in the
2		commission of the offense.
3	C.	Is a juvenile found delinquent under subdivision d of subsection 1 of section
4		12.1-20-03, subdivision a of subsection 2 of section 12.1-20-03, or as a sexual
5		offender for a misdemeanor. The court may deviate from requiring the juvenile to-
6		register if the court first finds the juvenile has not previously been convicted as a
7		sexual offender or for a crime against a child, and the juvenile did not exhibit
8		mental abnormality or predatory conduct in the commission of the offense.
9	d.	Has pled guilty or nolo contendere to, or been found guilty of, a crime against a
10		child or an attempted crime against a child , including juvenile delinquent
11		adjudications of equivalent offenses. Except if the offense is described in section
12		12.1-29-02, or section 12.1-18-01 or 12.1-18-02 and the person is not the parent
13		of the victim, the court may deviate from requiring an individual to register if the
14		court first finds the individual has not previously been convicted as a sexual
15		offender or for a crime against a child, and the individual did not exhibit mental
16		abnormality or predatory conduct in the commission of the offense.
17	e.<u>d.</u>	Has pled guilty or nolo contendere , <u>or</u> been found guilty , or been adjudicated
18		delinquent of any crime against another individual which is not otherwise
19		specified in this section if the court determines that registration is warranted by
20		the nature of the crime and therefore orders registration for the individual. If the
21		court orders an individual to register as an offender under this section, the
22		individual shall comply with all of the registration requirements in this chapter.
23	<u>e.</u>	Is a child who has been adjudicated delinquent of an offense which would classify
24		the child as a sexual offender, the prosecutor requested the court to consider
25		sexual offender registration, and the court determines the child:
26		(1) Exhibited a mental abnormality or predatory conduct in the commission of
27		the offense; or
28		(2) Previously has been adjudicated as a sexual offender.
29	3. If a	court has not ordered an individual to register in this state, an individual who
30	resi	des, is homeless, or is temporarily domiciled in this state shall register if the
31	indiv	/idual:

- 1a.Is incarcerated or is on probation or parole after July 31, 1995, for a crime2against a child described in section 12.1-29-02, or section 12.1-18-01 or312.1-18-02 if the individual was not the parent of the victim, or as a sexual4offender;
- b. Has pled guilty or nolo contendere to, or <u>has</u> been adjudicated for or found guilty
 of, an offense in a court of this state for which registration is mandatory under this
 section or an offense from another court in the United States, a tribal court, or
 court of another country equivalent to those offenses set forth in this section; or
- 9 c. Has pled guilty or nolo contendere to, or has been found guilty of, a crime against
 10 a child or as a sexual offender for which registration is mandatory under this
 11 section if the conviction occurred after July 31, 1985.
- 12 In its consideration of mental abnormality or predatory conduct, the court shall 4. 13 consider the age of the offender, the age of the victim, the difference in ages of the 14 victim and offender, the circumstances and motive of the crime, the relationship of the 15 victim and offender, and the mental state of the offender. The court may order an 16 offender to be evaluated by a qualified counselor, psychologist, or physician before 17 sentencing. Except as provided under subdivision ed of subsection 2, the court 18 shallmay state on the record in open court its affirmative finding for not requiring an 19 offender to register.
- 20 5. When an individual is required to register under this section, the official in charge of a 21 facility or institution where the individual required to register is confined, or the 22 department, shall, before the discharge, parole, or release of that individual, inform the 23 individual of the duty to register pursuant to this section. The official or the department 24 shall require the individual to read and sign a form as required by the attorney general, 25 stating that the duty of the individual to register has been explained to that individual. 26 The official in charge of the place of confinement, or the department, shall obtain the 27 address where the individual expects to reside, attend school, or work upon discharge, 28 parole, or release and shall report the address to the attorney general. The official in 29 charge of the place of confinement, or the department, shall give three copies of the 30 form to the individual and shall send three copies to the attorney general no later than 31 forty-five days before the scheduled release of that individual. The attorney general

shall forward one copy to the law enforcement agency having jurisdiction where the
individual expects to reside, attend school, or work upon discharge, parole, or release,
one copy to the prosecutor who prosecuted the individual, and one copy to the court in
which the individual was prosecuted. All forms must be transmitted and received by
the law enforcement agency, prosecutor, and court thirty days before the discharge,
parole, or release of the individual.

7 An individual who is required to register pursuant to this section who is released on 6. 8 probation or discharged upon payment of a fine must, before the release or discharge, 9 be informed of the duty to register under this section by the court in which that 10 individual is convicted. The court shall require the individual to read and sign a form as 11 required by the attorney general, stating that the duty of the individual to register under 12 this section has been explained to that individual. The court shall obtain the address 13 where the individual expects to reside, attend school, or work upon release or 14 discharge and shall report the address to the attorney general within three days. The 15 court shall give one copy of the form to the individual and shall send two copies to the 16 attorney general. The attorney general shall forward one copy to the appropriate law 17 enforcement agency having jurisdiction where the individual expects to reside, attend 18 school, or work upon discharge, parole, or release.

19 7. Registration consists of a written or electronic statement signed by the individual, 20 giving the information required by the attorney general, and the biometric data and 21 photograph of the individual. An individual who is not required to provide a sample of 22 blood and other body fluids under section 31-13-03 or by the individual's state or court 23 of conviction or adjudication shall submit a sample of blood and other body fluids for 24 inclusion in a centralized database of DNA identification records under section 25 31-13-05. The collection, submission, testing and analysis of, and records produced 26 from, samples of blood and other body fluids, are subject to chapter 31-13. Evidence 27 of the DNA profile comparison is admissible in accordance with section 31-13-02. A 28 report of the DNA analysis certified by the state crime laboratory is admissible in 29 accordance with section 31-13-05. A district court shall order an individual who refuses 30 to submit a sample of blood or other body fluids for registration purposes to show 31 cause at a specified time and place why the individual should not be required to

1 submit the sample required under this subsection. Within three days after registration, 2 the registering law enforcement agency shall forward the statement, biometric data, 3 and photograph to the attorney general and shall submit the sample of the individual's 4 blood and body fluids to the state crime laboratory. If an individual required to register 5 under this section has a change in vehicle or computer online identity, the individual 6 shall register, within three days after the change, with the law enforcement agency 7 having local jurisdiction of the individual's place of residence of the individual's new 8 vehicle or computer online identity. If an individual required to register pursuant to this 9 section has a change in name, school, or residence or employment address, that 10 individual shall register, at least ten days before the change, with the law enforcement 11 agency having local jurisdiction of the individual's place of residence of the individual's 12 new name, school, residence address, or employment address. A change in school or 13 employment address includes the termination of school or employment for which an 14 individual required to register under this section, the individual shall register within 15 three days of the termination with the law enforcement agency having local jurisdiction 16 of the individual's place of residence. The law enforcement agency, within three days 17 after receipt of the information, shall forward it to the attorney general. The attorney 18 general shall forward the appropriate registration data to the law enforcement agency 19 having local jurisdiction of the new place of residence, school, or employment. Upon a 20 change of address, the individual required to register also shall register within three 21 days at the law enforcement agency having local jurisdiction of the new place of 22 residence. If an individual required to register in North Dakota, including in a tribal 23 registry, resides in another state or on tribal lands, that individual shall register 24 employment and school addresses and any changes in required registration 25 information with the law enforcement agency having local jurisdiction over the school 26 or employment address. The individual registering under this section shall periodically 27 confirm the information required under this subsection in a manner and at an interval 28 determined by the attorney general. A law enforcement agency that has previously 29 registered an offender may omit the biometric data portion of the registration if that 30 agency has a set of biometric data on file for that individual and is personally familiar

- violates this section from serving a term of at least ninety days in jail and completing
 probation of one year.
- When an individual is released on parole or probation and is required to register
 pursuant to this section, but fails to do so within the time prescribed, the court shall
 order the probation, or the parole board shall order the parole, of the individual
 revoked.
- 11. If an individual required to register pursuant to this section is temporarily sent outside
 the facility or institution where that individual is confined under conviction or sentence,
 the local law enforcement agency having jurisdiction over the place where that
 individual is being sent must be notified within a reasonable time period before that
 individual is released from the facility or institution. This subsection does not apply to
 any individual temporarily released under guard from the facility or institution in which
 that individual is confined.
- 14 12. The attorney general, with the assistance of the department and the juvenile courts,
 15 shall develop guidelines for the risk assessment of sexual offenders who are required
 16 to register, with a low-risk, moderate-risk, or high-risk level being assigned to each
 17 offender as follows:
- 18a.The department shall conduct a risk assessment of sexual offenders who are19incarcerated in institutions under the control of the department and sexual20offenders who are on supervised probation. The department, in a timely manner,21shall provide the attorney general any information, including the offender's level22of risk and supporting documentation, concerning individuals required to be23registered under this section who are about to be released or placed into the24community.
