11	An Act relating to firearms; amending 21 O.S. 2021, Section 1289.9, which relates to carrying weapons
12	while under the influence of alcohol; modifying provisions of unlawful act; amending 21 O.S. 2021,
13	Section 1290.11, which relates to eligibility for a handgun license; making certain exception for medical
14	marijuana patient licensees; prohibiting certain denial; updating statutory language; and providing an
15	effective date.

18	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
19	SECTION 1. AMENDATORY 21 O.S. 2021, Section 1289.9, is
20	amended to read as follows:
21	Section 1289.9.
22	CARRYING WEAPONS UNDER INFLUENCE OF ALCOHOL
23	It shall be unlawful for any person to carry or use shotguns,
24	rifles, or pistols in any circumstances while under the influence of

1 beer, intoxicating liquors or any hallucinogenic, or any unlawful or unprescribed drug, and it shall be unlawful for any person to carry 2 or use shotguns, rifles, or pistols when under the influence of any 3 drug prescribed by a licensed physician or medical marijuana 4 5 obtained pursuant to a valid medical marijuana patient license if the current effects or aftereffects of such consumption affect 6 mental, emotional or physical processes to a degree that would 7 result in abnormal behavior. Any person convicted of a violation of 8 9 the provisions of this section shall be punished as provided in Section 1289.15 of this title. 10

Any person convicted of a violation of the provisions of this section after having been issued a handgun license pursuant to the provisions of the Oklahoma Self-Defense Act shall have the license suspended for a term of six (6) months and shall be subject to an administrative fine of Fifty Dollars (\$50.00), upon a hearing and determination by the Oklahoma State Bureau of Investigation that the person is in violation of the provisions of this section.

18 SECTION 2. AMENDATORY 21 O.S. 2021, Section 1290.11, is

OTHER PRECLUSIONS

A. The following conditions shall preclude a person from beingeligible for a handgun license pursuant to the provisions of the

Oklahoma Self-Defense Act for a period of time as prescribed in each
 of the following paragraphs:

1. An arrest for an alleged commission of a felony offense or a
felony charge pending in this state, another state or pursuant to
the United States Code. The preclusive period shall be until the
final determination of the matter;

7 2. The person is subject to the provisions of a deferred
8 sentence or deferred prosecution in this state or another state or
9 pursuant to federal authority for the commission of a felony
10 offense. The preclusive period shall be three (3) years and shall
11 begin upon the final determination of the matter;

12 3. Any involuntary commitment for a mental illness, condition, or disorder pursuant to the provisions of Section 5-410 of Title 43A 13 of the Oklahoma Statutes or any involuntary commitment in another 14 state pursuant to any provisions of law of that state. 15 The preclusive period shall be permanent as provided by Title 18 of the 16 United States Code Section 922(q)(4) unless the person has been 17 granted relief from the disqualifying disability pursuant to Section 18 1290.27 of this title; 19

4. The person has previously undergone treatment for a mental
illness, condition, or disorder which required medication or
supervision as defined by paragraph 7 of Section 1290.10 of this
title. The preclusive period shall be three (3) years from the last
date of treatment or upon presentation of a certified statement from

a licensed physician stating that the person is either no longer
 disabled by any mental or psychiatric illness, condition, or
 disorder or that the person has been stabilized on medication for
 ten (10) years or more;

5 5. Inpatient treatment for substance abuse. The preclusive 6 period shall be three (3) years from the last date of treatment or 7 upon presentation of a certified statement from a licensed physician 8 stating that the person has been free from substance use for twelve 9 (12) months or more preceding the filing of an application for a 10 handgun license;

Two or more convictions of public intoxication pursuant to 11 6. subsection D of Section 6-101 of Title 37A of the Oklahoma Statutes, 12 or a similar law of another state. The preclusive period shall be 13 three (3) years from the date of the completion of the last sentence 14 or shall require a certified statement from a licensed physician 15 stating that the person is not in need of substance abuse treatment; 16 7. Two or more misdemeanor convictions relating to intoxication 17

18 or driving under the influence of an intoxicating substance or 19 alcohol. The preclusive period shall be three (3) years from the 20 date of the completion of the last sentence or shall require a 21 certified statement from a licensed physician stating that the 22 person is not in need of substance abuse treatment;

8. A court order for a final Victim Protection Order protective
order against the applicant, as authorized by the Protection from

Domestic Abuse Act, or any court order granting a final victim
protection protective order against the applicant from another
state. The preclusive period shall be sixty (60) days from the date
an order was vacated, canceled, withdrawn or is otherwise no longer
in effect;

9. An adjudicated delinquent or convicted felon residing in the
residence of the applicant which may be a violation of Section 1283
of this title. The preclusive period shall be thirty (30) days from
the date the person no longer resides in the same residence as the
applicant;

10. An arrest for an alleged commission of, a charge pending 12 for, or the person is subject to the provisions of a deferred 13 prosecution for any one or more of the following misdemeanor 14 offenses in this state or another state:

- a. any assault and battery which caused serious physical
 injury to the victim or any second or subsequent
 assault and battery,
- 18 b. any aggravated assault and battery,
- c. any stalking pursuant to Section 1173 of this title,
 or a similar law of another state,
- d. any violation of the Protection from Domestic Abuse
 Act or any violation of a victim protection protective
 order of another state,
- 24

1 any violation relating to illegal drug use or e. 2 possession except for an applicant or licensee in legal possession of a medical marijuana patient 3 4 license, or 5 f. an act of domestic abuse as defined by Section 644 of this title or an act of domestic assault and battery 6 or any comparable acts under the law of another state. 7 The preclusive period shall be until the final determination of the 8 9 matter. The preclusive period for a person subject to the provisions of a deferred sentence for the offenses mentioned in this 10 paragraph shall be three (3) years and shall begin upon the final 11 determination of the matter; or 12 11. A previously issued handgun license has been revoked. The 13 preclusive period shall be five (5) years from the date of 14 revocation and shall require the person to submit a new application 15 for a handgun license pursuant to the provisions of Section 1290.12 16 of this title. 17 Nothing in this section shall be construed to require a full 18 Β.

19 investigation of the applicant by the Oklahoma State Bureau of 20 Investigation.

21 <u>C. Nothing in this section shall be construed to allow the</u>
22 <u>Oklahoma State Bureau of Investigation to deny an otherwise</u>
23 <u>qualified applicant from obtaining a handgun license pursuant to the</u>

2	a lawful holder of a medical marijuana patient license.
