c. all improvements on leased lands that do not become a part of the realty;

5 3. The dormant, and other stock of nurserymen, including all trees, shrubs and plants that have been dug and placed in bins or 6 7 storage, and are ready for sale. The trees, shrubs or plants of a nurseryman shall be "growing crops" within the meaning of Section 6 8 9 of Article X of the Oklahoma Constitution and exempt from ad valorem 10 taxation, if such trees, shrubs or plants are grown upon the 11 premises of the nurseryman, removed from the earth on such premises 12 prior to any preparation for resale, and if such trees, shrubs or plants are held for resale in a manner that will permit the 13 continued growth or development of the tree, shrub or plant; 14

15 4. All horses, cattle, mules, asses, sheep, swine, goats and other livestock including poultry, and commercially raised livestock 16 including but not limited to animals of the families bovidae, 17 cervidae and antilocapridae or birds of the ratite group. Such 18 livestock or poultry having a speculative value, by reason of the 19 fact that the same is subject to registration in some recognized 20 association, shall be assessed on the market value as though the 21 same had no speculative value; 22

5. All household furniture, including gold and silver plate,
musical instruments, watches and jewelry;

6. Personal, private or professional libraries;

7. All wagons, vehicles or carriages and all farm tractors,
implements or machinery appertaining to agricultural labor; and all
types of motors, feed grinders, pumps for irrigation and other

All machinery and materials used by manufacturers, and all 6 manufactured articles, including all machinery and equipment of 7 cotton gins, cottonseed oil mills, newspaper and printing plants, 8 9 refineries, gasoline plants, flour and grain mills and elevators, 10 bakeries, ice plants, laundries, automobile assembly plants, repair 11 shops, breweries, radio broadcasting stations, tractors, graders, 12 road machinery and equipment, and all other similar or related plants or industries; 13

9. All goods and capital employed in merchandising, wares, and merchandise, including oil, gas, and petroleum products severed from the realty;
