

HOUSE AMENDMENTS TO HOUSE BILL 2442

- 1 On page 1 of the printed bill, line 4, after “456.571,” insert “456.572.”
- 2 In line 5, delete “458.505.”
- 3 On page 7, delete line 14 and insert:
- 4 “(c) Provide policy direction and oversight to the department regarding the department’s finan-
- 5 cial planning and biennial budget proposal prior to its submittal to the Oregon Department of Ad-
- 6 ministrative Services; and”.
- 7 In line 15, delete “(c)” and insert “(d)”.
- 8 In line 17, delete “department” and insert “Housing and Community Services Department”.
- 9 On page 9, line 29, after the period insert “In appointing members, the Governor shall seek to
- 10 appoint persons from all geographic regions of the state and with expertise in housing programs and
- 11 related services to persons experiencing poverty.”.
- 12 In line 42, after the period delete the rest of the line and line 43.
- 13 On page 10, line 1, after “to” insert a colon and delete the rest of the line and line 2 and insert:
- 14 “(a) Aid in stimulating and increasing the supply of housing for persons and families of lower
- 15 income;
- 16 “(b) Address geographic and racial disparities; and
- 17 “(c) Ensure funds distributed by the Housing and Community Services Department contribute
- 18 to addressing other state priorities.”.
- 19 In lines 6 and 7, delete the boldfaced material.
- 20 In line 37, after “council” insert “, in conjunction with the Community Action Partnership of
- 21 Oregon,”.
- 22 In line 39, after “council” insert “, in conjunction with the Community Action Partnership of
- 23 Oregon,”.
- 24 On page 15, delete lines 29 through 45 and delete page 16.
- 25 On page 17, delete lines 1 through 21 and insert:
- 26 “**SECTION 16.** ORS 456.572 is amended to read:
- 27 “456.572. (1) The Housing and Community Services Department shall develop a comprehensive
- 28 state plan for responding to the needs of very low income, low income and moderate income
- 29 Oregonians for housing and services, with the goal of providing affordable housing. The [*Housing*
- 30 *and Community Services*] department shall [*insure*] **ensure** that the development, annual updating
- 31 and implementation of [*this*] **the state housing** plan involve substantial interagency coordination
- 32 among appropriate federal, state and local entities. **The department shall provide the Oregon**
- 33 **Housing Stability Council with adequate opportunity to review and provide input on the state**
- 34 **housing plan to the department prior to the development, annual updating and implementa-**
- 35 **tion of the state housing plan.**

1 “(2) The state housing plan shall contain, at a minimum:

2 “(a) Information on market and inventory conditions including, but not limited to, population

3 trends, household composition, housing conditions and an inventory of assisted housing and public

4 housing;

5 “(b) A needs assessment that summarizes data on the housing needs of homeless and income-

6 eligible families and includes a five-year projection;

7 “(c) Strategies for a five-year period based upon a review of need and conditions including, but

8 not limited to, investment priorities, local and state policies, local institutional structure and local

9 activities for public housing resident management and ownership;

10 “(d) A review of resources including, but not limited to, private, federal and nonfederal re-

11 sources, tax credits and a summary table of anticipated funding from each federal program and any

12 state or local resources available to meet matching requirements;

13 “(e) A plan for coordination of resources reviewed under paragraph (d) of this subsection; and

14 “(f) An implementation program translating the five-year strategy and resource review into plans

15 and goals for the number of families to be assisted each year, specifying plans for homeless assist-

16 ance and setting forth details on monitoring, fair housing and relocation.

17 “(3) Before issuing the state housing plan, and before each annual update of that plan, the

18 Housing and Community Services Department shall hold at least one public hearing to receive

19 comments from public and private interests.”.

20 On page 18, line 13, after “Council” insert “, in conjunction with the Community Action Part-

21 nership of Oregon,”.

22 On page 19, line 31, after the second “Services” insert a comma and delete “and”.

23 In line 32, after “Council” insert “and the Community Action Partnership of Oregon”.

24 On page 20, delete line 24 and insert:

25 “(d) Oregon will strive to rank among the top states in the nation in providing food security

26 without hunger.”.

27 In line 35, delete the second “and”.

28 In line 36, delete the period and restore “; and”.

29 After line 38, insert:

30 “(g) The Hunger Task Force.”.

31 In line 40, delete “Relief” and restore “in the”.

32 In line 41, before the period insert “Department of Human Services”.

33 On page 21, after line 36, insert:

34 “(5) The Director of Human Services shall provide for the payment of appropriate task force

35 operating expenses, including but not limited to staff support, based upon the availability of

36 legislatively approved funding for such purposes.”.

37 In line 38, delete “Relief”.

38 On page 22, line 5, after “(5)” delete the rest of the line and line 6 and insert “Make recom-

39 mendations and proposals that the task force deems appropriate to the agencies and entities with

40 member representatives on the task force. The”.

41 In line 12, after the period insert “After the recommendations and proposals have been reviewed

42 and approved by the member representatives of the task force, the task force shall submit the rec-

43 ommendations and proposals to the Governor, the Legislative Assembly and others as deemed ap-

44 propriate by the task force.”.

45 On page 45, delete lines 6 through 13 and insert:
