AN ACT to amend Tennessee Code Annotated, Section 10-7-504; Section 33-6-413; Section 38-8-116; Section 39-16-702; Title 39, Chapter 17, Part 13 and Section 70-2-104, relative to handguns.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 39-17-1366, is amended by deleting the section.

SECTION 2. Tennessee Code Annotated, Section 39-17-1351, is amended by adding the following as a new subsection:

(z)

- (1) A person who holds a concealed handgun carry permit pursuant to § 39-17-1366 that is active on June 30, 2023, may apply to the department to convert the person's concealed handgun carry permit to an enhanced handgun carry permit.
- (2) In order to be eligible to convert a concealed handgun carry permit to an enhanced handgun carry permit, a person must provide proof of completion of the training requirements in subsection (e).
- (3) An enhanced handgun carry permit issued pursuant to this subsection (z) is active until the expiration date issued on the person's concealed handgun carry permit held on June 30, 2023.

SECTION 17. Tennessee Code Annotated, Section 39-17-1313(a), is amended by deleting "or concealed handgun carry permit".

SECTION 18. Tennessee Code Annotated, Section 70-2-104(g)(3)(B), is amended by deleting ", a concealed handgun carry permit,".

SECTION 19. This act takes effect July 1, 2023, the public welfare requiring it.
