#### A BILL

To direct the Under Secretary for Intelligence and Analysis of the Department of Homeland Security to develop and disseminate a threat assessment regarding terrorist use of ghost guns, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Homeland Security
- 5 Assessment of Terrorists Use of Ghost Guns Act".
- 6 SEC. 2. THREAT ASSESSMENT ON TERRORIST USE OF
- 7 GHOST GUNS.
- 8 (a) IN GENERAL.—The Under Secretary for Intel-
- 9 ligence and Analysis of the Department of Homeland Se-
- 10 curity shall, in coordination with appropriate Federal
- 11 partners, annually develop and disseminate a terrorism
- 12 threat assessment regarding the availability of ghost guns
- 13 in furtherance of an act of terrorism, including the provi-
- 14 sion of material support or resources to a foreign terrorist
- 15 organization. Consistent with the protection of classified
- 16 and confidential unclassified information, the Under Sec-
- 17 retary shall share the threat assessment developed under
- 18 this section with State, local, and Tribal law enforcement
- 19 officials, including officials who operate within State, local,
- 20 and regional fusion centers through the Department of
- 21 Homeland Security State, Local, and Regional Fusion
- 22 Center Initiative established in accordance with section
- 23 210A of the Homeland Security Act of 2002 (6 U.S.C.
- 24 124h).
- 25 (b) Definitions.—In this section:

- (1) Foreign terrorist organization.—The term "foreign terrorist organization" means an organization designated as a foreign terrorist organization under section 219 of the Immigration and Nationality Act (8 U.S.C. 1189).
  - (2) GHOST GUN.—The term "ghost gun" means a firearm, including a frame or receiver, that lacks a unique serial number engraved or cast in metal, metal alloy, or plastic on the frame or receiver by a licensed manufacturer or importer, or is otherwise assembled, molded, machined, or 3D printed without being associated with a unique serial number.
  - (3) Frame or receiver or receiver" means the part of a firearm that can provide the action or housing for the hammer, bolt, or breechblock and firing mechanism, and includes a frame or lower receiver blank, casting, or machined body that requires further machining or molding to be used as part of a firearm, and which is designed or intended to be used in the assembly of a functional firearm.
