## A BILL

To establish competitive grant programs to incentivize the safe and responsible storage of firearms, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Responsible Ownership  
5 of Firearms Act of 2020”.

6 **SEC. 2. SENSE OF CONGRESS.**

7 It is the sense of Congress that—

8 (1) since 1999, more than 15,000 law enforce-  
9 ment agencies have partnered with nonprofit organi-  
10 zations to distribute more than 38 million firearm

1 safety education kits, which include firearm locking  
2 devices and informational materials, to firearm own-  
3 ers in all 50 States and 5 U.S. territories;

4 (2) in addition to providing for the secure stor-  
5 age of countless firearms, these actions have raised  
6 awareness about safe and responsible firearm owner-  
7 ship and the importance of storing firearms securely  
8 when not in use, which has proven effective in pre-  
9 venting unauthorized access to firearms thereby re-  
10 ducing and preventing accidents, theft, and misuse,  
11 including suicide; and

12 (3) Federal investment in enhancing and ex-  
13 panding these efforts is critical to educating a  
14 broader proportion of the public while keeping oper-  
15 able firearms out of the hands of those who cannot  
16 be trusted to use them responsibly.

17 **SEC. 3. ESTABLISHMENT OF COMPETITIVE GRANT PRO-**  
18 **GRAM.**

19 (a) **PURPOSE.**—The purpose of this program is to re-  
20 duce the rates of accidental death, theft, criminal misuse,  
21 and suicide through the safe and responsible storage of  
22 firearms when not in use.

23 (b) **ESTABLISHMENT.**—The Attorney General,  
24 through the Bureau of Justice Assistance of the Office  
25 of Justice Programs of the Department of Justice shall

1 establish a competitive grant program to make funds  
2 available to nonprofit organizations to purchase firearm  
3 safety education kits for distribution to the public.

4 (c) ACTIVITIES.—In carrying out this section, the Di-  
5 rector of the Bureau of Justice Assistance shall make  
6 available grants to nonprofit organizations to partner with  
7 local, State, or tribal law enforcement agencies to:

8 (1) purchase and distribute firearm locking de-  
9 vices to firearm owners; and

10 (2) develop and distribute educational materials  
11 on safe and responsible gun ownership, safe firearm  
12 storage and firearm safety in general.

13 The educational materials shall not include information in-  
14 tended to prevent, preclude, or dissuade the legal use, pos-  
15 session, or ownership of firearms.

16 (d) ELIGIBLE ENTITIES.—

17 (1) An entity eligible to receive funding under  
18 this section shall be—

19 (A) a nonprofit organization; and

20 (B) identified as having the technical and  
21 logistical experience, and financial capabilities  
22 needed to carry out activities under subsection  
23 (c).

24 (2) The Attorney General, through the Depart-  
25 ment of Justice Office of Justice Programs, shall

1       prioritize for receipt of a grant under this Act eligi-  
2       ble entities that have a history of effectively partici-  
3       pating in activities set forth in subsection (c).

4       (e) AUTHORIZATION OF APPROPRIATIONS.—There is  
5       authorized to be appropriated to carry out this section  
6       \$50,000,000, to be available until expended.

7       **SEC. 4. RULE OF CONSTRUCTION.**

8       Nothing in this Act, or any amendment made by this  
9       Act, shall be construed to—

10           (1) authorize the establishment, directly or indi-  
11           rectly, of a national firearms registry; or

12           (2) promote or require mandatory firearm stor-  
13           age requirements.
