# A BILL

# 17 SEC. 7. SENSE OF THE CONGRESS.

- 18 (a) FINDINGS.—The Congress finds as follows:
- 19 (1) The Elementary and Secondary Education 20 Act prohibits the Federal Government from man-21 dating, directing, or controlling a State, local edu-22 cational agency, or school's curriculum, program of 23 instruction, or allocation of State and local re-24 sources, and from mandating a State or any subdivi-

- sion thereof to spend any funds or incur any costsnot paid for under such Act.
  - (2) The Elementary and Secondary Education Act prohibits the Federal Government from funding the development, pilot testing, field testing, implementation, administration, or distribution of any federally sponsored national test in reading, mathematics, or any other subject, unless specifically and explicitly authorized by law.
    - (3) The Secretary of Education, through 3 separate initiatives, has created a system of waivers and grants that influence, incentivize, and coerce State educational agencies into implementing common national elementary and secondary standards and assessments endorsed by the Secretary.
    - (4) The Race to the Top Fund encouraged and incentivized States to adopt Common Core State Standards developed by the National Governor's Association Center for Best Practices and the Council of Chief State School Officers.
    - (5) The Race to the Top Assessment grants awarded to the Partnership for the Assessment of Readiness for College and Careers (PARCC) and SMARTER Balanced Assessment Consortium (SMARTER Balance) initiated the development of

1	Common Core State Standards aligned assessments
2	that will, in turn, inform and ultimately influence
3	kindergarten through 12th-grade curriculum and in-
4	structional materials.
5	(6) The conditional Elementary and Secondary
6	Education Act flexibility waiver authority employed
7	by the Department of Education coerced States into
8	accepting Common Core State Standards and
9	aligned assessments.
10	(b) Sense of the Congress.—It is the sense of
11	the Congress that States and local educational agencies
12	should maintain the rights and responsibilities of deter-
13	mining educational curriculum, programs of instruction,
14	and assessments for elementary and secondary education.

- 11 delinquent, migrant students, English learners, at-risk
- 12 students, and Native Americans, to increase academic
- 13 achievement of such students.
- 14 "(d) LOCAL USE OF FUNDS.—A local educational
- 15 agency receiving an award under this section—
- "(1) shall use up to 1 percent of each award for
- outreach and communication to parents about their
- options and to register students for direct student
- 19 services;
- 20 "(2) may use not more than 2 percent of each
- award for administrative costs related to direct stu-
- dent services; and
- "(3) shall use the remainder of the award to
- 24 pay the transportation required to provide public
- school choice or the hourly rate for high-quality aca-

- "(B) Reallocation.—The Secretary shall reallocate such excess funds to other States whose grants under this subpart would otherwise be insufficient to provide an appropriate level of services to migratory children, in such amounts as the Secretary determines are appropriate.

# "(e) Consortium Arrangements.—

"(1) IN GENERAL.—In the case of a State that receives a grant of \$1,000,000 or less under this section, the Secretary shall consult with the State educational agency to determine whether consortium arrangements with another State or other appro-

2	more accurately reflecting cost factors for different
3	types of summer and intersession program designs;
4	"(4) adjust the full-time equivalent number of
5	migratory children who reside in each State to take
6	into account—
7	"(A) the unique needs of those children
8	participating in evidence-based or other effec-
9	tive special programs provided under this sub-
10	part that operate during the summer and inter-
11	session periods; and
12	"(B) the additional costs of operating such
13	programs; and
14	"(5) conduct an analysis of the options for ad-
15	justing the formula so as to better direct services to
16	migratory children, including the most at-risk migra-
17	tory children.
18	"(g) Nonparticipating States.—In the case of a
19	State desiring to receive an allocation under this subpart
20	for a fiscal year that did not receive an allocation for the
21	previous fiscal year or that has been participating for less
22	than 3 consecutive years, the Secretary shall calculate the
23	State's number of identified migratory children aged 3
24	through 21 for purposes of subsection (a)(1)(A) by using
25	the most recent data available that identifies the migra-

1	tory children residing in the State until data is available
2	to calculate the 3-year average number of such children
3	in accordance with such subsection.
4	"SEC. 1134. STATE APPLICATIONS; SERVICES.
5	"(a) Application Required.—Any State desiring
6	to receive a grant under this subpart for any fiscal year
7	shall submit an application to the Secretary at such time
8	and in such manner as the Secretary may require.
9	"(b) Program Information.—Each such applica-
10	tion shall include—

17	school to another, whether or not such a move oc-

19	"(4) a description of the State's priorities for
20	the use of funds received under this subpart, and
21	how such priorities relate to the State's assessment
22	of needs for services in the State;
23	"(5) a description of how the State will deter-
24	mine the amount of any subgrants the State will
25	award to local operating agencies, taking into ac-

1	count the numbers and needs of migratory children,

3	ability of funds from other Federal, State, and local
4	programs; and
5	"(6) a description of how the State will encour-
6	age programs and projects assisted under this sub-
7	part to offer family literacy services if the programs
8	and projects serve a substantial number of migra-
9	tory children whose parents do not have a regular
10	high school diploma or its recognized equivalent or
11	who have low levels of literacy.
12	"(c) Assurances.—Each such application shall also

- "(2) Unaddressed Needs.—Funds provided under this subpart shall be used to address the needs of migratory children that are not addressed by services available from other Federal or non-Federal programs, except that migratory children who are eligible to receive services under subpart 1 may receive those services through funds provided under that subpart, or through funds under this subpart that remain after the agency addresses the needs described in paragraph (1).
- "(3) Construction.—Nothing in this subpart shall be construed to prohibit a local educational agency from serving migratory children simultaneously with students with similar educational needs in the same educational settings, where appropriate.

  - "(8) includes an assurance that the State agency has provided for appropriate training for teachers and other instructional and administrative personnel to enable such teachers and personnel to carry out the project effectively.

18	"(ii) work with the authorized public
19	chartering agencies involved to avoid dupli-
20	cation of work for the charter schools and
21	authorized public chartering agencies; and
22	"(iii) provide adequate technical as-
23	sistance and support for—

1	"(I) the charter schools receiving
2	funds under the State entity's pro-
3	gram; and
4	"(II) quality authorizing efforts
5	in the State; and
6	"(F) the State entity's plan to solicit and
7	consider input from parents and other members
8	of the community on the implementation and
9	operation of the charter schools in the State.
10	"(2) Priority.—In awarding grants under this
11	section, the Secretary shall give priority to State en-
12	tities to the extent that they meet the following cri-
13	teria:
14	"(A) In the case of a State entity located
15	in a State that allows an entity other than a
16	local educational agency to be an authorized
17	public chartering agency, the State has a qual-
18	ity authorized public chartering agency that is
19	an entity other than a local educational agency.
20	"(B) The State entity is located in a State
21	that does not impose any limitation on the
22	number or percentage of charter schools that
23	may exist or the number or percentage of stu-
24	dents that may attend charter schools in the
25	State.

1	"(C) The State entity is located in a State
2	that ensures equitable financing, as compared
3	to traditional public schools, for charter schools
4	and students in a prompt manner.
5	"(D) The State entity is located in a State
6	that uses charter schools and best practices
7	from charter schools to help improve struggling
8	schools and local educational agencies.
9	"(E) The State entity partners with an or-
10	ganization that has a demonstrated record of
11	success in developing management organiza-
12	tions to support the development of charter
13	schools in the State.
14	"(F) The State entity supports charter
15	schools that support at-risk students through
16	activities such as dropout prevention, dropout
17	recovery, or comprehensive career counseling
18	practices.
19	"(G) The State entity authorizes all char-
20	ter schools in the State to serve as school food
21	authorities.
22	"(H) The State entity has taken steps to
23	ensure that all authorizing public chartering
24	agencies implement best practices for charter

25

school authorizing.

1	"(g) Local Uses of Funds.—An eligible applicant
2	receiving a subgrant under this section shall use such
3	funds to carry out activities related to opening and pre-
4	paring to operate a new charter school, a replicated, high-
5	quality charter school model, or an expanded, high-quality
6	charter school, such as—
7	"(1) preparing teachers and school leaders, in-
8	cluding through professional development;
9	"(2) acquiring equipment, educational mate-
10	rials, and supplies; and
11	"(3) carrying out necessary renovations and
12	minor facilities repairs (excluding construction).
13	"(h) REPORTING REQUIREMENTS.—Each State enti-
14	ty receiving a grant under this section shall submit to the
15	Secretary, at the end of the third year of the 5-year grant
16	period and at the end of such grant period, a report on—
17	"(1) the number of students served by each
18	subgrant awarded under this section and, if applica-
19	ble, how many new students were served during each
20	year of the subgrant period;
21	"(2) the progress the State entity made toward
22	meeting the priorities described in subsection $(f)(2)$ ,
23	as applicable;
24	"(3) how the State entity met the objectives of
25	the quality charter school program described in the

1	State entity's application under subsection (e), in-
2	cluding how the State entity met the objective of
3	sharing best and promising practices described in
4	subsection $(e)(1)(A)(x)$ in areas such as instruction,
5	professional development, curricula development, and
6	operations between charter schools and other public
7	schools, and the extent to which, if known, such
8	practices were adopted and implemented by such
9	other public schools;
10	"(4) how the State entity complied with, and
11	ensured that eligible applicants complied with, the
12	assurances described in the State entity's applica-
13	tion;
14	"(5) how the State entity worked with author-
15	ized public chartering agencies, including how the
16	agencies worked with the management company or
17	leadership of the schools that received subgrants
18	under this section;
19	"(6) the number of subgrants awarded under
20	this section to carry out each of the following:
21	"(A) the opening of new charter schools;
22	"(B) the opening of replicated, high-quality
23	charter school models; and
24	"(C) the opening of expanded, high-quality
25	charter schools; and

1	"(7) how the State entity has worked with char-
2	ter schools receiving funds under the State entity's
3	program to foster community involvement in the
4	planning for and opening of such schools.
5	"(i) STATE ENTITY DEFINED.—For purposes of this
6	section, the term 'State entity' means—
7	"(1) a State educational agency;
8	"(2) a State charter school board;
9	"(3) a Governor of a State; or
10	"(4) a charter school support organization.
11	"SEC. 3104. FACILITIES FINANCING ASSISTANCE.
12	"(a) Grants to Eligible Entities.—
13	"(1) IN GENERAL.—From the amount reserved
14	under section 3102(b)(1), the Secretary shall not
15	use less than 50 percent to award grants to eligible
16	entities that have the highest-quality applications
17	approved under subsection (d), after considering the
18	diversity of such applications, to demonstrate inno-
19	vative methods of assisting charter schools to ad-
20	dress the cost of acquiring, constructing, and ren-
21	ovating facilities by enhancing the availability of
22	loans or bond financing.
23	"(2) Eligible entity defined.—For pur-
24	poses of this section, the term 'eligible entity'
25	means—

1	"(A) a public entity, such as a State or
2	local governmental entity;
3	"(B) a private nonprofit entity; or
4	"(C) a consortium of entities described in
5	subparagraphs (A) and (B).
6	"(b) Grantee Selection.—The Secretary shall
7	evaluate each application submitted under subsection (d),
8	and shall determine whether the application is sufficient
9	to merit approval.
10	"(c) Grant Characteristics.—Grants under sub-
11	section (a) shall be of a sufficient size, scope, and quality
12	so as to ensure an effective demonstration of an innovative
13	means of enhancing credit for the financing of charter
14	school acquisition, construction, or renovation.
15	"(d) Applications.—
16	"(1) In general.—To receive a grant under
17	subsection (a), an eligible entity shall submit to the
18	Secretary an application in such form as the Sec-
19	retary may reasonably require.
20	"(2) Contents.—An application submitted
21	under paragraph (1) shall contain—
22	"(A) a statement identifying the activities
23	proposed to be undertaken with funds received
24	under subsection (a), including how the eligible
25	entity will determine which charter schools will

1	receive assistance, and how much and what
2	types of assistance charter schools will receive;
3	"(B) a description of the involvement of
4	charter schools in the application's development
5	and the design of the proposed activities;
6	"(C) a description of the eligible entity's
7	expertise in capital market financing;
8	"(D) a description of how the proposed ac-
9	tivities will leverage the maximum amount of
10	private-sector financing capital relative to the
11	amount of public funding used and otherwise
12	enhance credit available to charter schools, in-
13	cluding how the eligible entity will offer a com-
14	bination of rates and terms more favorable than
15	the rates and terms that a charter school could
16	receive without assistance from the eligible enti-
17	ty under subsection (a);
18	"(E) a description of how the eligible enti-
19	ty possesses sufficient expertise in education to
20	evaluate the likelihood of success of a charter
21	school program for which facilities financing is
22	sought; and
23	"(F) in the case of an application sub-
24	mitted by a State governmental entity, a de-
25	scription of the actions that the entity has

1	taken, or will take, to ensure that charter
2	schools within the State receive the funding the
3	charter schools need to have adequate facilities.
4	"(e) Charter School Objectives.—An eligible
5	entity receiving a grant under subsection (a) shall use the
6	funds deposited in the reserve account established under
7	subsection (f) to assist one or more charter schools to ac-
8	cess private sector capital to accomplish one or more of
9	the following objectives:
10	"(1) The acquisition (by purchase, lease, dona-
11	tion, or otherwise) of an interest (including an inter-
12	est held by a third party for the benefit of a charter
13	school) in improved or unimproved real property
14	that is necessary to commence or continue the oper-
15	ation of a charter school.
16	"(2) The construction of new facilities, or the
17	renovation, repair, or alteration of existing facilities,
18	necessary to commence or continue the operation of
19	a charter school.
20	"(3) The predevelopment costs required to as-
21	sess sites for purposes of paragraph (1) or (2) and
22	which are necessary to commence or continue the
23	operation of a charter school.

24 "(f) Reserve Account.—

"(1) USE OF FUNDS.—To assist charter schools to accomplish the objectives described in subsection (e), an eligible entity receiving a grant under subsection (a) shall, in accordance with State and local law, directly or indirectly, alone or in collaboration with others, deposit the funds received under subsection (a) (other than funds used for administrative costs in accordance with subsection (g)) in a reserve account established and maintained by the eligible entity for this purpose. Amounts deposited in such account shall be used by the eligible entity for one or more of the following purposes:

- "(A) Guaranteeing, insuring, and reinsuring bonds, notes, evidences of debt, loans, and interests therein, the proceeds of which are used for an objective described in subsection (e).
- "(B) Guaranteeing and insuring leases of personal and real property for an objective described in subsection (e).
- "(C) Facilitating financing by identifying potential lending sources, encouraging private lending, and other similar activities that directly promote lending to, or for the benefit of, charter schools.

"(D) Facilitating the issuance of bonds by charter schools, or by other public entities for the benefit of charter schools, by providing technical, administrative, and other appropriate assistance (including the recruitment of bond counsel, underwriters, and potential investors and the consolidation of multiple charter school projects within a single bond issue).

- "(2) INVESTMENT.—Funds received under subsection (a) and deposited in the reserve account established under paragraph (1) shall be invested in obligations issued or guaranteed by the United States or a State, or in other similarly low-risk securities.
- "(3) Reinvestment of Earnings.—Any earnings on funds received under subsection (a) shall be deposited in the reserve account established under paragraph (1) and used in accordance with such paragraph.
- "(g) Limitation on Administrative Costs.—An eligible entity may use not more than 2.5 percent of the funds received under subsection (a) for the administrative costs of carrying out its responsibilities under this section (excluding subsection (k)).
- 25 "(h) Audits and Reports.—

1	"(1) Financial record maintenance and
2	AUDIT.—The financial records of each eligible entity
3	receiving a grant under subsection (a) shall be main-
4	tained in accordance with generally accepted ac-
5	counting principles and shall be subject to an annual
6	audit by an independent public accountant.
7	"(2) Reports.—
8	"(A) Grantee annual reports.—Each
9	eligible entity receiving a grant under sub-
10	section (a) annually shall submit to the Sec-
11	retary a report of its operations and activities
12	under this section (excluding subsection (k)).
13	"(B) Contents.—Each annual report
14	submitted under subparagraph (A) shall in-
15	clude—
16	"(i) a copy of the most recent finan-
17	cial statements, and any accompanying
18	opinion on such statements, prepared by
19	the independent public accountant review-
20	ing the financial records of the eligible en-
21	tity;
22	"(ii) a copy of any report made on an
23	audit of the financial records of the eligible
24	entity that was conducted under paragraph
25	(1) during the reporting period;

1	"(iii) an evaluation by the eligible en-
2	tity of the effectiveness of its use of the
3	Federal funds provided under subsection
4	(a) in leveraging private funds;
5	"(iv) a listing and description of the
6	charter schools served during the reporting
7	period, including the amount of funds used
8	by each school, the type of project facili-
9	tated by the grant, and the type of assist-
10	ance provided to the charter schools;
11	"(v) a description of the activities car-
12	ried out by the eligible entity to assist
13	charter schools in meeting the objectives
14	set forth in subsection (e); and
15	"(vi) a description of the characteris-
16	tics of lenders and other financial institu-
17	tions participating in the activities under-
18	taken by the eligible entity under this sec-
19	tion (excluding subsection (k)) during the
20	reporting period.
21	"(C) Secretarial Report.—The Sec-
22	retary shall review the reports submitted under
23	subparagraph (A) and shall provide a com-
24	prehensive annual report to Congress on the ac-

1	tivities conducted under this section (excluding
2	subsection (k)).
3	"(i) No Full Faith and Credit for Grantee
4	Obligation.—No financial obligation of an eligible entity
5	entered into pursuant to this section (such as an obliga-
6	tion under a guarantee, bond, note, evidence of debt, or
7	loan) shall be an obligation of, or guaranteed in any re-
8	spect by, the United States. The full faith and credit of
9	the United States is not pledged to the payment of funds
10	which may be required to be paid under any obligation
11	made by an eligible entity pursuant to any provision of
12	this section.
13	"(j) Recovery of Funds.—
14	"(1) In General.—The Secretary, in accord-
15	ance with chapter 37 of title 31, United States
16	Code, shall collect—
17	"(A) all of the funds in a reserve account
18	established by an eligible entity under sub-
19	section (f)(1) if the Secretary determines, not
20	earlier than 2 years after the date on which the
21	eligible entity first received funds under sub-
22	section (a), that the eligible entity has failed to
23	make substantial progress in carrying out the
24	purposes described in subsection $(f)(1)$ ; or

1	"(B) all or a portion of the funds in a re-
2	serve account established by an eligible entity
3	under subsection (f)(1) if the Secretary deter-
4	mines that the eligible entity has permanently
5	ceased to use all or a portion of the funds in
6	such account to accomplish any purpose de-
7	scribed in subsection $(f)(1)$ .
8	"(2) Exercise of Authority.—The Secretary
9	shall not exercise the authority provided in para-
10	graph (1) to collect from any eligible entity any
11	funds that are being properly used to achieve one or
12	more of the purposes described in subsection $(f)(1)$ .
13	"(3) Procedures.—The provisions of sections
14	451, 452, and 458 of the General Education Provi-
15	sions Act (20 U.S.C. 124, 1234a, 1234g) shall apply
16	to the recovery of funds under paragraph (1).
17	"(4) Construction.—This subsection shall
18	not be construed to impair or affect the authority of
19	the Secretary to recover funds under part D of the
20	General Education Provisions Act (20 U.S.C. 1234
21	et seq.).
22	"(k) Per-Pupil Facilities Aid Program.—
23	"(1) Definition of Per-Pupil facilities aid
24	PROGRAM.—In this subsection, the term 'per-pupil

facilities aid program' means a program in which a

1	State makes payments, on a per-pupil basis, to char-
2	ter schools to provide the schools with financing—
3	"(A) that is dedicated solely for funding
4	charter school facilities; or
5	"(B) a portion of which is dedicated for
6	funding charter school facilities.
7	"(2) Grants.—
8	"(A) In General.—From the amount
9	under section 3102(b)(1) remaining after the
10	Secretary makes grants under subsection (a),
11	the Secretary shall make grants, on a competi-
12	tive basis, to States to pay for the Federal
13	share of the cost of establishing or enhancing,
14	and administering per-pupil facilities aid pro-
15	grams.
16	"(B) Period.—The Secretary shall award
17	grants under this subsection for periods of not
18	more than 5 years.
19	"(C) Federal share.—The Federal
20	share of the cost described in subparagraph (A)
21	for a per-pupil facilities aid program shall be
22	not more than—
23	"(i) 90 percent of the cost, for the
24	first fiscal year for which the program re-
25	ceives assistance under this subsection:

1	"(ii) 80 percent in the second such
2	year;
3	"(iii) 60 percent in the third such
4	year;
5	"(iv) 40 percent in the fourth such
6	year; and
7	"(v) 20 percent in the fifth such year.
8	"(D) State share.—A State receiving a
9	grant under this subsection may partner with 1
10	or more organizations to provide up to 50 per-
11	cent of the State share of the cost of estab-
12	lishing or enhancing, and administering the per-
13	pupil facilities aid program.
14	"(E) Multiple grants.—A State may
15	receive more than 1 grant under this sub-
16	section, so long as the amount of such funds
17	provided to charter schools increases with each
18	successive grant.
19	"(3) Use of funds.—
20	"(A) In general.—A State that receives
21	a grant under this subsection shall use the
22	funds made available through the grant to es-
23	tablish or enhance, and administer, a per-pupil
24	facilities aid program for charter schools in the
25	State of the applicant.

1	"(B) EVALUATIONS; TECHNICAL ASSIST-
2	ANCE; DISSEMINATION.—From the amount
3	made available to a State through a grant
4	under this subsection for a fiscal year, the State
5	may reserve not more than 5 percent to carry
6	out evaluations, to provide technical assistance,
7	and to disseminate information.
8	"(C) Supplement, not supplant.—
9	Funds made available under this subsection
10	shall be used to supplement, and not supplant,
11	State and local public funds expended to pro-
12	vide per pupil facilities aid programs, oper-
13	ations financing programs, or other programs,
14	for charter schools.
15	"(4) Requirements.—
16	"(A) Voluntary participation.—No
17	State may be required to participate in a pro-
18	gram carried out under this subsection.
19	"(B) State Law.—
20	"(i) In general.—Except as pro-
21	vided in clause (ii), to be eligible to receive
22	a grant under this subsection, a State shall
23	establish or enhance, and administer, a
24	per-pupil facilities aid program for charter

schools in the State, that—

1	"(I) is specified in State law; and
2	"(II) provides annual financing
3	on a per-pupil basis, for charter
4	school facilities.
5	"(ii) Special Rule.—Notwith-
6	standing clause (i), a State that is required
7	under State law to provide its charter
8	schools with access to adequate facility
9	space, but which does not have a per-pupi
10	facilities aid program for charter schools
11	specified in State law, may be eligible to
12	receive a grant under this subsection if the
13	State agrees to use the funds to develop a
14	per-pupil facilities aid program consistent
15	with the requirements of this subsection.
16	"(5) Applications.—To be eligible to receive a
17	grant under this subsection, a State shall submit an
18	application to the Secretary at such time, in such
19	manner, and containing such information as the Sec-
20	retary may require.
21	"SEC. 3105. NATIONAL ACTIVITIES.
22	"(a) In General.—Of the amount reserved under
23	section 3102(b)(2), the Secretary shall—

1	"(1) use not less than 75 percent of such
2	amount to award grants in accordance with sub-
3	section (b); and
4	"(2) use not more than 25 percent of such
5	amount to—
6	"(A) provide technical assistance to State
7	entities in awarding subgrants under section
8	3103, and eligible entities and States receiving
9	grants under section 3104;
10	"(B) disseminate best practices; and
11	"(C) evaluate the impact of the charter
12	school program, including the impact on stu-
13	dent achievement, carried out under this sub-
14	part.
15	"(b) Grants.—
16	"(1) IN GENERAL.—The Secretary shall make
17	grants, on a competitive basis, to eligible applicants
18	for the purpose of carrying out the activities de-
19	scribed in section 3102(a)(1), subparagraphs (A)
20	through (C) of section 3103(a)(1), and section
21	3103(g).
22	"(2) Terms and conditions.—Except as oth-
23	erwise provided in this subsection, grants awarded
24	under this subsection shall have the same terms and

1	conditions as grants awarded to State entities under
2	section 3103.
3	"(3) Charter management organiza-
4	TIONS.—The Secretary shall—
5	"(A) of the amount described in subsection
6	(a)(1), use not less than 75 percent to make
7	grants, on a competitive basis, to eligible appli-
8	cants described in paragraph (4)(B); and
9	"(B) notwithstanding paragraphs (1)(A)
10	and (2) of section 3103(f)—
11	"(i) award grants to eligible appli-
12	cants on the basis of the quality of the ap-
13	plications submitted under this subsection;
14	and
15	"(ii) in awarding grants to eligible ap-
16	plicants described in paragraph (4)(B) of
17	this subsection, take into consideration
18	whether such an eligible applicant—
19	"(I) demonstrates a high propor-
20	tion of high-quality charter schools
21	within the network of the eligible ap-
22	plicant;
23	"(II) demonstrates success in
24	serving students who are educationally
25	disadvantaged;

1	"(III) does not have a significant
2	proportion of charter schools that
3	have been closed, had their charter re-
4	voked for compliance issues, or had
5	their affiliation with such eligible ap-
6	plicant revoked;
7	"(IV) has sufficient procedures in
8	effect to ensure timely closure of low-
9	performing or financially mismanaged
10	charter schools and clear plans and
11	procedures in effect for the students
12	in such schools to attend other high-
13	quality schools; and
14	"(V) demonstrates success in
15	working with schools identified for im-
16	provement by the State.
17	"(4) Eligible applicant defined.—For pur-
18	poses of this subsection, the term 'eligible applicant'
19	means an eligible applicant (as defined in section
20	3110) that—
21	"(A) desires to open a charter school in—
22	"(i) a State that did not apply for a
23	grant under section 3103; or
24	"(ii) a State that did not receive a
25	grant under section 3103; or

1	"(B) is a charter management organiza-
2	tion.
3	"(c) Contracts and Grants.—The Secretary may
4	carry out any of the activities described in this section di-
5	rectly or through grants, contracts, or cooperative agree-
6	ments.
7	"SEC. 3106. FEDERAL FORMULA ALLOCATION DURING
8	FIRST YEAR AND FOR SUCCESSIVE ENROLL-
9	MENT EXPANSIONS.
10	"(a) In General.—For purposes of the allocation
11	to schools by the States or their agencies of funds under
12	part A of title I, and any other Federal funds which the
13	Secretary allocates to States on a formula basis, the Sec-
14	retary and each State educational agency shall take such

"(1) IN GENERAL.—The measures described in subsection (a) shall include provision for appropriate adjustments, through recovery of funds or reduction of payments for the succeeding year, in cases where payments made to a charter school on the basis of estimated or projected enrollment data exceed the amounts that the school is eligible to receive on the basis of actual or final enrollment data.

"(2) Rule.—For charter schools that first open after November 1 of any academic year, the State, in accordance with guidance provided by the Secretary and applicable Federal statutes and regulations, shall ensure that such charter schools that are eligible for the funds described in subsection (a) for such academic year have a full and fair opportunity to receive those funds during the charter schools' first year of operation.

1	"(1) Charter management organization.—

6	"(2) Charter school support organiza-
7	TION.—The term 'charter school support organiza-
8	tion' means a nonprofit, nongovernmental entity that
9	is not an authorized public chartering agency, which
10	provides on a statewide basis—
11	"(A) assistance to developers during the
12	planning, program design, and initial implemen-
13	tation of a charter school; and
14	"(B) technical assistance to charter schools
15	to operate such schools.
16	"(3) Developer.—The term 'developer' means
17	an individual or group of individuals (including a
18	public or private nonprofit organization), which may
19	include teachers, administrators and other school
20	staff, parents, or other members of the local commu-
21	nity in which a charter school project will be carried
22	out.
23	"(4) Eligible Applicant.—The term 'eligible
24	applicant' means a developer that has—

1	"(A) applied to an authorized public char-
2	tering authority to operate a charter school;
3	and
4	"(B) provided adequate and timely notice
5	to that authority.
6	"(5) Authorized public chartering agen-
7	cy.—The term 'authorized public chartering agency'
8	means a State educational agency, local educational
9	agency, or other public entity that has the authority
10	pursuant to State law and approved by the Sec-

- "(D) has demonstrated success in increasing student academic achievement, including graduation rates where applicable, for the groups of students described in section 1111(b)(3)(B)(ii)(II), except that such demonstration is not required in a case in which the number of students in a group is insufficient to yield statistically reliable information or the results would reveal personally identifiable information about an individual student.
- "(8) REPLICATED, HIGH-QUALITY CHARTER SCHOOL MODEL.—The term 'replicated, high-quality charter school model' means a high-quality charter school that has opened a new campus under an existing charter or an additional charter if required or permitted by State law.

  - "(4) To coordinate activities funded under this subpart with parent involvement initiatives funded under section 1118 and other provisions of this Act.
  - "(5) To assist the Secretary, State educational agencies, and local educational agencies in the co-

- 1 ordination and integration of Federal, State, and
- 2 local services and programs to engage families in
- 3 education.

#### 4 "SEC. 3142. GRANTS AUTHORIZED.

- 5 "(a) STATEWIDE FAMILY ENGAGEMENT CENTERS.—
- 6 From the amount appropriated under section 3(c)(1)(C),
- 7 the Secretary is authorized to award grants for each fiscal
- 8 year to statewide organizations (or consortia of such orga-
- 9 nizations), to establish Statewide Family Engagement
- 10 Centers that provide comprehensive training and technical

- 21 "SEC. 3143. APPLICATIONS.
- 22 "(a) Submissions.—Each statewide organization, or
- 23 a consortium of such organizations, that desires a grant
- 24 under this subpart shall submit an application to the Sec-

1	retary at such time, in such manner, and including the
2	information described in subsection (b).
3	"(b) Contents.—Each application submitted under
4	subsection (a) shall include, at a minimum, the following:
5	"(1) A description of the applicant's approach
6	to family engagement in education.
7	"(2) A description of the support that the
8	Statewide Family Engagement Center that will be
9	operated by the applicant will have from the State
10	educational agency and any partner organization
11	outlining the commitment to work with the center.
12	"(3) A description of the applicant's plan for
13	building a statewide infrastructure for family en-
14	gagement in education, that includes—
15	"(A) management and governance;
16	"(B) statewide leadership; or
17	"(C) systemic services for family engage-
18	ment in education.
19	"(4) A description of the applicant's dem-
20	onstrated experience in providing training, informa-
21	tion, and support to State educational agencies, local
22	educational agencies, schools, educators, parents,
23	and organizations on family engagement in edu-
24	cation policies and practices that are effective for
25	parents (including low-income parents) and families,

1	English learners, minorities, parents of students
2	with disabilities, parents of homeless students, foster
3	parents and students, and parents of migratory stu-
4	dents, including evaluation results, reporting, or
5	other data exhibiting such demonstrated experience.
6	"(5) A description of the steps the applicant
7	will take to target services to low-income students
8	and parents.
9	"(6) An assurance that the applicant will—
10	"(A) establish a special advisory com-
11	mittee, the membership of which includes—
12	"(i) parents, who shall constitute a
13	majority of the members of the special ad-
14	visory committee;
15	"(ii) representatives of education pro-
16	fessionals with expertise in improving serv-
17	ices for disadvantaged children;
18	"(iii) representatives of local elemen-
19	tary schools and secondary schools, includ-
20	ing students;
21	"(iv) representatives of the business
22	community; and
23	"(v) representatives of State edu-
24	cational agencies and local educational
25	agencies;

1	"(B) use not less than 65 percent of the
2	funds received under this subpart in each fiscal
3	year to serve local educational agencies, schools,
4	and community-based organizations that serve
5	high concentrations of disadvantaged students,
6	including English learners, minorities, parents
7	of students with disabilities, parents of home-
8	less students, foster parents and students, and
9	parents of migratory students;
10	"(C) operate a Statewide Family Engage-
11	ment Center of sufficient size, scope, and qual-
12	ity to ensure that the Center is adequate to
13	serve the State educational agency, local edu-
14	cational agencies, and community-based organi-
15	zations;
16	"(D) ensure that the Center will retain
17	staff with the requisite training and experience
18	to serve parents in the State;
19	"(E) serve urban, suburban, and rural
20	local educational agencies and schools;
21	"(F) work with—
22	"(i) other Statewide Family Engage-
23	ment Centers assisted under this subpart;
24	and

1	"(ii) parent training and information
2	centers and community parent resource
3	centers assisted under sections 671 and
4	672 of the Individuals with Disabilities
5	Education Act;
6	"(G) use not less than 30 percent of the
7	funds received under this subpart for each fiscal
8	year to establish or expand technical assistance
9	for evidence-based parent education programs;
10	"(H) provide assistance to State edu-
11	cational agencies and local educational agencies
12	and community-based organizations that sup-
13	port family members in supporting student aca-
14	demic achievement;
15	"(I) work with State educational agencies,
16	local educational agencies, schools, educators,
17	and parents to determine parental needs and
18	the best means for delivery of services to ad-
19	dress such needs;
20	"(J) conduct sufficient outreach to assist
21	parents, including parents who the applicant
22	may have a difficult time engaging with a
23	school or local educational agency; and
24	"(K) conduct outreach to low-income stu-
25	dents and parents, including low-income stu-

1	dents and parents who are not proficient in
2	English.
3	"SEC. 3144. USES OF FUNDS.
4	"(a) In General.—Grantees shall use grant funds
5	received under this subpart, based on the needs deter-
6	mined under section 3143(b)(6)(I), to provide training
7	and technical assistance to State educational agencies,
8	local educational agencies, and organizations that support
9	family-school partnerships, and activities, services, and
10	training for local educational agencies, school leaders, edu-
11	cators, and parents—
12	"(1) to assist parents in participating effectively
13	in their children's education and to help their chil-
14	dren meet State standards, such as assisting par-
15	ents—
16	"(A) to engage in activities that will im-
17	prove student academic achievement, including
18	understanding how they can support learning in
19	the classroom with activities at home and in
20	afterschool and extracurricular programs;
21	"(B) to communicate effectively with their
22	children, teachers, school leaders, counselors,
23	administrators, and other school personnel;
24	"(C) to become active participants in the
25	development, implementation, and review of

1	school-parent compacts, family engagement in
2	education policies, and school planning and im-
3	provement;
4	"(D) to participate in the design and pro-
5	vision of assistance to students who are not
6	making academic progress;
7	"(E) to participate in State and local deci-
8	sionmaking;
9	"(F) to train other parents; and
10	"(G) to help the parents learn and use
11	technology applied in their children's education;
12	"(2) to develop and implement, in partnership
13	with the State educational agency, statewide family
14	engagement in education policy and systemic initia-
15	tives that will provide for a continuum of services to
16	remove barriers for family engagement in education
17	and support school reform efforts; and
18	"(3) to develop and implement parental involve-
19	ment policies under this Act.
20	"(b) Matching Funds for Grant Renewal.—
21	For each fiscal year after the first fiscal year for which
22	an organization or consortium receives assistance under
23	this section, the organization or consortium shall dem-
24	onstrate in the application that a portion of the services
25	provided by the organization or consortium is supported

1	through non-Federal contributions, which may be in cash
2	or in-kind.
3	"(c) Technical Assistance.—The Secretary shall
4	reserve not more than 2 percent of the funds appropriated
5	under section 3(c)(1)(C) to carry out this subpart to pro-
6	vide technical assistance, by competitive grant or contract,
7	for the establishment, development, and coordination of
8	Statewide Family Engagement Centers.
9	"(d) Rule of Construction.—Nothing in this sec-
10	tion shall be construed to prohibit a Statewide Family En-
11	gagement Center from—
12	"(1) having its employees or agents meet with
13	a parent at a site that is not on school grounds; or
14	"(2) working with another agency that serves
15	children.
16	"(e) Parental Rights.—Notwithstanding any
17	other provision of this section—
18	"(1) no person (including a parent who edu-
19	cates a child at home, a public school parent, or a
20	private school parent) shall be required to partici-
21	pate in any program of parent education or develop-
22	mental screening under this section; and
23	"(2) no program or center assisted under this
24	section shall take any action that infringes in any

manner on the right of a parent to direct the edu-

2	cation of their children.
3	"SEC. 3145. FAMILY ENGAGEMENT IN INDIAN SCHOOLS.
4	"The Secretary of the Interior, in consultation with
5	the Secretary of Education, shall establish, or enter into
6	contracts and cooperative agreements with local Indian
7	nonprofit parent organizations to establish and operate
8	Family Engagement Centers.
9	"PART B—LOCAL ACADEMIC FLEXIBLE GRANT
10	"SEC. 3201. PURPOSE.
11	"The purpose of this part is to—
12	"(1) provide local educational agencies with the
13	opportunity to access funds to support the initiatives
14	important to their schools and students to improve
15	academic achievement, including protecting student
16	safety; and
17	"(2) provide nonprofit and for-profit entities
18	the opportunity to work with students to improve
19	academic achievement, including student safety.
20	"SEC. 3202. ALLOTMENTS TO STATES.
21	"(a) Reservations.—From the funds appropriated
22	under section $3(c)(2)$ for any fiscal year, the Secretary
23	shall reserve—
24	"(1) not more than one-half of 1 percent for
25	national activities to provide technical assistance to

eligible entities in carrying out programs under this part; and

"(2) not more than one-half of 1 percent for payments to the outlying areas and the Bureau of Indian Education, to be allotted in accordance with their respective needs for assistance under this part, as determined by the Secretary, to enable the outlying areas and the Bureau to carry out the purpose of this part.

## "(b) State Allotments.—

"(1) Determination.—From the funds appropriated under section 3(c)(2) for any fiscal year and remaining after the Secretary makes reservations under subsection (a), the Secretary shall allot to each State for the fiscal year an amount that bears the same relationship to the remainder as the amount the State received under chapter B of subpart 1 of part A of title I for the preceding fiscal year bears to the amount all States received under that chapter for the preceding fiscal year, except that no State shall receive less than an amount equal to one-half of 1 percent of the total amount made available to all States under this subsection.

"(2) REALLOTMENT OF UNUSED FUNDS.—If a State does not receive an allotment under this part

1	for a fiscal year, the Secretary shall reallot the
2	amount of the State's allotment to the remaining
3	States in accordance with this section.
4	"(c) State Use of Funds.—
5	"(1) In general.—Each State that receives an
6	allotment under this part shall reserve not less than
7	75 percent of the amount allotted to the State under
8	subsection (b) for each fiscal year for awards to eli-
9	gible entities under section 3204.
10	"(2) Awards to nongovernmental enti-
11	TIES TO IMPROVE STUDENT ACADEMIC ACHIEVE-
12	MENT.—Each State that receives an allotment under
13	subsection (b) for each fiscal year shall reserve not
14	less than 10 percent of the amount allotted to the
15	State for awards to nongovernmental entities under
16	section 3205.
17	"(3) State activities and state adminis-
18	TRATION.—A State educational agency may reserve
19	not more than 15 percent of the amount allotted to
20	the State under subsection (b) for each fiscal year
21	for the following:
22	"(A) Enabling the State educational agen-
23	cy—
24	"(i) to pay the costs of developing the
25	State assessments and standards required

1	under section 1111(b), which may include
2	the costs of working, at the sole discretion
3	of the State, in voluntary partnerships
4	with other States to develop such assess-
5	ments and standards; or
6	"(ii) if the State has developed the as-
7	sessments and standards required under
8	section 1111(b), to administer those as-
9	sessments or carry out other activities re-
10	lated to ensuring that the State's schools
11	and local educational agencies are helping
12	students meet the State's academic stand-
13	ards under such section.
14	"(B) The administrative costs of carrying
15	out its responsibilities under this part, except
16	that not more than 5 percent of the reserved
17	amount may be used for this purpose.
18	"(C) Monitoring and evaluation of pro-
19	grams and activities assisted under this part.
20	"(D) Providing training and technical as-
21	sistance under this part.
22	"(E) Statewide academic focused pro-
23	grams.
24	"(F) Sharing evidence-based and other ef-
25	fective strategies with eligible entities.

2	"(a) In General.—In order to receive an allotment
3	under section 3202 for any fiscal year, a State educational
4	agency shall submit to the Secretary, at such time as the
5	Secretary may require, an application that—
6	"(1) describes how the State educational agency
7	will use funds reserved for State-level activities, in-
8	cluding how, if any, of the funds will be used to sup-
9	port student safety;
10	"(2) describes the procedures and criteria the
11	State educational agency will use for reviewing appli-
12	cations and awarding funds to eligible entities on a
13	competitive basis, which shall include reviewing how
14	the proposed project will help increase student aca-
15	demic achievement;
16	"(3) describes how the State educational agency
17	will ensure that awards made under this part are—
18	"(A) of sufficient size and scope to support
19	high-quality, effective programs that are con-
20	sistent with the purpose of this part; and
21	"(B) in amounts that are consistent with
22	section 3204(f);
23	"(4) describes the steps the State educational
24	agency will take to ensure that programs implement
25	effective strategies, including providing ongoing

1	technical assistance and training, and dissemination
2	of evidence-based and other effective strategies;
3	"(5) describes how the State educational agency
4	will consider students across all grades when making
5	these awards;
6	"(6) an assurance that, other than providing
7	technical and advisory assistance and monitoring
8	compliance with this part, the State educational
9	agency has not exercised and will not exercise any
10	influence in the decisionmaking process of eligible
11	entities as to the expenditure of funds received by
12	the eligible entities under this part;
13	"(7) describes how programs under this part
14	will be coordinated with programs under this Act,
15	and other programs as appropriate;
16	"(8) contains an assurance that the State edu-
17	cational agency—
18	"(A) will make awards for programs for a
19	period of not more than 5 years; and
20	"(B) will require each eligible entity seek-
21	ing such an award to submit a plan describing
22	how the project to be funded through the award
23	will continue after funding under this part
24	ends, if applicable;

1	"(9) contains an assurance that funds appro-
2	priated to carry out this part will be used to supple-
3	ment, and not supplant, State and local public funds
4	expended to provide programs and activities author-
5	ized under this part and other similar programs; and
6	"(10) an assurance that the State will support
7	projects from each of the categories listed in section
8	3204(b)(1)(D) in awarding subgrants to local edu-
9	cational agencies.
10	"(b) DEEMED APPROVAL.—An application submitted
11	by a State educational agency pursuant to subsection (a)
12	shall be deemed to be approved by the Secretary unless
13	the Secretary makes a written determination, prior to the
14	expiration of the 120-day period beginning on the date on
15	which the Secretary received the application, that the ap-
16	plication is not in compliance with this part.
17	"(c) DISAPPROVAL.—The Secretary shall not finally
18	disapprove the application, except after giving the State
19	educational agency notice and an opportunity for a hear-
20	ing.
21	"(d) NOTIFICATION.—If the Secretary finds that the
22	application is not in compliance, in whole or in part, with
23	this part, the Secretary shall—
24	"(1) give the State educational agency notice

and an opportunity for a hearing; and

1	"(2) notify the State educational agency of the
2	finding of noncompliance, and, in such notification,
3	shall—
4	"(A) cite the specific provisions in the ap-
5	plication that are not in compliance; and
6	"(B) request additional information, only
7	as to the noncompliant provisions, needed to
8	make the application compliant.
9	"(e) Response.—If the State educational agency re-
10	sponds to the Secretary's notification described in sub-
11	section (d)(2) during the 45-day period beginning on the
12	date on which the agency received the notification, and
13	resubmits the application with the requested information
14	described in subsection (d)(2)(B), the Secretary shall ap-
15	prove or disapprove such application prior to the later of—
16	"(1) the expiration of the 45-day period begin-
17	ning on the date on which the application is resub-
18	mitted; or
19	"(2) the expiration of the 120-day period de-
20	scribed in subsection (b).
21	"(f) Failure To Respond.—If the State edu-
22	cational agency does not respond to the Secretary's notifi-
23	cation described in subsection (d)(2) during the 45-day pe-
24	riod beginning on the date on which the agency received

1	the notification, such application shall be deemed to be
2	disapproved.
3	"(g) Rule of Construction.—An application sub-
4	mitted by a State educational agency pursuant to sub-
5	section (a) shall not be approved or disapproved based
6	upon the activities for which the agency may make funds
7	available to eligible entities under section 3204 if the agen-
8	cy's use of funds is consistent with section 3204(b).
9	"SEC. 3204. LOCAL COMPETITIVE GRANT PROGRAM.
10	"(a) In General.—A State that receives funds
11	under this part for a fiscal year shall provide the amount
12	made available under section $3202(c)(1)$ to eligible entities
13	in accordance with this section.
14	"(b) Use of Funds.—
15	"(1) In general.—An eligible entity that re-
16	ceives an award under this part shall use the funds
17	for activities that—
18	"(A) are evidence-based;
19	"(B) will improve student academic
20	achievement;

14	"(II) provide compensation or
15	benefits to teachers, school leaders,
16	other school officials, or local edu-
17	cational agency staff.
18	"(2) Participation of Children enrolled
19	IN PRIVATE SCHOOLS.—An eligible entity that re-
20	ceives an award under this part shall ensure compli-
21	ance with section 6501 (relating to participation of
22	children enrolled in private schools).
23	"(c) Application.—
24	"(1) In general.—To be eligible to receive an
25	award under this part, an eligible entity shall submit

1	an application to the State educational agency at
2	such time, in such manner, and including such infor-
3	mation as the State educational agency may reason-
4	ably require, including the contents required by
5	paragraph (2).
6	"(2) Contents.—Each application submitted
7	under paragraph (1) shall include—
8	"(A) a description of the activities to be
9	funded and how they are consistent with sub-
10	section (b), including any activities that will in-
11	crease student safety;
12	"(B) an assurance that funds under this
13	part will be used to increase the level of State,
14	local, and other non-Federal funds that would,
15	in the absence of funds under this part, be
16	made available for programs and activities au-
17	thorized under this part, and in no case sup-
18	plant State, local, or non-Federal funds;
19	"(C) an assurance that the community will
20	be given notice of an intent to submit an appli-
21	cation with an opportunity for comment, and
22	that the application will be available for public
23	review after submission of the application; and
24	"(D) an assurance that students who ben-
25	efit from any activity funded under this part

- shall continue to maintain enrollment in a pub-
- 2 lic elementary or secondary school.
- 3 "(d) Review.—In reviewing local applications under
- 4 this section, a State educational agency shall use a peer
- 5 review process or other methods of assuring the quality
- 6 of such applications but the review shall be limited to the
- 7 likelihood that the project will increase student academic
- 8 achievement.
- 9 "(e) Geographic Diversity.—A State educational
- 10 agency shall distribute funds under this part equitably
- 11 among geographic areas within the State, including rural,

- 13 "(f) AWARD.—A grant shall be awarded to all eligible

15	"SEC. 3205. AWARDS TO NONGOVERNMENTAL ENTITIES TO
16	IMPROVE ACADEMIC ACHIEVEMENT.

18	under section 3202(c)(2), a State educational agency shall
19	award grants to nongovernmental entities, including pub-
20	lic or private organizations, community-based or faith-
21	based organizations, and business entities for a program
22	or project to increase the academic achievement of public
23	school students attending public elementary or secondary
24	schools (or both) in compliance with the requirements in
25	this section. Subject to the availability of funds, the State

1	educational agency shall award a grant to each eligible ap-

16	program or project is targeting to impact, and if the
17	program will prioritize students in high-need local

19	"(5) A description of how the applicant will
20	conduct sufficient outreach to ensure students can
21	participate in the program or project.
22	"(6) A description of any partnerships the ap-
23	plicant has entered into with local educational agen-

cies or other entities the applicant will work with, if

applicable.

1	"(7) A description of how the applicant will
2	work to share evidence-based and other effective
3	strategies from the program or project with local
4	educational agencies and other entities working with
5	students to increase academic achievement.
6	"(8) An assurance that students who benefit
7	from any program or project funded under this sec-
8	tion shall continue to maintain enrollment in a pub-
9	lic elementary or secondary school.
10	"(c) MATCHING CONTRIBUTION.—An eligible appli-
11	cant receiving a grant under this section shall provide, ei-
12	ther directly or through private contributions, non-Federal
13	matching funds equal to not less than 50 percent of the
14	amount of the grant.

16	review the application to ensure that—

- other staff who serve Indian and Alaska Native students have the ability to provide culturally appropriate and effective instruction to such students.

15	"(A) are composed primarily of the family
16	members of Indian or Alaska Native students,
17	Indian or Alaska Native community members,
18	tribal government education officials, and tribal
19	members from a specific community;
20	"(B) assist in the social, cultural, and edu-
21	cational development of Indians or Alaska Na-
22	tives in such community;
23	"(C) meet the unique cultural, language,
24	and academic needs of Indian or Alaska Native
25	students: and

1	"(D) demonstrate organizational and ad-
2	ministrative capacity to effectively manage the
3	grant.
4	"SEC. 5113. AMOUNT OF GRANTS.
5	"(a) Amount of Grant Awards.—
6	"(1) In general.—Except as provided in sub-
7	section (b) and paragraph (2), the Secretary shall
8	allocate to each local educational agency that has an
9	approved application under this subpart an amount
10	equal to the product of—
11	"(A) the number of Indian children who
12	are eligible under section 5117 and served by
13	such agency; and
14	"(B) the greater of—
15	"(i) the average per pupil expenditure
16	of the State in which such agency is lo-
17	cated; or
18	"(ii) 80 percent of the average per
19	pupil expenditure of all the States.
20	"(2) Reduction.—The Secretary shall reduce
21	the amount of each allocation otherwise determined
22	under this section in accordance with subsection (e).
23	"(b) Minimum Grant.—
24	"(1) In general.—Notwithstanding subsection
25	(e), an entity that is eligible for a grant under sec-

- tion 5112, and a school that is operated or supported by the Bureau of Indian Education that is eligible for a grant under subsection (d), that submits an application that is approved by the Secretary, shall, subject to appropriations, receive a grant under this subpart in an amount that is not less than \$3,000.
- 8 "(2) Consortia.—Local educational agencies 9 may form a consortium for the purpose of obtaining 10 grants under this subpart.
- 11 "(3) INCREASE.—The Secretary may increase 12 the minimum grant under paragraph (1) to not 13 more than \$4,000 for all grantees if the Secretary 14 determines such increase is necessary to ensure the 15 quality of the programs provided.
- 16 "(c) DEFINITION.—For the purpose of this section, 17 the term 'average per pupil expenditure', used with respect 18 to a State, means an amount equal to—
- "(1) the sum of the aggregate current expenditures of all the local educational agencies in the State, plus any direct current expenditures by the State for the operation of such agencies, without regard to the sources of funds from which such local or State expenditures were made, during the second

1	fiscal year preceding the fiscal year for which the
2	computation is made; divided by
3	"(2) the aggregate number of children who
4	were included in average daily attendance for whom
5	such agencies provided free public education during
6	such preceding fiscal year.
7	"(d) Schools Operated or Supported by the
8	BUREAU OF INDIAN EDUCATION.—
9	"(1) In general.—Subject to subsection (e),
10	in addition to the grants awarded under subsection
11	(a), the Secretary shall allocate to the Secretary of
12	the Interior an amount equal to the product of—
13	"(A) the total number of Indian children
14	enrolled in schools that are operated by—
15	"(i) the Bureau of Indian Education;
16	or
17	"(ii) an Indian tribe, or an organiza-
18	tion controlled or sanctioned by an Indian
19	tribal government, for the children of that
20	tribe under a contract with, or grant from,
21	the Department of the Interior under the
22	Indian Self-Determination Act or the Trib-
23	ally Controlled Schools Act of 1988; and
24	"(B) the greater of—

1	"(i) the average per pupil expenditure
2	of the State in which the school is located;
3	or
4	"(ii) 80 percent of the average per
5	pupil expenditure of all the States.
6	"(2) Special rule.—Any school described in
7	paragraph (1)(A) that wishes to receive an allocation
8	under this subpart shall submit an application in ac-
9	cordance with section 5114, and shall otherwise be
10	treated as a local educational agency for the purpose
11	of this subpart, except that such school shall not be
12	subject to section $5114(c)(5)$ or section $5119$ .
13	"(e) Ratable Reductions.—If the sums appro-
14	priated for any fiscal year to carry out this subpart are
15	insufficient to pay in full the amounts determined for local
16	educational agencies under subsection (a)(1) and for the
17	Secretary of the Interior under subsection (d), each of
18	those amounts shall be ratably reduced.
19	"SEC. 5114. APPLICATIONS.
20	"(a) Application Required.—Each local edu-
21	cational agency that desires to receive a grant under this
22	subpart shall submit an application to the Secretary at
23	such time, in such manner, and containing such informa-
24	tion as the Secretary may reasonably require.

1	"(b) Comprehensive Program Required.—Each
2	application submitted under subsection (a) shall include
3	a description of a comprehensive program for meeting the
4	needs of Indian and Alaska Native children served by the
5	local educational agency, including the language and cul-
6	tural needs of the children, that—
7	"(1) describes how the comprehensive program
8	will offer programs and activities to meet the cul-
9	turally related academic needs of American Indian
10	and Alaska Native students;
11	"(2)(A) is consistent with the State, tribal, and
12	local plans submitted under other provisions of this
13	Act; and
14	"(B) includes academic content and student
15	academic achievement goals for such children, and
16	benchmarks for attaining such goals, that are based
17	on State academic content and student academic
18	achievement standards adopted under title I for all
19	children;
20	"(3) explains how the local educational agency
21	will use the funds made available under this subpart
22	to supplement other Federal, State, and local pro-
23	grams that serve such students;

1	"(4) demonstrates how funds made available
2	under this subpart will be used for activities de-
3	scribed in section 5115;
4	"(5) describes the professional development op-
5	portunities that will be provided, as needed, to en-
6	sure that—
7	"(A) teachers and other school profes-
8	sionals who are new to the Indian or Alaska
9	Native community are prepared to work with
10	Indian and Alaska Native children;
11	"(B) all teachers who will be involved in
12	programs assisted under this subpart have been
13	properly trained to carry out such programs;
14	and
15	"(C) those family members of Indian and
16	Alaska Native children and representatives of
17	tribes who are on the committee described in
18	(c)(5) will participate in the planning of profes-
19	sional development materials;
20	"(6) describes how the local educational agen-
21	cy—
22	"(A) will periodically assess the progress of
23	all Indian children enrolled in the schools of the
24	local educational agency, including Indian chil-
25	dren who do not participate in programs as-

1	sisted under this subpart, in meeting the goals
2	described in paragraph (2);
3	"(B) will provide the results of each as-
4	sessment referred to in subparagraph (A) to—
5	"(i) the committee described in sub-
6	section $(c)(5)$ ;
7	"(ii) the community served by the
8	local educational agency; and
9	"(iii) the tribes whose children are
10	served by the local educational agency; and
11	"(C) is responding to findings of any pre-
12	vious assessments that are similar to the as-
13	sessments described in subparagraph (A); and
14	"(7) explicitly delineates—
15	"(A) a formal, collaborative process that
16	the local educational agency used to directly in-
17	volve tribes, Indian organizations, or Alaska
18	Native Organizations in the development of the
19	comprehensive programs and the results of such
20	process; and
21	"(B) how the local educational agency
22	plans to ensure that tribes, Indian organiza-
23	tions, or Alaska Native Organizations will play
24	an active, meaningful, and ongoing role in the
25	functioning of the comprehensive programs.

1	"(c) Assurances.—Each application submitted
2	under subsection (a) shall include assurances that—
3	"(1) the local educational agency will use funds
4	received under this subpart only to supplement the
5	funds that, in the absence of the Federal funds
6	made available under this subpart, such agency
7	would make available for services described in this
8	subsection, and not to supplant such funds;
9	"(2) the local educational agency will use funds
10	received under this subpart only for activities de-
11	scribed and authorized under this subpart;
12	"(3) the local educational agency will prepare
13	and submit to the Secretary such reports, in such
14	form and containing such information, as the Sec-
15	retary may require to—
16	"(A) carry out the functions of the Sec-
17	retary under this subpart;
18	"(B) determine the extent to which activi-
19	ties carried out with funds provided to the local
20	educational agency under this subpart are effec-
21	tive in improving the educational achievement
22	of Indian and Alaska Native students served by
23	such agency; and

1	"(C) determine the extent to which such
2	activities address the unique cultural, language,
3	and educational needs of Indian students;
4	"(4) the program for which assistance is
5	sought—
6	"(A) is based on a comprehensive local as-
7	sessment and prioritization of the unique edu-
8	cational and culturally related academic needs
9	of the American Indian and Alaska Native stu-
10	dents for whom the local educational agency is
11	providing an education;
12	"(B) will use the best available talents and
13	resources, including individuals from the Indian
14	or Alaska Native community; and
15	"(C) was developed by such agency in open
16	consultation with the families of Indian or Alas-
17	ka Native children, Indian or Alaska Native
18	teachers, Indian or Alaska Native students
19	from secondary schools, and representatives of
20	tribes, Indian organizations, or Alaska Native
21	Organizations in the community including
22	through public hearings held by such agency to
23	provide to the individuals described in this sub-
24	paragraph a full opportunity to understand the

1	program and to offer recommendations regard-
2	ing the program;
3	"(5) the local educational agency developed the
4	program with the participation and written approval
5	of a committee—
6	"(A) that is composed of, and selected
7	by—
8	"(i) family members of Indian and
9	Alaska Native children that are attending
10	the local educational agency's schools;
11	"(ii) teachers in the schools; and
12	"(iii) Indian and Alaska Native stu-
13	dents attending secondary schools of the
14	agency;
15	"(B) a majority of whose members are
16	family members of Indian and Alaska Native
17	children that are attending the local educational
18	agency's schools;
19	"(C) that has set forth such policies and
20	procedures, including policies and procedures
21	relating to the hiring of personnel, as will en-
22	sure that the program for which assistance is
23	sought will be operated and evaluated in con-
24	sultation with, and with the involvement of,

1	parents of the children, and representatives of
2	the area, to be served;
3	"(D) with respect to an application de-
4	scribing a schoolwide program in accordance
5	with section 5115(c), that has—
6	"(i) reviewed in a timely fashion the
7	program;
8	"(ii) determined that the program will
9	not diminish the availability of culturally
10	related activities for American Indian and
11	Alaska Native students; and
12	"(iii) will directly enhance the edu-
13	cational experience of American Indian and
14	Alaska Native students; and
15	"(E) that has adopted reasonable bylaws
16	for the conduct of the activities of the com-
17	mittee and abides by such bylaws; and
18	"(6) the local educational agency conducted
19	adequate outreach to family members to meet the
20	requirements under subsection (c)(5).
21	"SEC. 5115. AUTHORIZED SERVICES AND ACTIVITIES.
22	"(a) General Requirements.—Each local edu-
23	cational agency that receives a grant under this subpart
24	shall use the grant funds, in a manner consistent with the

1	purpose specified in section 5111, for services and activi-
2	ties that—
3	"(1) are designed to carry out the comprehen-
4	sive program of the local educational agency for In-
5	dian students, and described in the application of
6	the local educational agency submitted to the Sec-
7	retary under section 5114(a) solely for the services
8	and activities described in such application;
9	"(2) are designed with special regard for the
10	language and cultural needs of the Indian students;
11	and
12	"(3) supplement and enrich the regular school
13	program of such agency.
14	"(b) Particular Activities.—The services and ac-
15	tivities referred to in subsection (a) may include—
16	"(1) activities that support Native American
17	language immersion programs and Native American
18	language restoration programs, which may be taught
19	by traditional leaders;
20	"(2) culturally related activities that support
21	the program described in the application submitted
22	by the local educational agency;
23	"(3) early childhood and family programs that
24	emphasize school readiness:

1	"(4) enrichment programs that focus on prob-
2	lem solving and cognitive skills development and di-
3	rectly support the attainment of challenging State
4	academic content and student academic achievement
5	standards;
6	"(5) integrated educational services in combina-
7	tion with other programs including programs that
8	enhance student achievement by promoting increased
9	involvement of parents and families in school activi-
10	ties;
11	"(6) career preparation activities to enable In-
12	dian students to participate in programs such as the
13	programs supported by the Carl D. Perkins Career
14	and Technical Education Improvement Act of 2006
15	including programs for tech-prep education, men-
16	toring, and apprenticeship;
17	"(7) activities to educate individuals so as to
18	prevent violence, suicide, and substance abuse;

- "(8) the acquisition of equipment, but only if the acquisition of the equipment is essential to achieve the purpose described in section 5111;
- "(9) activities that promote the incorporation of culturally responsive teaching and learning strategies into the educational program of the local educational agency;

1	"(10) activities that incorporate culturally and
2	linguistically relevant curriculum content into class-
3	room instruction that is responsive to the unique
4	learning styles of Indian and Alaska Native children
5	and ensures that children are better able to meet
6	State standards;
7	"(11) family literacy services;
8	"(12) activities that recognize and support the
9	unique cultural and educational needs of Indian chil-
10	dren, and incorporate appropriately qualified tribal
11	elders and seniors;
12	"(13) dropout prevention strategies for Indian
13	and Alaska Native students; and
14	"(14) strategies to meet the educational needs
15	of at-risk Indian students in correctional facilities,
16	including such strategies that support Indian and
17	Alaska Native students who are transitioning from
18	such facilities to schools served by local educational
19	agencies.
20	"(c) Schoolwide Programs.—Notwithstanding
21	any other provision of law, a local educational agency may
22	use funds made available to such agency under this sub-
23	part to support a schoolwide program under section 1114
1	: <i>e</i>

1	"(1) the committee established pursuant to sec-
2	tion 5114(e)(5) approves the use of the funds for
3	the schoolwide program;

- 4 "(2) the schoolwide program is consistent with 5 the purpose described in section 5111; and
- 6 "(3) the local educational agency identifies in 7 its application how the use of such funds in a 8 schoolwide program will produce benefits to the 9 American Indian and Alaska Native students that 10 would not be achieved if the funds were not used in 11 a schoolwide program.
- 12 "(d) Limitation on Administrative Costs.—Not
- 13 more than 5 percent of the funds provided to a grantee
- 14 under this subpart for any fiscal year may be used for
- 15 administrative purposes.
- 16 "(e) Limitation on the Use of Funds.—Funds
- 17 provided to a grantee under this subpart may not be used
- 18 for long-distance travel expenses for training activities
- 19 available locally or regionally.
- 20 "SEC. 5116. INTEGRATION OF SERVICES AUTHORIZED.
- 21 "(a) Plan.—An entity receiving funds under this
- 22 subpart may submit a plan to the Secretary for the inte-
- 23 gration of education and related services provided to In-
- 24 dian students.

"(b) Consolidation of Programs.—Upon the re-1 2 ceipt of an acceptable plan under subsection (a), the Sec-3 retary, in cooperation with each Federal agency providing 4 grants for the provision of education and related services 5 to the entity, shall authorize the entity to consolidate, in accordance with such plan, the federally funded education 6 7 and related services programs of the entity and the Fed-8 eral programs, or portions of the programs, serving Indian students in a manner that integrates the program services 10 involved into a single, coordinated, comprehensive program and reduces administrative costs by consolidating 11 administrative functions. 12 13 "(c) Programs Affected.—The funds that may be 14 consolidated in a demonstration project under any such 15 plan referred to in subsection (a) shall include funds for any Federal program exclusively serving Indian children, 16 17 or the funds reserved under any Federal program to exclu-18 sively serve Indian children, under which the entity is eligible for receipt of funds under a statutory or administrative 19 formula for the purposes of providing education and re-20 21 lated services that would be used to serve Indian students. 22 "(d) Plan Requirements.—For a plan to be ac-23 ceptable pursuant to subsection (b), the plan shall— 24 "(1) identify the programs or funding sources

to be consolidated;

1	"(2) be consistent with the objectives of this
2	section concerning authorizing the services to be in-
3	tegrated in a demonstration project;
4	"(3) describe a comprehensive strategy that
5	identifies the full range of potential educational op-
6	portunities and related services to be provided to as-
7	sist Indian students to achieve the objectives set
8	forth in this subpart;
9	"(4) describe the way in which services are to
10	be integrated and delivered and the results expected
11	from the plan;
12	"(5) identify the projected expenditures under
13	the plan in a single budget;
14	"(6) identify the State, tribal, or local agency
15	or agencies to be involved in the delivery of the serv-
16	ices integrated under the plan;
17	"(7) identify any statutory provisions, regula-
18	tions, policies, or procedures that the entity believes
19	need to be waived in order to implement the plan;
20	"(8) set forth measures for academic content
21	and student academic achievement goals designed to
22	be met within a specific period of time; and
23	"(9) be approved by a committee formed in ac-
24	cordance with section $5114(c)(5)$ , if such a com-
25	mittee exists.

- 1 "(e) Plan Review.—Upon receipt of the plan from
- 2 an eligible entity, the Secretary shall consult with the Sec-
- 3 retary of each Federal department providing funds to be
- 4 used to implement the plan, and with the entity submit-
- 5 ting the plan. The parties so consulting shall identify any
- 6 waivers of statutory requirements or of Federal depart-
- 7 mental regulations, policies, or procedures necessary to en-
- 8 able the entity to implement the plan. Notwithstanding
- 9 any other provision of law, the Secretary of the affected
- 10 department shall have the authority to waive any regula-
- 11 tion, policy, or procedure promulgated by that department
- 12 that has been so identified by the entity or department,
- 13 unless the Secretary of the affected department deter-
- 14 mines that such a waiver is inconsistent with the objectives
- 15 of this subpart or those provisions of the statute from

- 18 "(f) Plan Approval.—Within 90 days after the re-
- 19 ceipt of an entity's plan by the Secretary, the Secretary
- 20 shall inform the entity, in writing, of the Secretary's ap-
- 21 proval or disapproval of the plan. If the plan is dis-
- 22 approved, the entity shall be informed, in writing, of the
- 23 reasons for the disapproval and shall be given an oppor-
- 24 tunity to amend the plan or to petition the Secretary to
- 25 reconsider such disapproval.

1	"(g) Responsibilities of Department of Edu-
2	CATION.—Not later than 180 days after the date of enact-
3	ment of the Student Success Act, the Secretary of Edu-
4	cation, the Secretary of the Interior, the Secretary of the
5	Department of Health and Human Services, and the head
6	of any other Federal department or agency identified by
7	the Secretary of Education, shall enter into an inter-
8	departmental memorandum of agreement providing for
9	the implementation and coordination of the demonstration
10	projects authorized under this section. The lead agency
11	head for a demonstration project under this section shall
12	be—
13	"(1) the Secretary of the Interior, in the case
14	of an entity meeting the definition of a contract or
15	grant school under title XI of the Education Amend-
16	ments of 1978; or
17	"(2) the Secretary of Education, in the case of
18	any other entity.
19	"(h) RESPONSIBILITIES OF LEAD AGENCY.—The re-
20	sponsibilities of the lead agency shall include—
21	"(1) the use of a single report format related
22	to the plan for the individual project, which shall be
23	used by an eligible entity to report on the activities
24	undertaken under the project;

- "(2) the use of a single report format related to the projected expenditures for the individual project which shall be used by an eligible entity to report on all project expenditures;
  - "(3) the development of a single system of Federal oversight for the project, which shall be implemented by the lead agency; and
  - "(4) the provision of technical assistance to an eligible entity appropriate to the project, except that an eligible entity shall have the authority to accept or reject the plan for providing such technical assistance and the technical assistance provider.
- 13 "(i) REPORT REQUIREMENTS.—A single report format shall be developed by the Secretary, consistent with 14 15 the requirements of this section. Such report format shall require that reports described in subsection (h), together 16 with records maintained on the consolidated program at 18 the local level, shall contain such information as will allow 19 a determination that the eligible entity has complied with 20 the requirements incorporated in its approved plan, in-21 cluding making a demonstration of student academic 22 achievement, and will provide assurances to each Sec-23 retary that the eligible entity has complied with all directly applicable statutory requirements and with those directly

- 3 "(j) No Reduction in Amounts.—In no case shall
- 4 the amount of Federal funds available to an eligible entity
- 5 involved in any demonstration project be reduced as a re-

- 7 "(k) Interagency Fund Transfers Author-
- 8 IZED.—The Secretary is authorized to take such action
- 9 as may be necessary to provide for an interagency transfer
- 10 of funds otherwise available to an eligible entity in order
- 11 to further the objectives of this section.
- 12 "(l) Administration of Funds.—
- "(1) IN GENERAL.—Program funds for the con-
- solidated programs shall be administered in such a
- manner as to allow for a determination that funds
- from a specific program are spent on allowable ac-
- 17 tivities authorized under such program, except that
- the eligible entity shall determine the proportion of
- the funds granted that shall be allocated to such
- program.
- 21 "(2) Separate records not required.—
- Nothing in this section shall be construed as requir-
- ing the eligible entity to maintain separate records
- 24 tracing any services or activities conducted under
- 25 the approved plan to the individual programs under

- 1 which funds were authorized for the services or ac-
- 2 tivities, nor shall the eligible entity be required to al-
- 3 locate expenditures among such individual programs.
- 4 "(m) Overage.—The eligible entity may commingle
- 5 all administrative funds from the consolidated programs
- 6 and shall be entitled to the full amount of such funds
- 7 (under each program's or agency's regulations). The over-
- 8 age (defined as the difference between the amount of the
- 9 commingled funds and the actual administrative cost of
- 10 the programs) shall be considered to be properly spent for
- 11 Federal audit purposes, if the overage is used for the pur-
- 12 poses provided for under this section.
- 13 "(n) FISCAL ACCOUNTABILITY.—Nothing in this
- 14 part shall be construed so as to interfere with the ability
- 15 of the Secretary or the lead agency to fulfill the respon-
- 16 sibilities for the safeguarding of Federal funds pursuant
- 17 to chapter 75 of title 31, United States Code.
- 18 "(o) Report on Statutory Obstacles to Pro-
- 19 GRAM INTEGRATION.—
- 20 "(1) Preliminary Report.—Not later than 2
- 21 years after the date of enactment of the Student
- 22 Success Act, the Secretary of Education shall submit
- a preliminary report to the Committee on Education
- and the Workforce and the Committee on Natural
- Resources of the House of Representatives and the

Committee on Health, Education, Labor, and Pensions and the Committee on Indian Affairs of the Senate on the status of the implementation of the demonstration projects authorized under this section.

"(2) Final report.—Not later than 5 years after the date of enactment of the Student Success Act, the Secretary of Education shall submit a report to the Committee on Education and the Workforce and the Committee on Natural Resources of the House of Representatives and the Committee on Health, Education, Labor, and Pensions and the Committee on Indian Affairs of the Senate on the results of the implementation of the demonstration projects authorized under this section. Such report shall identify statutory barriers to the ability of participants to integrate more effectively their education and related services to Indian students in a manner consistent with the objectives of this section.

20 "(p) Definitions.—For the purposes of this section,21 the term 'Secretary' means—

"(1) the Secretary of the Interior, in the case of an entity meeting the definition of a contract or grant school under title XI of the Education Amendments of 1978; or

1	"(2) the Secretary of Education, in the case of
2	any other entity.
3	"SEC. 5117. STUDENT ELIGIBILITY FORMS.
4	"(a) In General.—The Secretary shall require that,
5	as part of an application for a grant under this subpart,
6	each applicant shall maintain a file, with respect to each
7	Indian child for whom the local educational agency pro-
8	vides a free public education, that contains a form that
9	sets forth information establishing the status of the child
10	as an Indian child eligible for assistance under this sub-
11	part, and that otherwise meets the requirements of sub-
12	section (b).
13	"(b) Forms.—The form described in subsection (a)
14	shall include—
15	"(1) either—
16	"(A)(i) the name of the tribe or band of
17	Indians (as defined in section 5151) with re-
18	spect to which the child claims membership;
19	"(ii) the enrollment or membership number
20	establishing the membership of the child (if
21	readily available); and
22	"(iii) the name and address of the organi-
23	zation that maintains updated and accurate
24	membership data for such tribe or band of Indi-

1	"(B) the name, the enrollment or member-
2	ship number (if readily available), and the name
3	and address of the organization responsible for
4	maintaining updated and accurate membership
5	data, of any parent or grandparent of the child
6	from whom the child claims eligibility under

8	tribe or band of Indians (as so defined);
9	"(2) a statement of whether the tribe or band
10	of Indians (as so defined), with respect to which the
11	child, or parent or grandparent of the child, claims
12	membership, is federally recognized;
13	"(3) the name and address of the parent or
14	legal guardian of the child;
15	"(4) a signature of the parent or legal guardian
16	of the child that verifies the accuracy of the informa-
17	tion supplied; and
18	"(5) any other information that the Secretary
19	considers necessary to provide an accurate program
20	profile.
21	"(c) Statutory Construction.—Nothing in this
22	section shall be construed to affect a definition contained

- "(1) Types of proof.—For purposes of determining whether a child is eligible to be counted for the purpose of computing the amount of a grant award under section 5113, the membership of the child, or any parent or grandparent of the child, in a tribe or band of Indians (as so defined) may be established by proof other than an enrollment number, notwithstanding the availability of an enrollment number for a member of such tribe or band. Nothing in subsection (b) shall be construed to require the furnishing of an enrollment number.
  - "(2) NO NEW OR DUPLICATIVE DETERMINA-TIONS.—Once a child is determined to be an Indian eligible to be counted for such grant award, the local education agency shall maintain a record of such determination and shall not require a new or duplicate determination to be made for such child for a subsequent application for a grant under this subpart.
  - "(3) Previously filed forms.—An Indian student eligibility form that was on file as required by this section on the day before the date of enactment of the Student Success Act and that met the requirements of this section, as this section was in effect on the day before the date of enactment of such Act, shall remain valid for such Indian student.

2	"(1) In general.—
3	"(A) Review.—For each fiscal year, in
4	order to provide such information as is nec-
5	essary to carry out the responsibility of the Sec-

24	cational agency that provides false information in an

6	"(3) Excluded Children.—A student who
7	provides false information for the form required
8	under subsection (a) shall not be counted for the
9	purpose of computing the amount of a grant under

11	"(f) Tribal Grant and Contract Schools.—
12	Notwithstanding any other provision of this section, in cal-
13	culating the amount of a grant under this subpart to a
14	tribal school that receives a grant or contract from the
15	Bureau of Indian Education, the Secretary shall use only
16	one of the following, as selected by the school:
17	"(1) A count of the number of students in the
18	schools certified by the Bureau.
19	"(2) A count of the number of students for
20	whom the school has eligibility forms that comply
21	with this section.
22	"(g) Timing of Child Counts.—For purposes of
23	determining the number of children to be counted in calcu-
24	lating the amount of a local educational agency's grant

14	ness, screening and referral, and the provision
15	of services to Indian children and youth with
16	disabilities;
17	"(H) partnership projects between local
18	educational agencies and institutions of higher
19	education that allow secondary school students
20	to enroll in courses at the postsecondary level to
21	aid such students in the transition from sec-
22	ondary to postsecondary education;
23	"(I) partnership projects between schools
24	and local businesses for career preparation pro-

grams designed to provide Indian youth with

1	the knowledge and skills such youth need to
2	make an effective transition from school to a
3	high-skill, high-wage career;
4	"(J) programs designed to encourage and
5	assist Indian students to work toward, and gain
6	entrance into, an institution of higher edu-
7	cation;
8	"(K) family literacy services;
9	"(L) activities that recognize and support
10	the unique cultural and educational needs of In-
11	dian children, and incorporate appropriately
12	qualified tribal elders and seniors;
13	"(M) high quality professional development
14	of teaching professionals and paraprofessionals;

16	"(N) other services that meet the purpose
17	described in this section.
18	"(d) Grant Requirements and Applications.—
19	"(1) Grant requirements.—
20	"(A) IN GENERAL.—The Secretary may
21	make multiyear grants under subsection (c) for
22	the planning, development, pilot operation, or
23	demonstration of any activity described in sub-
24	section (c) for a period not to exceed 5 years.

1	"(B) Priority.—In making multiyear

# "(2) DISSEMINATION GRANTS.—

"(A) IN GENERAL.—In addition to awarding the multiyear grants described in paragraph (1), the Secretary may award grants under subsection (c) to eligible entities for the dissemination of exemplary materials or programs assisted under this section.

10	"(iv) a description of how the appli-
11	cant will incorporate the proposed activities
12	into the ongoing school program involved
13	once the grant period is over; and
14	"(v) such other assurances and infor-
15	mation as the Secretary may reasonably
16	require.
17	"(e) Administrative Costs.—Not more than 5 per-
18	cent of the funds provided to a grantee under this subpart
19	for any fiscal year may be used for administrative pur-
20	poses.
21	"SEC. 5122. PROFESSIONAL DEVELOPMENT FOR TEACHERS
22	AND EDUCATION PROFESSIONALS.
23	"(a) Purposes.—The purposes of this section are—

1	"(1) to increase the number of qualified Indian
2	and Alaska Native teachers and administrators serv-
3	ing Indian and Alaska Native students;
4	"(2) to provide training to qualified Indian and
5	Alaska Native individuals to become educators and
6	education support service professionals; and
7	"(3) to improve the skills of qualified Indian in-
8	dividuals who serve in the capacities described in
9	paragraph (2).
10	"(b) Eligible Entities.—For the purpose of this
11	section, the term 'eligible entity' means—
12	"(1) an institution of higher education, includ-
13	ing an Indian institution of higher education;
14	"(2) a State educational agency or local edu-
15	cational agency, in consortium with an institution of
16	higher education;
17	"(3) an Indian tribe or organization, in consor-
18	tium with an institution of higher education; and
19	"(4) a Bureau-funded school (as defined in sec-
20	tion 1146 of the Education Amendments of 1978).
21	"(c) Program Authorized.—The Secretary is au-
22	thorized to award grants to eligible entities having applica-

- "(A) Type of training.—For education personnel, the training received pursuant to a grant under this section may be inservice or preservice training.
- "(B) Program.—For individuals who are being trained to enter any field other than teaching, the training received pursuant to a grant under this section shall be in a program that results in a graduate degree.
- "(e) APPLICATION.—Each eligible entity desiring a 20 grant under this section shall submit an application to the 21 Secretary at such time, in such manner, and accompanied 22 by such information, as the Secretary may reasonably re-23 quire.
- 24 "(f) SPECIAL RULE.—In awarding grants under this25 section, the Secretary—

13	"(D) include the goal of increasing pro-
14	ficiency and fluency in not less than 1 Native
15	American language.
16	"(d) Application.—
17	"(1) In general.—An eligible entity that de-
18	sires to receive a grant under this section shall sub-
19	mit an application to the Secretary at such time, in
20	such manner, and accompanied by such information
21	as the Secretary may require.
22	"(2) Certification.—An eligible entity that
23	submits an application for a grant to carry out the
24	activity specified in subsection (c)(1), shall include
25	in such application a certification that assures that

- 1 such entity has experience and a demonstrated
- 2 record of effectiveness in operating and admin-

Significant disparities between academic achievement of Alaska Native students and non-Native students continues, including lower graduation rates, increased school dropout rates, and lower achievement scores on standardized tests.
  - "(5) The preservation of Alaska Native cultures and languages and the integration of Alaska Native cultures and languages into education, positive identity development for Alaska Native students, and local, place-based, and culture-based programming are critical to the attainment of educational success and the long-term well-being of Alaska Native students.
  - "(6) Improving educational outcomes for Alaska Native students increases access to employment opportunities.

1 "(7) The programs and activities authorized 2 under this part give priority to Alaska Native orga-3 nizations as a means of increasing Alaska Native 4 parents' and community involvement in the pro-5 motion of academic success of Alaska Native stu-6 dents.

"(8) The Federal Government should lend support to efforts developed by and undertaken within the Alaska Native community to improve educational opportunity for Alaska Native students. In 1983, pursuant to Public Law 98–63, Alaska ceased to receive educational funding from the Bureau of Indian Affairs. The Bureau of Indian Education does not operate any schools in Alaska, nor operate or fund Alaska Native education programs. The program under this part supports the Federal trust responsibility of the United States to Alaska Natives.

1	"(I) Education programs for at-risk urban

23	"(B) Public Law 95–341 (commonly
24	known as the 'American Indian Religious Free-

dom Act' (42 U.S.C. 1996));

1	"(C) the National Museum of the Amer-
2	ican Indian Act (20 U.S.C. 80q et seq.);
3	"(D) the Native American Graves Protec-
4	tion and Repatriation Act (25 U.S.C. 3001 et
5	seq.);
6	"(E) the National Historic Preservation
7	Act (16 U.S.C. 470 et seq.);
8	"(F) the Native American Languages Act
9	(25 U.S.C. 2901 et seq.);
10	"(G) the American Indian, Alaska Native,
11	and Native Hawaiian Culture and Art Develop-
12	ment Act (20 U.S.C. 4401 et seq.);
13	"(H) the Workforce Investment Act of
14	1998 (29 U.S.C. 2801 et seq.); and
15	"(I) the Older Americans Act of 1965 (42
16	U.S.C. 3001 et seq.).
17	"(5) Many Native Hawaiian students lag be-
18	hind other students in terms of—
19	"(A) school readiness factors;
20	"(B) scoring below national norms on edu-
21	cation achievement tests at all grade levels;
22	"(C) underrepresentation in the uppermost
23	achievement levels and in gifted and talented
24	programs;

1	"(D) overrepresentation among students
2	qualifying for special education programs;
3	"(E) underrepresentation in institutions of
4	higher education and among adults who have
5	completed 4 or more years of college.
6	"(6) The percentage of Native Hawaiian stu-
7	dents served by the State of Hawaii Department of
8	Education rose 30 percent from 1980 to 2008, and
9	there are and will continue to be geographically
10	rural, isolated areas with a high Native Hawaiian
11	population density.
12	"(7) The Native Hawaiian people are deter-
13	mined to preserve, develop, and transmit to future
14	generations their ancestral territory and their cul-
15	tural identity in accordance with their own spiritual
16	and traditional beliefs, customs, practices, language,
17	and social institutions.
18	"SEC. 5302. PURPOSES.
19	"The purposes of this part are—
20	"(1) to authorize, develop, implement, assess,
21	and evaluate innovative educational programs, Na-
22	tive Hawaiian language medium programs, Native
23	Hawaiian culture-based education programs, and
24	other education programs to improve the academic
25	achievement of Native Hawaiian students by meet-

1	ing their unique cultural and language needs in

4	"(2) to provide guidance to appropriate Fed-

17	lected, analyzed, evaluated, reported, and used in de-
18	cisionmaking activities regarding the types of grants
19	awarded under this part.
20	"SEC. 5303. NATIVE HAWAIIAN EDUCATION COUNCIL
21	GRANT.
22	"(a) Grant Authorized.—In order to better effec-
23	tuate the purposes of this part through the coordination
24	of educational and related services and programs available
25	to Native Hawaiians, including those programs that re-

1	ceive funding under this part, the Secretary shall award
2	a grant to an education council, as described under sub-
3	section (b).
4	"(b) Education Council.—
5	"(1) ELIGIBILITY.—To be eligible to receive the
6	grant under subsection (a), the council shall be an
7	education council (referred to in this section as the
8	'Education Council') that meets the requirements of
9	this subsection.
10	"(2) Composition.—The Education Council
11	shall consist of 15 members of whom—
12	"(A) one shall be the President of the Uni-
13	versity of Hawaii (or a designee);
14	"(B) one shall be the Governor of the
15	State of Hawaii (or a designee);
16	"(C) one shall be the Superintendent of
17	the State of Hawaii Department of Education
18	(or a designee);
19	"(D) one shall be the chairperson of the
20	Office of Hawaiian Affairs (or a designee);
21	"(E) one shall be the executive director of
22	Hawaii's Charter School Network (or a des-
23	ignee);
24	"(F) one shall be the chief executive officer
25	of the Kamehameha Schools (or a designee).

1	"(G) one shall be the Chief Executive Offi-
2	cer of the Queen Liliuokalani Trust (or a des-
3	ignee);
4	"(H) one shall be a member, selected by
5	the other members of the Education Council,
6	who represents a private grant-making entity;
7	"(I) one shall be the Mayor of the County
8	of Hawaii (or a designee);
9	"(J) one shall be the Mayor of Maui Coun-
10	ty (or a designee from the Island of Maui);
11	"(K) one shall be the Mayor of the County
12	of Kauai (or a designee);
13	"(L) one shall be appointed by the Mayor
14	of Maui County from the Island of either
15	Molokai or Lanai;
16	"(M) one shall be the Mayor of the City
17	and County of Honolulu (or a designee);
18	"(N) one shall be the chairperson of the
19	Hawaiian Homes Commission (or a designee);
20	and
21	"(O) one shall be the chairperson of the
22	Hawaii Workforce Development Council (or a
23	designee representing the private sector).
24	"(3) Requirements.—Any designee serving on
25	the Education Council shall demonstrate, as deter-

1	mined by the individual who appointed such designee
2	with input from the Native Hawaiian community,
3	not less than 5 years of experience as a consumer
4	or provider of Native Hawaiian education or cultural
5	activities, with traditional cultural experience given
6	due consideration.
7	"(4) LIMITATION.—A member (including a des-
8	ignee), while serving on the Education Council, shall
9	not be a recipient of grant funds that are awarded
10	under this part.
11	"(5) Term of members.—A member who is a
12	designee shall serve for a term of not more than 4
13	years.
14	"(6) Chair, vice chair.—
15	"(A) Selection.—The Education Council
16	shall select a Chair and a Vice Chair from
17	among the members of the Education Council.
18	"(B) Term limits.—The Chair and Vice
19	Chair shall each serve for a 2-year term.
20	"(7) Administrative provisions relating
21	TO EDUCATION COUNCIL.—The Education Council
22	shall meet at the call of the Chair of the Council,
23	or upon request by a majority of the members of the
24	Education Council, but in any event not less often
25	than every 120 days.

1	"(8) NO COMPENSATION.—None of the funds
2	made available through the grant may be used to
3	provide compensation to any member of the Edu-
4	cation Council or member of a working group estab-
5	lished by the Education Council, for functions de-
6	scribed in this section.

9	"(d) Use of Funds for Technical Assist-
10	ANCE.—The Education Council shall use funds made
11	available through the grant to—
12	"(1) provide technical assistance to Native Ha-
13	waiian organizations that are grantees or potential
14	grantees under this part;
15	"(2) obtain from such grantees information and
16	data regarding grants awarded under this part, in-
17	cluding information and data about—
18	"(A) the effectiveness of such grantees in
19	meeting the educational priorities established by
20	the Education Council, as described in para-
21	graph (6)(D), using metrics related to these
22	priorities; and
23	"(B) the effectiveness of such grantees in
24	carrying out any of the activities described in
25	section 5304(c) that are related to the specific

1	goals and purposes of each grantee's grant
2	project, using metrics related to these priorities;
3	"(3) assess and define the educational needs of
4	Native Hawaiians;
5	"(4) assess the programs and services available
6	to address the educational needs of Native Hawai-
7	ians;
8	"(5) assess and evaluate the individual and ag-
9	gregate impact achieved by grantees under this part
10	in improving Native Hawaiian educational perform-
11	ance and meeting the goals of this part, using
12	metrics related to these goals; and
13	"(6) prepare and submit to the Secretary, at
14	the end of each calendar year, an annual report that
15	contains—
16	"(A) a description of the activities of the
17	Education Council during the calendar year;
18	"(B) a description of significant barriers to
19	achieving the goals of this part;
20	"(C) a summary of each community con-
21	sultation session described in subsection (e);
22	and
23	"(D) recommendations to establish prior-
24	ities for funding under this part, based on an
25	assessment of

1	"(i) the educational needs of Native
2	Hawaiians;
3	"(ii) programs and services available
4	to address such needs;
5	"(iii) the effectiveness of programs in
6	improving the educational performance of
7	Native Hawaiian students to help such stu-
8	dents meet challenging State student aca-
9	demic achievement standards; and
10	"(iv) priorities for funding in specific
11	geographic communities.
12	"(e) Use of Funds for Community Consulta-
13	TIONS.—The Education Council shall use funds made
14	available through the grant under subsection (a) to hold
15	not less than one community consultation each year on
16	each of the islands of Hawaii, Maui, Molokai, Lanai,
17	Oahu, and Kauai, at which—
18	"(1) not less than three members of the Edu-
19	cation Council shall be in attendance;
20	"(2) the Education Council shall gather com-
21	munity input regarding—
22	"(A) current grantees under this part, as
23	of the date of the consultation;
24	"(B) priorities and needs of Native Hawai-
25	ians; and

1	"(C) other Native Hawaiian education
2	issues; and
3	"(3) the Education Council shall report to the

9	through the grant shall remain available until expended.

11	after the date of enactment of the Student Success Act,
12	and for each subsequent year, the Secretary shall prepare
13	and submit to the Committee on Education and the Work-
14	force of the House of Representatives, and the Committee
15	on Indian Affairs and the Committee on Health, Edu-
16	cation, Labor, and Pensions of the Senate, a report that—
17	"(1) summarizes the annual reports of the Edu-

1	"(2) the repair and renovation of public schools
2	that serve high concentrations of Native Hawaiian
3	students;
4	"(3) programs designed to improve the aca-
5	demic achievement of Native Hawaiian students by
6	meeting their unique cultural and language needs in
7	order to help such students meet challenging State
8	student academic achievement standards, including
9	activities relating to—
10	"(A) achieving competence in reading, lit-
11	eracy, mathematics, and science for students in
12	preschool through grade 3;
13	"(B) the educational needs of at-risk chil-
14	dren and youth;
15	"(C) professional development for teachers
16	and administrators;
17	"(D) the use of Native Hawaiian language
18	and preservation or reclamation of Native Ha-
19	waiian culture-based educational practices; and
20	"(E) other programs relating to the activi-
21	ties described in this part; and
22	"(4) programs in which a local educational
23	agency, institution of higher education, or a State
24	educational agency in partnership with a nonprofit
25	entity serving underserved communities within the

1	Native Hawaiian population apply for a grant or
2	contract under this part as part of a partnership or
3	consortium.
4	"(c) Authorized Activities.—Activities provided
5	through programs carried out under this part may in-
6	clude—
7	"(1) the development and maintenance of a
8	statewide Native Hawaiian early education and care
9	system to provide a continuum of high-quality early
10	learning services for Native Hawaiian children from
11	the prenatal period through the age of kindergarten
12	entry;
13	"(2) the operation of family-based education
14	centers that provide such services as—
15	"(A) early care and education programs
16	for Native Hawaiians; and
17	"(B) research on, and development and as-
18	sessment of, family-based, early childhood, and
19	preschool programs for Native Hawaiians;
20	"(3) activities that enhance beginning reading
21	and literacy in either the Hawaiian or the English
22	language among Native Hawaiian students in kin-
23	dergarten through grade 3 and assistance in ad-
24	dressing the distinct features of combined English

1	and Hawaiian literacy for Hawaiian speakers in
2	grades 5 and 6;
3	"(4) activities to meet the special needs of Na-
4	tive Hawaiian students with disabilities, including—
5	"(A) the identification of such students
6	and their needs;
7	"(B) the provision of support services to
8	the families of such students; and
9	"(C) other activities consistent with the re-
10	quirements of the Individuals with Disabilities
11	Education Act;
12	"(5) activities that address the special needs of
13	Native Hawaiian students who are gifted and tal-
14	ented, including—
15	"(A) educational, psychological, and devel-
16	opmental activities designed to assist in the
17	educational progress of such students; and
18	"(B) activities that involve the parents of
19	such students in a manner designed to assist in
20	the educational progress of such students;
21	"(6) the development of academic and voca-
22	tional curricula to address the needs of Native Ha-
23	waiian students, including curricula materials in the
24	Hawaiian language and mathematics and science

1	curricula that incorporate Native Hawaiian tradition
2	and culture;
3	"(7) professional development activities for edu-
4	cators, including—
5	"(A) the development of programs to pre-
6	pare prospective teachers to address the unique
7	needs of Native Hawaiian students within the
8	context of Native Hawaiian culture, language,
9	and traditions;
10	"(B) in-service programs to improve the
11	ability of teachers who teach in schools with
12	high concentrations of Native Hawaiian stu-
13	dents to meet the unique needs of such stu-
14	dents; and
15	"(C) the recruitment and preparation of
16	Native Hawaiians, and other individuals who
17	live in communities with a high concentration of
18	Native Hawaiians, to become teachers;
19	"(8) the operation of community-based learning
20	centers that address the needs of Native Hawaiian
21	students, parents, families, and communities
22	through the coordination of public and private pro-
23	grams and services, including—
24	"(A) early education programs;

1	"(B) before, after, and Summer school
2	programs, expanded learning time, or weekend
3	academies;
4	"(C) career and technical education pro-
5	grams; and
6	"(D) programs that recognize and support
7	the unique cultural and educational needs of
8	Native Hawaiian children, and incorporate ap-
9	propriately qualified Native Hawaiian elders
10	and seniors;
11	"(9) activities, including program co-location,
12	that ensure Native Hawaiian students graduate col-
13	lege and career ready including—
14	"(A) family literacy services;
15	"(B) counseling, guidance, and support
16	services for students; and
17	"(C) professional development activities de-
18	signed to help educators improve the college
19	and career readiness of Native Hawaiian stu-
20	dents;
21	"(10) research and data collection activities to
22	determine the educational status and needs of Na-
23	tive Hawaiian children and adults;
24	"(11) other research and evaluation activities
25	related to programs carried out under this part: and

1	"(12) other activities, consistent with the pur-
2	poses of this part, to meet the educational needs of
3	Native Hawaiian children and adults.
4	"(d) Additional Activities.—Notwithstanding
5	any other provision of this part, funds made available to
6	carry out this section as of the day before the date of en-
7	actment of the Student Success Act shall remain available
8	until expended. The Secretary shall use such funds to sup-
9	port the following:
10	"(1) The repair and renovation of public
11	schools that serve high concentrations of Native Ha-
12	waiian students.
13	"(2) The perpetuation of, and expansion of ac-
14	cess to, Hawaiian culture and history through digital
15	archives.
16	"(3) Informal education programs that connect
17	traditional Hawaiian knowledge, science, astronomy,

22	"(e) Administrative Costs.—
23	"(1) In general.—Except as provided in para-
24	graph (2), not more than 5 percent of funds pro-

- "(2) EXCEPTION.—The Secretary may waive the requirement of paragraph (1) for a nonprofit entity that receives funding under this section and allow not more than 10 percent of funds provided to such nonprofit entity under this section for any fiscal year to be used for administrative purposes.

20	SEC. 601. GENERAL PROVISIONS FOR THE ACT.
21	(a) Amending Title VI.—Title VI (20 U.S.C. 7301
22	et seq.) is amended to read as follows:

1	"TITLE VI—GENERAL
2	PROVISIONS
3	"PART A—DEFINITIONS
4	"SEC. 6101. DEFINITIONS.
5	"Except as otherwise provided, in this Act:
6	"(1) Average daily attendance.—
7	"(A) In general.—Except as provided
8	otherwise by State law or this paragraph, the
9	term 'average daily attendance' means—
10	"(i) the aggregate number of days of
11	attendance of all students during a school
12	year; divided by
13	"(ii) the number of days school is in
14	session during that year.
15	"(B) Conversion.—The Secretary shall
16	permit the conversion of average daily member-
17	ship (or other similar data) to average daily at-
18	tendance for local educational agencies in
19	States that provide State aid to local edu-
20	cational agencies on the basis of average daily
21	membership (or other similar data).
22	"(C) Special rule.—If the local edu-
23	cational agency in which a child resides makes
24	a tuition or other payment for the free public
25	education of the child in a school located in an-

1	other school district, the Secretary shall, for the
2	purpose of this Act—
3	"(i) consider the child to be in attend-
4	ance at a school of the agency making the
5	payment; and
6	"(ii) not consider the child to be in at-
7	tendance at a school of the agency receiv-
8	ing the payment.
9	"(D) CHILDREN WITH DISABILITIES.—If a
10	local educational agency makes a tuition pay-
11	ment to a private school or to a public school
12	of another local educational agency for a child
13	with a disability, as defined in section 602 of
14	the Individuals with Disabilities Education Act,
15	the Secretary shall, for the purpose of this Act,
16	consider the child to be in attendance at a
17	school of the agency making the payment.
18	"(2) Average per-pupil expenditure.—The
19	term 'average per-pupil expenditure' means, in the
20	case of a State or of the United States—
21	"(A) without regard to the source of
22	funds—
23	"(i) the aggregate current expendi-
24	tures, during the third fiscal year pre-
25	ceding the fiscal year for which the deter-

1	mination is made (or, if satisfactory data
2	for that year are not available, during the
3	most recent preceding fiscal year for which
4	satisfactory data are available) of all local
5	educational agencies in the State or, in the
6	case of the United States, for all States
7	(which, for the purpose of this paragraph,
8	means the 50 States and the District of
9	Columbia); plus
10	"(ii) any direct current expenditures
11	by the State for the operation of those
12	agencies; divided by
13	"(B) the aggregate number of children in
14	average daily attendance to whom those agen-
15	cies provided free public education during that
16	preceding year.
17	"(3) Charter school.—The term 'charter
18	school' means a public school that—
19	"(A) in accordance with a specific State
20	statute authorizing the granting of charters to
21	schools, is exempt from significant State or
22	local rules that inhibit the flexible operation
23	and management of public schools, but not
24	from any rules relating to the other require-
25	ments of this paragraph;

1	"(B) is created by a developer as a public
2	school, or is adapted by a developer from an ex-
3	isting public school, and is operated under pub-
4	lic supervision and direction;
5	"(C) operates in pursuit of a specific set of
6	educational objectives determined by the
7	school's developer and agreed to by the author-
8	ized public chartering agency;
9	"(D) provides a program of elementary or
10	secondary education, or both;
11	"(E) is nonsectarian in its programs, ad-
12	missions policies, employment practices, and all
13	other operations, and is not affiliated with a
14	sectarian school or religious institution;
15	"(F) does not charge tuition;
16	"(G) complies with the Age Discrimination
17	Act of 1975, title VI of the Civil Rights Act of
18	1964, title IX of the Education Amendments of
19	1972, section 504 of the Rehabilitation Act of
20	1973, part B of the Individuals with Disabil-
21	ities Education Act, the Americans with Dis-
22	abilities Act of 1990 (42 U.S.C. 12101 et seq.),
23	and section 444 of the General Education Pro-
24	visions Act (20 U.S.C. 1232(g)) (commonly

I	known as the 'Family Education Rights and
2	Privacy Act of 1974');
3	"(H) is a school to which parents choose to
4	send their children, and admits students on the
5	basis of a lottery if more students apply for ad-
6	mission than can be accommodated, except that
7	in cases in which students who are enrolled in
8	a charter school affiliated (such as by sharing
9	a network) with another charter school, those
10	students may be automatically enrolled in the
11	next grade level at such other charter school, so
12	long as a lottery is used to fill seats created
13	through regular attrition in student enrollment
14	"(I) agrees to comply with the same Fed-
15	eral and State audit requirements as do other
16	elementary schools and secondary schools in the
17	State, unless such State audit requirements are
18	waived by the State;
19	"(J) meets all applicable Federal, State
20	and local health and safety requirements;
21	"(K) operates in accordance with State
22	law;
23	"(L) has a written performance contract
24	with the authorized public chartering agency in
25	the State that includes a description of how

1	student performance will be measured in char-
2	ter schools pursuant to State assessments that
3	are required of other schools and pursuant to
4	any other assessments mutually agreeable to
5	the authorized public chartering agency and the
6	charter school; and
7	"(M) may serve prekindergarten or post-
8	secondary students.
9	"(4) Child.—The term 'child' means any per-
10	son within the age limits for which the State pro-
11	vides free public education.
12	"(5) CHILD WITH A DISABILITY.—The term
13	'child with a disability' has the same meaning given
14	that term in section 602 of the Individuals with Dis-
15	abilities Education Act.
16	"(6) Community-based organization.—The
17	term 'community-based organization' means a public
18	or private nonprofit organization of demonstrated ef-
19	fectiveness that—
20	"(A) is representative of a community or
21	significant segments of a community; and
22	"(B) provides educational or related serv-
23	ices to individuals in the community.
24	"(7) Consolidated local application.—
25	The term 'consolidated local application' means an

1	application submitted by a local educational agency
2	pursuant to section 6305.
3	"(8) Consolidated local plan.—The term
4	'consolidated local plan' means a plan submitted by
5	a local educational agency pursuant to section 6305.
6	"(9) Consolidated State Application.—
7	The term 'consolidated State application' means an
8	application submitted by a State educational agency
9	pursuant to section 6302.
10	"(10) Consolidated State Plan.—The term
11	'consolidated State plan' means a plan submitted by
12	a State educational agency pursuant to section
13	6302.
14	"(11) Core academic subjects.—The term
15	'core academic subjects' means English, reading or
16	language arts, mathematics, science, foreign lan-
17	guages, civics and government, economics, arts, his-
18	tory, and geography.
19	"(12) County.—The term 'county' means one
20	of the divisions of a State used by the Secretary of
21	Commerce in compiling and reporting data regard-
22	ing counties.
23	"(13) COVERED PROGRAM.—The term 'covered
24	program' means each of the programs authorized
25	by—

1	"(A) part A of title I;
2	"(B) title II; and
3	"(C) part B of title III.
4	"(14) Current expenditures.—The term
5	'current expenditures' means expenditures for free
6	public education—
7	"(A) including expenditures for adminis-
8	tration, instruction, attendance and health serv-
9	ices, pupil transportation services, operation
10	and maintenance of plant, fixed charges, and
11	net expenditures to cover deficits for food serv-
12	ices and student body activities; but
13	"(B) not including expenditures for com-
14	munity services, capital outlay, and debt serv-
15	ice, or any expenditures made from funds re-
16	ceived under title I.
17	"(15) Department.—The term 'Department'
18	means the Department of Education.
19	"(16) DIRECT STUDENT SERVICES.—The term
20	'direct student services' means public school choice
21	or high-quality academic tutoring that are designed
22	to help increase academic achievement for students.
23	"(17) DISTANCE EDUCATION.—The term 'dis-
24	tance education' means the use of one or more tech-
25	nologies to deliver instruction to students who are

1	separated from the instructor and to support regular
2	and substantive interaction between the students
3	and the instructor synchronously or nonsyn-
4	chronously.
5	"(18) EDUCATIONAL SERVICE AGENCY.—The
6	term 'educational service agency' means a regional
7	public multiservice agency authorized by State stat-
8	ute to develop, manage, and provide services or pro-
9	grams to local educational agencies.
10	"(19) Elementary school.—The term 'ele-
11	mentary school' means a nonprofit institutional day
12	or residential school, including a public elementary
13	charter school, that provides elementary education,
14	as determined under State law.
15	"(20) English learner.—The term 'English
16	learner', when used with respect to an individual,
17	means an individual—
18	"(A) who is aged 3 through 21;
19	"(B) who is enrolled or preparing to enroll
20	in an elementary school or secondary school;
21	"(C)(i) who was not born in the United
22	States or whose native language is a language
23	other than English;

1	"(ii)(I) who is a Native American or Alas-
2	ka Native, or a native resident of the outlying
3	areas; and
4	"(II) who comes from an environment
5	where a language other than English has had
6	a significant impact on the individual's level of
7	English language proficiency; or
8	"(iii) who is migratory, whose native lan-
9	guage is a language other than English, and
10	who comes from an environment where a lan-
11	guage other than English is dominant; and
12	"(D) whose difficulties in speaking, read-
13	ing, writing, or understanding the English lan-
14	guage may be sufficient to deny the indi-
15	vidual—
16	"(i) the ability to meet the State's
17	academic standards described in section
18	1111;
19	"(ii) the ability to successfully achieve
20	in classrooms where the language of in-
21	struction is English; or
22	"(iii) the opportunity to participate
23	fully in society.
24	"(21) Extended-year adjusted cohort
25	GRADUATION RATE.—

1	"(A) IN GENERAL.—The term 'extended-
2	year adjusted cohort graduation rate' means the
3	ratio where—
4	"(i) the denominator consists of the
5	number of students who form the original
6	cohort of entering first-time 9th grade stu-
7	dents enrolled in the high school no later
8	than the effective date for student mem-
9	bership data submitted annually by State
10	educational agencies to the National Cen-
11	ter for Education Statistics under section
12	153 of the Education Sciences Reform Act,
13	adjusted by—
14	"(I) adding the students who
15	joined that cohort, after the time of
16	the determination of the original co-
17	hort; and
18	"(II) subtracting only those stu-
19	dents who left that cohort, after the
20	time of the determination of the origi-
21	nal cohort, as described in subpara-
22	graph (B); and
23	"(ii) the numerator consists of the
24	number of students in the cohort, as ad-
25	justed under clause (i), who earned a reg-

1	ular high school diploma before, during, or
2	at the conclusion of—
3	"(I) one or more additional years
4	beyond the fourth year of high school;
5	or
6	"(II) a summer session imme-
7	diately following the additional year of
8	high school.
9	"(B) Cohort removal.—To remove a
10	student from a cohort, a school or local edu-
11	cational agency shall require documentation to
12	confirm that the student has transferred out,
13	emigrated to another country, transferred to a
14	prison or juvenile facility, or is deceased.
15	"(C) Transferred out.—
16	"(i) In general.—For purposes of
17	this paragraph, the term 'transferred out'
18	means a student who the high school or
19	local educational agency has confirmed, ac-
20	cording to clause (ii), has transferred—
21	"(I) to another school from which
22	the student is expected to receive a
23	regular high school diploma; or
24	"(II) to another educational pro-
25	gram from which the student is ex-

1	pected to receive a regular high school
2	diploma.
3	"(ii) Confirmation require-
4	MENTS.—
5	"(I) Documentation re-
6	QUIRED.—The confirmation of a stu-
7	dent's transfer to another school or
8	educational program described in
9	clause (i) requires documentation
10	from the receiving school or program
11	that the student enrolled in the receiv-
12	ing school or program.
13	"(II) Lack of confirmation.—
14	A student who was enrolled, but for
15	whom there is no confirmation of the
16	student having transferred out, shall
17	remain in the denominator of the ex-
18	tended-year adjusted cohort.
19	"(iii) Programs not providing
20	CREDIT.—A student who is retained in
21	grade or who is enrolled in a GED or other
22	alternative educational program that does

19	parents and their children.

23	"(C) Parent literacy training that leads to
24	economic self-sufficiency.

1	"(D) An age-appropriate education to pre-
2	pare children for success in school and life ex-
3	periences.
4	"(23) Four-year adjusted cohort gradua-
5	TION RATE.—
6	"(A) IN GENERAL.—The term 'four-year
7	adjusted cohort graduation rate' means the
8	ratio where—
9	"(i) the denominator consists of the
10	number of students who form the original
11	cohort of entering first-time 9th grade stu-
12	dents enrolled in the high school no later
13	than the effective date for student mem-
14	bership data submitted annually by State
15	educational agencies to the National Cen-
16	ter for Education Statistics pursuant to
17	section 153 of the Education Sciences Re-
18	form Act, adjusted by—
19	"(I) adding the students who
20	joined that cohort, after the time of
21	the determination of the original co-
22	hort; and
23	"(II) subtracting only those stu-
24	dents who left that cohort, after the
25	time of the determination of the origi-

1	nal cohort, as described in subpara-
2	graph (B); and
3	"(ii) the numerator consists of the
4	number of students in the cohort, as ad-
5	justed under clause (i), who earned a reg-
6	ular high school diploma before, during, or
7	at the conclusion of—
8	"(I) the fourth year of high
9	school; or
10	"(II) a summer session imme-
11	diately following the fourth year of
12	high school.
13	"(B) Cohort removal.—To remove a
14	student from a cohort, a school or local edu-
15	cational agency shall require documentation to
16	confirm that the student has transferred out,
17	emigrated to another country, transferred to a
18	prison or juvenile facility, or is deceased.
19	"(C) Transferred out.—
20	"(i) In general.—For purposes of
21	this paragraph, the term 'transferred out'
22	means a student who the high school or
23	local educational agency has confirmed, ac-
24	cording to clause (ii), has transferred—

1	"(I) to another school from which
2	the student is expected to receive a
3	regular high school diploma; or
4	"(II) to another educational pro-
5	gram from which the student is ex-
6	pected to receive a regular high school
7	diploma.
8	"(ii) Confirmation require-
9	MENTS.—
10	"(I) Documentation re-
11	QUIRED.—The confirmation of a stu-
12	dent's transfer to another school or
13	educational program described in
14	clause (i) requires documentation
15	from the receiving school or program
16	that the student enrolled in the receiv-
17	ing school or program.
18	"(II) Lack of confirmation.—
19	A student who was enrolled, but for
20	whom there is no confirmation of the
21	student having transferred out, shall
22	remain in the adjusted cohort.
23	"(iii) Programs not providing
24	CREDIT.—A student who is retained in
25	grade or who is enrolled in a GED or other

1	alternative educational program that does
2	not issue or provide credit toward the

24	any education provided beyond grade 12.

1	"(25) GIFTED AND TALENTED.—The term
2	'gifted and talented', when used with respect to stu-
3	dents, children, or youth, means students, children,
4	or youth who give evidence of high achievement ca-
5	pability in areas such as intellectual, creative, artis-
6	tic, or leadership capacity, or in specific academic
7	fields, and who need services or activities not ordi-
8	narily provided by the school in order to fully de-
9	velop those capabilities.
10	"(26) High-quality academic tutoring.—
11	The term 'high-quality academic tutoring' means
12	supplemental academic services that—
13	"(A) are in addition to instruction pro-
14	vided during the school day;
15	"(B) are provided by a non-governmental
16	entity or local educational agency that—
17	"(i) is included on a State educational
18	agency approved provider list after dem-
19	onstrating to the State educational agency
20	that its program consistently improves the
21	academic achievement of students; and
22	"(ii) agrees to provide parents of chil-
23	dren receiving high-quality academic tutor-
24	ing, the appropriate local educational agen-
25	cy, and school with information on partici-

1	pating students increases in academic
2	achievement, in a format, and to the extent
3	practicable, a language that such parent
4	can understand, and in a manner that pro-
5	tects the privacy of individuals consistent
6	with section 444 of the General Education
7	Provisions Act (20 U.S.C. 1232g);
8	"(C) are selected by the parents of stu-
9	dents who are identified by the local educational
10	agency as being eligible for such services from

14	and local health, safety, and civil rights laws;
15	and
16	"(E) ensure that all instruction and con-
17	tent are secular, neutral, and non-ideological.
18	"(27) High school.—The term 'high school'
19	means a secondary school that—
20	"(A) grants a diploma, as defined by the
21	State; and
22	"(B) includes, at least, grade 12.
23	"(28) Institution of Higher Education.—
24	The term 'institution of higher education' has the

meaning given that term in section 101(a) of the
Higher Education Act of 1965.

## "(29) Local Educational Agency.—

- "(A) IN GENERAL.—The term 'local educational agency' means a public board of education or other public authority legally constituted within a State for either administrative control or direction of, or to perform a service function for, public elementary schools or secondary schools in a city, county, township, school district, or other political subdivision of a State, or of or for a combination of school districts or counties that is recognized in a State as an administrative agency for its public elementary schools or secondary schools.
- "(B) ADMINISTRATIVE CONTROL AND DI-RECTION.—The term includes any other public institution or agency having administrative control and direction of a public elementary school or secondary school.
- "(C) BIE SCHOOLS.—The term includes an elementary school or secondary school funded by the Bureau of Indian Education but only to the extent that including the school makes the school eligible for programs for which spe-

cific eligibility is not provided to the school in another provision of law and the school does not have a student population that is smaller than the student population of the local educational agency receiving assistance under this Act with the smallest student population, except that the school shall not be subject to the jurisdiction of any State educational agency other than the Bureau of Indian Education.

- "(D) EDUCATIONAL SERVICE AGENCIES.—
  The term includes educational service agencies and consortia of those agencies.
- "(E) STATE EDUCATIONAL AGENCY.—The term includes the State educational agency in a State in which the State educational agency is the sole educational agency for all public schools.
- "(30) Native American and Native American' and 'Native American language' have the same meaning given those terms in section 103 of the Native American Languages Act of 1990.
- "(31) OTHER STAFF.—The term 'other staff' means specialized instructional support personnel, librarians, career guidance and counseling personnel,

1	education aides, and other instructional and admin-
2	istrative personnel.
3	"(32) Outlying Area.—The term 'outlying
4	area'—
5	"(A) means American Samoa, the Com-
6	monwealth of the Northern Mariana Islands,
7	Guam, and the United States Virgin Islands;
8	"(B) means the Republic of Palau, to the
9	extent permitted under section $105(f)(1)(B)(ix)$
10	of the Compact of Free Association Amend-
11	ments Act of 2003 (Public Law 99–658; 117
12	Stat. 2751) and until an agreement for the ex-
13	tension of United States education assistance
14	under the Compact of Free Association becomes
15	effective for the Republic of Palau; and
16	"(C) for the purpose of any discretionary
17	grant program under this Act, includes the Re-
18	public of the Marshall Islands and the Fed-
19	erated States of Micronesia, to the extent per-
20	mitted under section 105(f)(1)(B)(viii) of the
21	Compact of Free Association Amendments Act
22	of 2003 (Public Law 108–188; 117 Stat.
23	2751).
24	"(33) Parent.—The term 'parent' includes a
25	legal guardian or other person standing in loco

1	parentis (such as a grandparent, stepparent, or fos-
2	ter parent with whom the child lives, or a person
3	who is legally responsible for the child's welfare).
4	"(34) PARENTAL INVOLVEMENT.—The term
5	'parental involvement' means the participation of
6	parents in regular, two-way, and meaningful commu-
7	nication involving student academic learning and
8	other school activities, including ensuring—
9	"(A) that parents play an integral role in
10	assisting in their child's learning;
11	"(B) that parents are encouraged to be ac-
12	tively involved in their child's education at
13	school;
14	"(C) that parents are full partners in their
15	child's education and are included, as appro-
16	priate, in decisionmaking and on advisory com-
17	mittees to assist in the education of their child;
18	and
19	"(D) the carrying out of other activities,
20	such as those described in section 1118.
21	"(35) POVERTY LINE.—The term 'poverty line'
22	means the poverty line (as defined by the Office of
23	Management and Budget and revised annually in ac-
24	cordance with section 673(2) of the Community

1	Services Block Grant Act) applicable to a family of
2	the size involved.
3	"(36) Professional Development.—The
4	term 'professional development'—
5	"(A) includes evidence-based, job-embed-
6	ded, continuous activities that—
7	"(i) improve and increase teachers"
8	knowledge of the academic subjects the
9	teachers teach, and enable teachers to be-
10	come effective educators;
11	"(ii) are an integral part of broad
12	schoolwide and districtwide educational im-
13	provement plans;
14	"(iii) give teachers, school leaders,
15	other staff, and administrators the knowl-
16	edge and skills to provide students with
17	the opportunity to meet State academic
18	standards;
19	"(iv) improve classroom management
20	skills;
21	"(v)(I) have a positive and lasting im-
22	pact on classroom instruction and the
23	teacher's performance in the classroom;
24	and

1	"(II) are not 1-day or short-term
2	workshops or conferences;
3	"(vi) support the recruiting, hiring,
4	and training of effective teachers, including
5	teachers who became certified or licensed
6	through State and local alternative routes
7	to certification;
8	"(vii) advance teacher understanding
9	of effective instructional strategies that are
10	strategies for improving student academic
11	achievement or substantially increasing the
12	knowledge and teaching skills of teachers,
13	including through addressing the social
14	and emotional development needs of stu-
15	dents;
16	"(viii) are aligned with and directly
17	related to—
18	"(I) State academic standards
19	and assessments; and
20	"(II) the curricula and programs
21	tied to the standards described in sub-
22	clause (I);
23	"(ix) are developed with extensive par-
24	ticipation of teachers, school leaders, par-

1	ents, and administrators of schools to be
2	served under this Act;
3	"(x) are designed to give teachers of
4	English learners and other teachers and
5	instructional staff, the knowledge and
6	skills to provide instruction and appro-
7	priate language and academic support
8	services to those children, including the ap-
9	propriate use of curricula and assessments;
10	"(xi) to the extent appropriate, pro-
11	vide training for teachers, other staff, and
12	school leaders in the use of technology so
13	that technology and technology applica-
14	tions are effectively used to improve teach-
15	ing and learning in the curricula and core
16	academic subjects in which the students re-
17	ceive instruction;
18	"(xii) as a whole, are regularly evalu-
19	ated for their impact on increased teacher
20	effectiveness and improved student aca-
21	demic achievement, with the findings of
22	the evaluations used to improve the quality
23	of the professional development;
24	"(xiii) provide instruction in methods
25	of teaching children with special needs;

1	"(xiv) include instruction in the use of
2	data and assessments to inform and in-
3	struct classroom practice; and
4	"(xv) include instruction in ways that
5	teachers, school leaders, specialized in-
6	structional support personnel, other staff,
7	and school administrators may work more
8	effectively with parents; and
9	"(B) may include evidence-based, job-em-
10	bedded, continuous activities that—
11	"(i) involve the forming of partner-
12	ships with institutions of higher education
13	to establish school-based teacher training
14	programs that provide prospective teachers
15	and new teachers with an opportunity to
16	work under the guidance of experienced
17	teachers and college faculty;
18	"(ii) create programs to enable para-
19	professionals (assisting teachers employed
20	by a local educational agency receiving as-
21	sistance under subpart 1 of part A of title
22	I) to obtain the education necessary for
23	those paraprofessionals to become certified
24	and licensed teachers; and

1 "(iii) provide follow-up training to in2 dividuals who have participated in activi3 ties described in subparagraph (A) or an4 other clause of this subparagraph that are
5 designed to ensure that the knowledge and
6 skills learned by the teachers are imple7 mented in the classroom.

## "(37) Regular high school diploma.—

"(A) IN GENERAL.—The term 'regular high school diploma' means the standard high school diploma awarded to the preponderance of students in the State that is fully aligned with State standards, or a higher diploma. Such term shall not include a GED or other recognized equivalent of a diploma, a certificate of attendance, or any lesser diploma award.

"(B) EXCEPTION FOR STUDENTS WITH SIGNIFICANT COGNITIVE DISABILITIES.—For a student who is assessed using an alternate assessment aligned to alternate academic standards under section 1111(b)(1)(D), receipt of a regular high school diploma as defined under subparagraph (A) or a State-defined alternate diploma obtained within the time period for which the State ensures the availability of a

1	free appropriate public education and in accord-
2	ance with section 612(a)(1) of the Individuals
3	with Disabilities Education Act shall be counted
4	as graduating with a regular high school di-
5	ploma for the purposes of this Act.
6	"(38) School Leader.—The term 'school
7	leader' means a principal, assistant principal, or
8	other individual who is—
9	"(A) an employee or officer of a school,
10	local educational agency, or other entity oper-
11	ating the school; and
12	"(B) responsible for—
13	"(i) the daily instructional leadership
14	and managerial operations of the school;
15	and
16	"(ii) creating the optimum conditions
17	for student learning.
18	"(39) Secondary school.—The term 'sec-
19	ondary school' means a nonprofit institutional day or
20	residential school, including a public secondary char-
21	ter school, that provides secondary education, as de-
22	termined under State law, except that the term does
23	not include any education beyond grade 12.
24	"(40) Secretary.—The term 'Secretary'
25	means the Secretary of Education.

1	"(41) Specialized instructional support
2	PERSONNEL; SPECIALIZED INSTRUCTIONAL SUPPORT
3	SERVICES.—
4	"(A) Specialized instructional sup-
5	PORT PERSONNEL.—The term 'specialized in-
6	structional support personnel' means school
7	counselors, school social workers, school psy-
8	chologists, and other qualified professional per-
9	sonnel involved in providing assessment, diag-
10	nosis, counseling, educational, therapeutic, and
11	other necessary services (including related serv-
12	ices as that term is defined in section 602 of
13	the Individuals with Disabilities Education Act)
14	as part of a comprehensive program to meet
15	student needs.
16	"(B) Specialized instructional sup-
17	PORT SERVICES.—The term 'specialized instruc-
18	tional support services' means the services pro-
19	vided by specialized instructional support per-
20	sonnel.
21	"(42) State.—The term 'State' means each of
22	the 50 States, the District of Columbia, the Com-
23	monwealth of Puerto Rico, and each of the outlying
24	areas.

1	"(43) State educational agency.—The
2	term 'State educational agency' means the agency
3	primarily responsible for the State supervision of
4	public elementary schools and secondary schools.
5	"(44) Technology.—The term 'technology'
6	means modern information, computer and commu-
7	nication technology products, services, or tools, in-
8	cluding, but not limited to, the Internet and other
9	communications networks, computer devices and
10	other computer and communications hardware, soft-
11	ware applications, data systems, and other electronic
12	content and data storage.
13	"SEC. 6102. APPLICABILITY OF TITLE.
14	"Parts B, C, D, and E of this title do not apply to
15	title IV of this Act.
16	"SEC. 6103. APPLICABILITY TO BUREAU OF INDIAN EDU-
17	CATION OPERATED SCHOOLS.
18	"For the purpose of any competitive program under
19	this Act—
20	"(1) a consortium of schools operated by the
21	Bureau of Indian Education;
22	"(2) a school operated under a contract or
23	grant with the Bureau of Indian Education in con-
24	sortium with another contract or grant school or a
25	tribal or community organization; or

1	"(3) a Bureau of Indian Education school in
2	consortium with an institution of higher education,
3	a contract or grant school, or a tribal or community
4	organization,
5	shall be given the same consideration as a local edu-
6	cational agency.
7	"PART B—FLEXIBILITY IN THE USE OF
8	ADMINISTRATIVE AND OTHER FUNDS
9	"SEC. 6201. CONSOLIDATION OF STATE ADMINISTRATIVE
10	FUNDS FOR ELEMENTARY AND SECONDARY
11	EDUCATION PROGRAMS.
12	"(a) Consolidation of Administrative Funds.—

7	"(A) the coordination of those programs
8	with other Federal and non-Federal programs;
9	"(B) the establishment and operation of
10	peer-review mechanisms under this Act;
11	"(C) the administration of this title;
12	"(D) the dissemination of information re-
13	garding model programs and practices;
14	"(E) technical assistance under any pro-
15	gram under this Act;
16	"(F) State-level activities designed to carry
17	out this title;
18	"(G) training personnel engaged in audit
19	and other monitoring activities; and
20	"(H) implementation of the Cooperative
21	Audit Resolution and Oversight Initiative of the
22	Department.
23	"(c) Records.—A State educational agency that
24	consolidates administrative funds under this section shall
25	not be required to keep separate records, by individual

- 1 program, to account for costs relating to the administra-
- 2 tion of programs included in the consolidation under sub-
- 3 section (a).
- 4 "(d) Review.—To determine the effectiveness of
- 5 State administration under this section, the Secretary may
- 6 periodically review the performance of State educational
- 7 agencies in using consolidated administrative funds under
- 8 this section and take such steps as the Secretary finds
- 9 appropriate to ensure the effectiveness of that administra-
- 10 tion.
- 11 "(e) Unused Administrative Funds.—If a State
- 12 educational agency does not use all of the funds available
- 13 to the agency under this section for administration, the
- 14 agency may use those funds during the applicable period
- 15 of availability as funds available under one or more pro-
- 16 grams included in the consolidation under subsection (a).
- 17 "(f) Consolidation of Funds for Standards
- 18 AND ASSESSMENT DEVELOPMENT.—In order to develop
- 19 State academic standards and assessments, a State edu-
- 20 cational agency may consolidate the amounts described in
- 21 subsection (a) for those purposes under title I.
- 22 "SEC. 6202. SINGLE LOCAL EDUCATIONAL AGENCY STATES.
- 23 "A State educational agency that also serves as a
- 24 local educational agency shall, in its applications or plans

- 1 under this Act, describe how the agency will eliminate du-
- 2 plication in conducting administrative functions.
- 3 "SEC. 6203. CONSOLIDATION OF FUNDS FOR LOCAL ADMIN-
- 4 **ISTRATION.**
- 5 "(a) GENERAL AUTHORITY.—In accordance with
- 6 regulations of the Secretary and for any fiscal year, a local
- 7 educational agency, with the approval of its State edu-
- 8 cational agency, may consolidate and use for the adminis-
- 9 tration of one or more programs under this Act (or such

10	solidates administrative funds under this section shall not
11	be required to keep separate records, by individual pro-
12	gram, to account for costs relating to the administration
13	of the programs included in the consolidation.
14	"SEC. 6204. CONSOLIDATED SET-ASIDE FOR DEPARTMENT
15	OF THE INTERIOR FUNDS.
16	"(a) General Authority.—
17	"(1) Transfer.—The Secretary shall transfer
18	to the Department of the Interior, as a consolidated

	amount for covered programs, the Indian education
20	programs under part A of title V, and the education

20	"PART C—COORDINATION OF PROGRAMS; CON-
21	SOLIDATED STATE AND LOCAL PLANS AND
22	APPLICATIONS
23	"SEC. 6301. PURPOSES.
24	"The purposes of this part are—

1	"(1) to improve teaching and learning by en-
2	couraging greater cross-program coordination, plan-
3	ning, and service delivery;
4	"(2) to provide greater flexibility to State and
5	local authorities through consolidated plans, applica-
6	tions, and reporting; and
7	"(3) to enhance the integration of programs
8	under this Act with State and local programs.
9	"SEC. 6302. OPTIONAL CONSOLIDATED STATE PLANS OR
10	APPLICATIONS.
11	"(a) General Authority.—
12	"(1) SIMPLIFICATION.—In order to simplify ap-
13	plication requirements and reduce the burden for
14	State educational agencies under this Act, the Sec-
15	retary, in accordance with subsection (b), shall es-
16	tablish procedures and criteria under which, after
17	consultation with the Governor, a State educational
18	agency may submit a consolidated State plan or a
19	consolidated State application meeting the require-
20	ments of this section for—
21	"(A) each of the covered programs in
22	which the State participates; and
23	"(B) such other programs as the Secretary
24	may designate.

"(2)CONSOLIDATED APPLICATIONS AND PLANS.—After consultation with the Governor, a State educational agency that submits a consolidated State plan or a consolidated State application under this section shall not be required to submit separate State plans or applications under any of the pro-grams to which the consolidated State plan or con-solidated State application under this section ap-plies.

# "(b) Collaboration.—

1 "(3) Necessary materials.—The Secretary 2 shall require only descriptions, information, assur-3 ances (including assurances of compliance with ap-4 plicable provisions regarding participation by private 5 school children and teachers), and other materials 6 that are absolutely necessary for the consideration of 7 the consolidated State plan or consolidated State ap-8 plication.

#### 9 "SEC. 6303. CONSOLIDATED REPORTING.

- 10 "(a) In General.—In order to simplify reporting re-
- 11 quirements and reduce reporting burdens, the Secretary
- 12 shall establish procedures and criteria under which a State

"(7) before the application was submitted, the applicant afforded a reasonable opportunity for public comment on the application and considered such comment.

24	"(4) Peer review.—

1	"(A) ESTABLISHMENT.—The Secretary
2	shall establish a multi-disciplinary peer review
3	team, which shall meet the requirements of sec-
4	tion 6543, to review waiver requests under this

6	"(B) APPLICABILITY.—The Secretary may
7	approve a waiver request under this section
8	without conducting a peer review of the request,

12	"(ii) academic assessments;
13	"(iii) State accountability systems; or
14	"(iv) teacher and school leader evalua-

16	"(e) Reports.—
17	"(1) Waiver reports.—A State educational
18	agency, local educational agency, or Indian tribe
19	that receives a waiver under this section shall, at the
20	end of the second year for which a waiver is received
21	under this section and each subsequent year, submit
22	a report to the Secretary that—
23	"(A) describes the uses of the waiver by
24	the agency or by schools;

1	"(B) describes how schools continued to
2	provide assistance to the same populations
3	served by the programs for which waivers were

5	"(C) evaluates the progress of the agency
6	and schools, or Indian tribe, in improving the
7	quality of instruction or the academic achieve-

9	"(2) Report to congress.—The Secretary
10	shall annually submit to the Committee on Edu-

16	State educational agencies, local educational
17	agencies, Indian tribes, and schools; and
18	"(B) describing the status of the waivers
19	in improving academic achievement.
20	"(f) TERMINATION OF WAIVERS.—The Secretary
21	shall terminate a waiver under this section if the Secretary
22	determines, after notice and an opportunity for a hearing,
23	that the performance of the State or other recipient af-
24	fected by the waiver has been inadequate to justify a con-
25	tinuation of the waiver and the recipient of the waiver has

- 4 "(g) Publication.—A notice of the Secretary's deci-
- 5 sion to grant each waiver under subsection (a) shall be

- 7 provide for the dissemination of the notice to State edu-
- 8 cational agencies, interested parties, including educators,
- 9 parents, students, advocacy and civil rights organizations,
- 10 and the public.

- 12 "Subpart 1—Private Schools
- 13 "SEC. 6501. PARTICIPATION BY PRIVATE SCHOOL CHIL-
- 14 DREN AND TEACHERS.
- 15 "(a) Private School Participation.—
- 16 "(1) In General.—Except as otherwise pro-
- vided in this Act, to the extent consistent with the
- number of eligible children in areas served by a
- 19 State educational agency, local educational agency,

- "(2) SECULAR, NEUTRAL, AND NONIDEOLOG-ICAL SERVICES OR BENEFITS.—Educational services or other benefits, including materials and equipment, provided under this section, shall be secular, neutral, and nonideological.
- "(3) Special rule.—Educational services and other benefits provided under this section for private school children, teachers, and other educational personnel shall be equitable in comparison to services and other benefits for public school children, teachers, and other educational personnel participating in the program and shall be provided in a timely manner.

### "(4) Expenditures.—

"(A) IN GENERAL.—Expenditures for educational services and other benefits to eligible private school children, teachers, and other service personnel shall be equal to the expenditures for participating public school children,

1	taking into account the number and educational
2	needs, of the children to be served.
3	"(B) Obligation of funds.—Funds allo-
4	cated to a local educational agency for edu-
5	cational services and other benefits to eligible
6	private school children shall—
7	"(i) be obligated in the fiscal year for
8	which the funds are received by the agen-
9	cy; and
10	"(ii) with respect to any such funds
11	that cannot be so obligated, be used to
12	serve such children in the following fiscal
13	year.
14	"(C) NOTICE OF ALLOCATION.—Each
15	State educational agency shall—
16	"(i) determine, in a timely manner,
17	the proportion of funds to be allocated to
18	each local educational agency in the State
19	for educational services and other benefits
20	under this subpart to eligible private school
21	children; and
22	"(ii) provide notice, simultaneously, to
23	each such local educational agency and the
24	appropriate private school officials or their

1	representatives in the State of such alloca-
2	tion of funds.
3	"(5) Provision of Services.—An agency,
4	consortium, or entity described in subsection $(a)(1)$
5	of this section may provide those services directly or
6	through contracts with public and private agencies,
7	organizations, and institutions.
8	"(b) Applicability.—
9	"(1) In general.—This section applies to pro-
10	grams under—
11	"(A) subpart 2 of part A of title I;
12	"(B) subpart 4 of part A of title I;
13	"(C) part A of title II;
14	"(D) part B of title II; and
15	"(E) part B of title III.
16	"(2) Definition.—For the purpose of this sec-
17	tion, the term 'eligible children' means children eligi-
18	ble for services under a program described in para-
19	graph (1).
20	"(c) Consultation.—
21	"(1) In General.—To ensure timely and
22	meaningful consultation, a State educational agency,
23	local educational agency, educational service agency,
24	consortium of those agencies, or entity shall consult,
25	in order to reach an agreement, with appropriate

1	private school officials or their representatives dur-
2	ing the design and development of the programs
3	under this Act, on issues such as—
4	"(A) how the children's needs will be iden-
5	tified;
6	"(B) what services will be offered;
7	"(C) how, where, and by whom the services
8	will be provided;
9	"(D) how the services will be assessed and
10	how the results of the assessment will be used
11	to improve those services;
12	"(E) the size and scope of the equitable
13	services to be provided to the eligible private
14	school children, teachers, and other educational
15	personnel and the amount of funds available for
16	those services;
17	"(F) how and when the agency, consor-
18	tium, or entity will make decisions about the
19	delivery of services, including a thorough con-
20	sideration and analysis of the views of the pri-
21	vate school officials or their representatives on
22	the provision of services through potential
23	third-party providers or contractors; and
24	"(G) how, if the agency disagrees with the
25	views of the private school officials or their rep-

resentatives on the provision of services through a contract, the local educational agency will provide in writing to such private school officials or their representatives an analysis of the reasons why the local educational agency has chosen not to use a contractor.

- "(2) DISAGREEMENT.—If the agency, consortium, or entity disagrees with the views of the private school officials or their representatives with respect to an issue described in paragraph (1), the agency, consortium, or entity shall provide to the private school officials or their representatives a written explanation of the reasons why the local educational agency has chosen not to adopt the course of action requested by such officials or their representatives.
- "(3) TIMING.—The consultation required by paragraph (1) shall occur before the agency, consortium, or entity makes any decision that affects the opportunities of eligible private school children, teachers, and other educational personnel to participate in programs under this Act, and shall continue throughout the implementation and assessment of activities under this section.

"(4) DISCUSSION REQUIRED.—The consultation required by paragraph (1) shall include a discussion of service delivery mechanisms that the agency, consortium, or entity could use to provide equitable services to eligible private school children, teachers, administrators, and other staff.

"(5) Documentation.—Each local educational agency shall maintain in the agency's records and provide to the State educational agency involved a written affirmation signed by officials or their representatives of each participating private school that the meaningful consultation required by this section has occurred. The written affirmation shall provide the option for private school officials or their representatives to indicate that timely and meaningful consultation has not occurred or that the program design is not equitable with respect to eligible private school children. If such officials or their representatives do not provide such affirmation within a reasonable period of time, the local educational agency shall forward the documentation that such consultation has, or attempts at such consultation have, taken place to the State educational agency.

7	ian, or youth to appeal such decisions;
8	"(iii) the parent, guardian, or unac-
9	companied youth shall be referred to the
10	local educational agency liaison designated
11	under paragraph (1)(J)(ii), who shall carry
12	out the dispute resolution process as de-
13	scribed in paragraph (1)(C) as expedi-
14	tiously as possible after receiving notice of

22	English learners.
23	"(C) Programs in career and technical

1	"(D) Programs for gifted and talented stu-
2	dents.
3	"(E) School nutrition programs.
4	"(5) Coordination.—
5	"(A) IN GENERAL.—Each local educational
6	agency serving homeless children and youths
7	that receives assistance under this subtitle shall
8	coordinate—
9	"(i) the provision of services under
10	this subtitle with local social services agen-
11	cies and other agencies or entities pro-
12	viding services to homeless children and
13	youths and their families, including serv-
14	ices and programs funded under the Run-
15	away and Homeless Youth Act (42 U.S.C.
16	5701 et seq.); and
17	"(ii) transportation, transfer of school
18	records, and other interdistrict activities,

10	SEC. 801. FINDINGS; SENSE OF THE CONGRESS.
11	(a) FINDINGS.—The Congress finds as follows:
12	(1) To avoid negative attention and litigation,
13	some local educational agencies have entered into
14	agreements with employees who are suspected of
15	abusing or are known to have abused students.
16	(2) Instead of reporting sexual misconduct with
17	minors to the proper authorities such as the police
18	or child welfare services, under such agreements the
19	local educational agencies, schools, and employees
20	keep the information private and facilitate the em-
21	ployee's transfer to another local educational agency.
22	(b) Sense of the Congress.—It is the sense of
23	the Congress that—
24	(1) confidentiality agreements between local

educational agencies or schools and suspected child

sex abusers should be prohibited;

1	(2) the practice of employee transfers after sus-
2	pected or proven sexual misconduct should be
3	stopped, and States should require local educational
4	agencies and schools to provide law enforcement
5	with all information regarding sexual conduct be-
6	tween an employee and a minor; and
7	(3) Congress should help protect children and

(3) Congress should help protect children and help stop this unacceptable practice in our schools.
