JOINT RESOLUTION

Amending the Internal Revenue Code of 1986 to exempt employees with health coverage under TRICARE or the Veterans Administration from being taken into account for purposes of determining the employers to which the employer mandate applies under the Patient Protection and Affordable Care Act.

1 *Resolved by the Senate and House of Representatives*
2 *of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This joint resolution may be cited as the “Hire More
5 Heroes Act of 2015”.

1 **SEC. 2. EMPLOYEES WITH HEALTH COVERAGE UNDER**
2 **TRICARE OR THE VETERANS ADMINISTRA-**
3 **TION NOT TAKEN INTO ACCOUNT IN DETER-**
4 **MINING EMPLOYERS TO WHICH THE EM-**
5 **PLOYER MANDATE APPLIES UNDER PATIENT**
6 **PROTECTION AND AFFORDABLE CARE ACT.**

7 (a) IN GENERAL.—Section 4980H(c)(2) of the Inter-
8 nal Revenue Code of 1986 is amended by adding at the
9 end the following:

10 “(F) EXEMPTION FOR HEALTH COVERAGE
11 UNDER TRICARE OR THE VETERANS ADMINIS-
12 TRATION.—Solely for purposes of determining
13 whether an employer is an applicable large em-
14 ployer under this paragraph for any month, an
15 individual shall not be taken into account as an
16 employee for such month if such individual has
17 medical coverage for such month under—

18 “(i) chapter 55 of title 10, United
19 States Code, including coverage under the
20 TRICARE program, or

21 “(ii) under a health care program
22 under chapter 17 or 18 of title 38, United
23 States Code, as determined by the Sec-
24 retary of Veterans Affairs, in coordination
25 with the Secretary of Health and Human
26 Services and the Secretary.”.

1 (b) EFFECTIVE DATE.—The amendment made by
2 subsection (a) shall apply to months beginning after De-
3 cember 31, 2013.

4 **SEC. 3. BUDGETARY EFFECTS; STATUTORY PAY-AS-YOU-GO**
5 **(PAYGO) SCORECARDS.**

6 The budgetary effects of this joint resolution shall not
7 be entered on either PAYGO scorecard maintained pursu-
8 ant to section 4(d) of the Statutory Pay-As-You-Go Act
9 of 2010 (2 U.S.C. 933(d)).
