Mr. CROW (for himself and Mr. C. SCOTT FRANKLIN of Florida) introduced the following bill; which was referred to the Committee on Armed Services

A BILL

To require an annual report on missing, lost, and stolen weapons, large amounts of ammunition, destructive devices, and explosive material, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Transparency in Re-
5 porting for an Accurate Count of Combat Equipment
6 (TRACCE) Act”.

1 **SEC. 2. ANNUAL REPORT ON MISSING, LOST, AND STOLEN**
2 **WEAPONS, LARGE AMOUNTS OF AMMUNI-**
3 **TION, DESTRUCTIVE DEVICES, AND EXPLO-**
4 **SIVE MATERIAL.**

5 (a) IN GENERAL.—Section 2722 of title 10, United
6 States Code, is amended—

7 (1) in the section heading, by striking “report
8 to the Secretary of the Treasury” and inserting “re-
9 porting requirements”;

10 (2) in subsection (a), by inserting “and the Di-
11 rector of the Bureau of Alcohol, Tobacco, Firearms
12 and Explosives” after “Secretary of the Treasury”;

13 (3) by redesignating subsection (c) as sub-
14 section (d); and

15 (4) by inserting after subsection (b) the fol-
16 lowing new subsection (c):

17 “(c) ANNUAL REPORT.—Not later than December 31
18 each year, the Secretary shall submit to the congressional
19 defense committees a report that includes, for the pre-
20 ceding year—

21 “(1) all instances of missing, lost, or stolen
22 weapons, large amounts of ammunition, destructive
23 devices, or explosive material from the stocks of the
24 Department of Defense;

1 “(2) for each item identified under paragraph
2 (1), the type, quantity, and serial number, broken
3 down by armed force and component; and

4 “(3) such other information as the Secretary
5 determines appropriate.”.

6 (b) CLERICAL AMENDMENT.—The table of sections
7 at the beginning of chapter 161 of such title is amended
8 by striking the item relating to section 2722 and inserting
9 the following new item:

 “2722. Theft or loss of ammunition, destructive devices, and explosives reporting
 requirements.”.
