## A BILL

To prohibit Federal funding of State firearm ownership databases, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Gun Owner Registra-  
5 tion Information Protection Act”.

6 **SEC. 2. PROHIBITION ON FEDERAL FUNDING OF STATE**  
7 **FIREARM OWNERSHIP DATABASES.**

8 (a) DEFINITIONS.—In this section:

9 (1) STATE.—The term “State” means each of  
10 the several States, the District of Columbia, the  
11 Commonwealth of Puerto Rico, the Commonwealth  
12 of the Northern Mariana Islands, American Samoa,  
13 Guam, the United States Virgin Islands, and any  
14 other territory or possession of the United States.

15 (2) STATE FIREARM OWNERSHIP DATABASE.—  
16 The term “State firearm ownership database”  
17 means a comprehensive or partial database of a  
18 State or political subdivision of a State that lists—

19 (A) firearms lawfully owned or possessed  
20 by individuals; or

21 (B) individuals who lawfully own or pos-  
22 sess firearms.

23 (b) PROHIBITION.—A Federal agency may not fund  
24 or otherwise support the establishment or maintenance of  
25 a State firearm ownership database.

1           (c) EXCEPTION.—Subsection (b) shall not apply to  
2 a database of a State or political subdivision of a State  
3 that lists—

4           (1) firearms that have been reported as lost or  
5 stolen; or

6           (2) individuals who have reported their firearms  
7 as lost or stolen.
