- 7 measures related to firearms. The bill proposes to: (1) require a 72-hour
- 8 waiting period for all firearms sales; (2) repeal the statute that permits large
- 9 capacity ammunition feeding devices to be manufactured in Vermont; (3)
- require that, when a firearm is not in a person's immediate possession or
- 11 control, the firearm must be locked in a safe storage depository or rendered
- incapable of being fired; (4) permit a family or household member to file a
- petition for an Emergency Risk Protection Order; and (5) authorize health care
- providers to inform a law enforcement officer when the health care provider
- reasonably believes that a patient poses an extreme risk of causing harm to
- himself or herself or another person by purchasing, possessing, or receiving a
- dangerous weapon or by having a dangerous weapon.
