1	and for a second or subsequent offense shall be imprisoned not more than three

3	(b) No person shall knowingly possess a firearm or a dangerous or deadly
4	weapon on any school property with the intent to injure another person. A
5	person who violates this section shall, for the first offense, be imprisoned not
6	more than two years or fined not more than \$1,000.00, or both, and for a
7	second or subsequent offense shall be imprisoned not more than three years or
8	fined not more than \$5,000.00, or both.
9	(c) This section shall not apply to:
10	(1) A law enforcement officer while engaged in law enforcement duties.
11	(2) Possession and use of firearms or dangerous or deadly weapons if
12	the board of school directors, or the superintendent or principal if delegated
13	authority to do so by the board, authorizes possession or use for specific
14	occasions or for instructional or other specific purposes.
