SUBSTITUTE HOUSE BILL 1539

State of Washington 65th Legislature 2018 Regular Session

By House Education (originally sponsored by Representatives McCabe, Orwall, Griffey, Caldier, Senn, Dent, Gregerson, Smith, Kraft, Doglio, and Kagi)

- AN ACT Relating to a curriculum for the prevention of sexual abuse of students; amending RCW 28A.300.150 and 28A.300.160; adding a new section to chapter 28A.230 RCW; and creating a new section.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 NEW SECTION. **Sec. 1.** (1) The legislature recognizes that every 6 child should experience emotional and physical development that is 7 free from abuse and neglect. In 2015, Washington child protective services received reports screened in for investigation that alleged 8 the sexual abuse or sexual exploitation, or both, of two thousand six 9 10 hundred three children. Further, the legislature finds that most 11 sexual assaults are unreported. The legislature also finds that a clear relationship exists between youth victimization and mental 12 health problems and delinquent behavior. 13
- 14 (2) The legislature finds that thirty-one states have enacted Erin's laws. Erin's laws, named in honor of a childhood sexual 15 16 assault survivor, are intended to help children, teachers, and 17 parents identify sexual abuse, and to provide assistance, referral, or resource information for children and families who are victims of 18 child sexual abuse. The legislation adopted in these states requires 19 20 study or development of age-appropriate child sexual abuse 21 identification and prevention.

- 1 (3) The legislature finds that the federal every student succeeds 2 act, P.L. 114-95, as signed into law by President Barack Obama on 3 December 10, 2015, provides federal funding that can be used for the 4 implementation of programs established in accordance with Erin's 5 laws.
- 6 (4) The legislature, therefore, intends to incorporate curriculum 7 for the prevention of sexual abuse of students in kindergarten 8 through twelfth grade, such as Erin's law, into an existing statewide 9 coordinated program for the prevention of child abuse and neglect.
- 10 **Sec. 2.** RCW 28A.300.150 and 2006 c 263 s 705 are each amended to 11 read as follows:
- (1) The superintendent of public instruction shall collect and 12 disseminate to school districts information on and curricula for the 13 coordinated program for the prevention of sexual abuse of students in 14 kindergarten through twelfth grade, child abuse, and 15 16 ((prevention curriculum and)) established in RCW 28A.300.160. The 17 superintendent shall also adopt rules ((dealing with)) addressing the prevention of <u>sexual abuse of students in kindergarten</u> through 18 twelfth grade and child abuse for purposes of ((curriculum use)) 19 curricula used in ((the common)) public schools. 20
- (2) Effective July 1, 2018, the superintendent of public instruction and the ((departments of social and health services and community, trade, and economic development)) department of children, youth, and families shall share relevant information in furtherance of this section.

- (3) On or before September 1, 2018, the superintendent of public instruction must review any existing curricula related to the prevention of sexual abuse of students in kindergarten through twelfth grade. The review required by this subsection must evaluate the curricula for alignment with the provisions of RCW 28A.300.160(2).
- 32 **Sec. 3.** RCW 28A.300.160 and 1995 c 399 s 21 are each amended to 33 read as follows:
 - (1)(a) The office of the superintendent of public instruction shall be the lead agency and shall assist the department of ((social and health services, the department of community, trade, and economic development,)) children, youth, and families and school districts in establishing a coordinated ((primary prevention)) program for the

- 16 <u>(ix) Other relevant organizations.</u>
- 17 (2) In developing the program, consideration shall be given to 18 the following:
- 19 (a) Parent, teacher, and children's workshops whose information 20 and training is:
- 21 (i) Provided in a clear, age-appropriate, nonthreatening manner, 22 delineating the problem and the range of possible solutions;
- 23 (ii) Culturally and linguistically appropriate to the population 24 served;
 - (iii) Appropriate to the geographic area served; and
- 26 (iv) Designed to help counteract common stereotypes about the 27 sexual abuse of students in kindergarten through twelfth grade, child 28 abuse victims, and offenders;
- 29 (b) Training for school-age children's parents and school staff, 30 which includes:
 - (i) Physical and behavioral indicators of abuse;
- 32 (ii) Crisis counseling techniques;
- 33 (iii) Community resources;
- 34 (iv) Rights and responsibilities regarding reporting;
- (v) School district procedures to facilitate reporting and apprise supervisors and administrators of reports; and
 - (vi) Caring for a child's needs after a report is made;
- 38 (c) Training for licensed day care providers and parents that 39 includes:
- 40 (i) Positive child guidance techniques;

- 1 (ii) Physical and behavioral indicators of abuse;
- 2 (iii) Recognizing and providing safe, quality day care;
- 3 (iv) Community resources;
- 4 (v) Rights and responsibilities regarding reporting; and
- 5 (vi) Caring for the abused or neglected child;
- 6 (d) Training for children that includes:
- 7 (i) The right of every child to live free of abuse;
- 8 (ii) How to disclose incidents of abuse and neglect;
- 9 (iii) The availability of support resources and how to obtain 10 help;
- 11 (iv) Child safety training and age-appropriate self-defense 12 techniques; and
- (v) A period for crisis counseling and reporting immediately following the completion of each children's workshop in a school setting which maximizes the child's privacy and sense of safety.
- 16 (3) The ((primary)) coordinated prevention program established 17 under this section ((shall be)) is a voluntary program and ((shall 18 not be)) is not part of the state's program of basic ((program of)) 19 education.
- 20 (4) Parents shall be given notice of the ((primary)) coordinated 21 prevention program and may refuse to have their children participate 22 in the program.
- NEW SECTION. Sec. 4. A new section is added to chapter 28A.230 RCW to read as follows:
- The office of the superintendent of public instruction shall make the curriculum included under section 3(1)(b), chapter . . ., Laws of 27 2018 (section 3(1)(b) of this act) available on its web site.
